

# **Preface**

The fate of stiff vacuum extrusion (SVE), this "ugly duckling" of ferrous metallurgy is playing out in a surprising way. In a brief and clear way and yet without being noticed, it has made its debut in the Bethlehem Steel blast furnace (BF) in the United States of America and has made a triumphant return, after almost 20 years, to the lineup of industrial agglomeration technology. Despite the fact that it would not be entirely accurate to compare the scale of the blast furnace operation of what was once one of the largest American steel companies and that of the small, Indian company Suraj Products Ltd (Rourkela, West Bengali), it is this same experience that has enabled the authors to mold SVE into a fully fledged metallurgical technology. Six years of experience of using briquettes in the charge of a small blast furnace in Rourkela served as the basis of the technical and economic foundation of a project to construct a briquette factory at the Novolipetsk Steel Plant, which is designed to produce 700000 tons of briquettes annually (the deadline for commissioning this plant is 2018). Over the course of all this time, the briquette manufacturing plant in Rourkela (in West Bengal) has been a peculiar kind of Mecca for metallurgists who specialize in the field of the briquetting of natural and anthropogenic raw materials. Blast furnace specialists from the Novolipetsk Steel Plant, the West-Siberian Metallurgical Plant belonging to EVRAZ, the Metinvest Group (in the Ukraine) as well as delegations from Paul Wurth, and Tata Steel and many other Russian, and overseas specialists have familiarized themselves with the work of the plant. We would like to express our gratitude to the owner of the Suraj Products Ltd Company Mr. Yogesh Dalmia who is a real enthusiast of extrusion agglomeration technology and contributed personally to the development of the 100% briquetted operation of small-scale blast furnaces concept.

Within the confines of the project to construct a manufacturing plant at the Novolipetsk Steel Plant, the possibility of a partial replacement of sinter in the charge of a blast furnace with extruded briquettes (brex) is under examination. The practical realization of this substitution requires a growth in the production of brex of several orders of magnitude. The benefits of this "peaceful coexistence" of SVE and agglomeration are obvious. The efficiency of the agglomeration process itself increases as a result of the removal of fines from the charge for sintering. If 50% of the

sinter were replaced in the charge of a BF with brex, the basicity of the remaining sinter should be between 2.8 and 3.2. It is worth noting that given this basicity, calcium ferrite should predominate in the structure of the sinter, providing the increase of its strength. The results of a mathematical model of BF smelting using iron ore concentrate and coal brex with a carbon content in the brex of 9.5% demonstrated a high level of efficiency of a partial (by 50%) replacement of the production of sinter by the production of brex with a reduction in the coke rate of 15% and a reduction by 50% of the dust emissions,  $CO_2$  emissions at the sinter plant will decrease by 32% and sulfurous gas emissions by 43% during the manufacture of the sinter.

In 2017, several brex producing factories for ferroalloys industry were constructed in different countries of the world. The design of all these factories, for the most part was based on the results of that, which is described in this book, including the methods for the preparation of the charge for extrusion agglomeration. The first smelts already confirmed the justification behind our recommendation for the brex as an effective charge component for submerged electric arc furnaces. The share of brex in the charge of such furnace can exceed 50% of the charge, and the resulting alloy is distinguished by its higher quality. At present, the possibility of using brex based on chromium-containing materials in the charge of direct current electric furnaces is being studied.

It would be unlikely that there would have been the growth in the popularity of stiff extrusion briquetting around the world, or the construction of new plants for the manufacture of brex, were it not for the systematic improvement of the technological characteristics of stiff extrusion, or the search for new binding materials, and the optimization of the operating conditions, and servicing of extrusion equipment. The only producer of the stiff extrusion briquetting equipment in the world is the J.C. Steele&Sons, Inc. (North Carolina). We experienced beginner's luck in researching the metallurgical properties of the extruded agglomerates. We are undoubtedly grateful to Mr. Richard Steele (Vice-President), who kindly made laboratory equipment of the Company available to us. Specifically, this relates to a unique computerized laboratory extruder that was able to model all the significant stages of SVE. We are grateful to Jim Falter for the comprehensive reports on testing of our customers materials in the lab.

The authors also consider it their duty to express their gratitude to Tatyana Malysheva, a known Russian scientist and one of the authors of metallurgical mineralogy, with whose cooperation it was possible to build the theoretical models on the nature of the hot strength of brex as they are heated in a reducing atmosphere. The successful spread of SVE in the ferroalloys industry became possible thanks among other things to cooperation with the known Russian scientists and metallurgists, V.Ya. Dashevskyi (of the A. A. Baykov Institute of Metallurgy and Materials Science of the Russian Academy of Sciences) and A.V. Pavlov (of the National University of Science and Technology, MISiS), for which we also express our gratitude.

# **About the Authors**

**Ivan Kurunov** was born on January 27, 1939, in settlement Satka, Chelyabinsk region, Russia. He graduated from Chelyabinsk Polytechnic Institute of Metals in 1961. Since 1963 till 2005, he is postgraduate student, Associate Professor, Professor in Moscow Institute of Steel and Alloys. Since 2005 up to August 2017, he is Chief Expert of Ironmaking division in Novolipetsk Steel Company (JSC NLMK).

He is author and co-author of more than 300 technical and scientific publications, including 8 books and brochures and more than 120 patents for inventions in metallurgy.

The very day it was decided that this book was to be published, my friend and teacher Ivan Kurunov was gravely injured in a traffic accident. He died on August 31st, the day that the press service of Russia's largest steel producer—the Novolipetsk Steel Company—announced the start of the construction of a new extrusion briquettes manufacturing factory with a capacity of 700,000 tons per annum. This project is Ivan's brainchild. Ivan Kurunov's name will remain known in the history of metallurgy for his pioneering works in the field of blast-furnace production and efficient recycling of iron-containing materials.

**Aither Bizhanov** was born on October 6, 1956, in Buynaksk, Russia. He graduated from the Moscow Physical-Technical Institute in 1979. He spent 11 years as a Senior Researcher with the Institute for High Temperatures, USSR Academy of Sciences. In 1992, he joined EVRAZ, a large, vertically integrated steel and

vanadium enterprise with global assets. He joined Kosaya Gora Iron Works in 2005 as Commercial Director, introducing a briquetting technology for recycling of the natural and anthropogenic materials. He has Ph.D. in the agglomeration of natural and anthropogenic materials in metallurgy. # Chapter 1 Introduction

# 1.1 A Brief History of Industrial Briquetting in Ferrous Metallurgy

The development of ferrous metallurgy, the growth of the capacity of blast furnaces (BF) and increased ore consumption required the creation of technology for the agglomeration of natural and fine anthropogenic materials generated during the course of the entire process from iron ore extraction through to iron smelting. The first industrial agglomeration technology, which appeared back in the nineteenth century, was briquetting technology—production of lumps of regular geometric shapes from iron ore fines by applying pressure using different binders or without them, with further drying and firing or curing under natural conditions. Industrial briquetting began with the first commercially successful production of briquettes from fine magnetite iron ore in 1899 in Finland [1]. Moisturized magnetite concentrate briquettes were produced without application of any binder and using clay brick making equipment with a pressure of 30–50 MPa. Energy consumption for the production of 1 ton of briquettes was 5 kWh. Raw briquettes (150  $\times$  150  $\times$  75 mm) were subjected to strengthening roasting in a tunnel kiln at temperatures of up to 1400 °C. In the process of roasting a sulfide sulfur oxidation occurred, which was further removed up to a level of 98% and the oxidation of magnetite to hematite took place. Despite the large size, these briquettes were successfully used in a low shaft blast furnace (BF) with a capacity of 50-140 t/day at a factory in Pitkäranta. Sintered briquettes (with a porosity of 40%) had a high mechanical strength (10 MPa) and a high reducibility and their use led to a reduction of Coke consumption and increased productivity of BF. The success of the project has contributed to the rapid spread of such technology. In 1913, there were already 38 similar briquetting lines in operation (16 in Sweden, 12 in England, and 6 in the United States).

Subsequently, for the production of briquettes lever, revolving, circular, conveyor, and roller presses were used. Depending on the type of material and binder

(if any) that were used briquettes were pressed with low (50–150 kg/cm<sup>2</sup>), medium (150–750 kg/cm<sup>2</sup>), or high (over 750 kg/cm<sup>2</sup>) pressure [2]. The low productivity of the technological processes of briquetting as well as the insufficient strength properties of briquettes has prevented this technology from playing a meaningful role in the agglomeration of raw materials for blast furnace production. This role is now being played by the technologies of sinter production and pelletizing that were developed back in the early twentieth century. The first patents for the iron ore sintering method were obtained in Germany in 1902 and 1905, but the birth of a high-performance sintering process was in 1906 when A. Dwight and R. Lloyd in the United States patented a conveyor sintering machine [3]. The high technological effectiveness of the process and the possibility of recycling dispersed iron containing wastes, inevitably generated during iron and steel production, stimulated the development of this process and up to the present day the sinter strand sintering method is the main technological process for the agglomeration of raw materials in the steel industry, and is also widely used in nonferrous metallurgy. The main disadvantage of this agglomeration technology lies in its considerable adverse impact on the environment. A sinter plant within a metallurgical plant is the source of more than 50% of all dust and gas emissions.

The increase of lean iron ore and iron ore concentrate production from these has led to the development of the new technology for the agglomeration of fine concentrate. This technology was the production of pellets—pelletizing of iron ore concentrates with the formation of spherical granules 9–16 mm in size and their strengthening firing in a shaft furnace or on conveyor indurating machines. The patent for this technology was obtained by Andersen in Sweden in 1916, and the industrial production of pellets began to evolve rapidly from the second half of the twentieth century.

At the turn of the twentieth and twenty-first centuries in the steel industry, the technology of briquetting again began to be applied for the recycling of fine iron and iron-zinc-containing wastes—sludge, dusts, and fines. In Germany, technology has been developed for the production of briquettes from iron-zinc-containing sludge with their subsequent smelting in the cupola—Oxy-Cup, which is operated using an enriched oxygen blast [4]. Briquettes are being produced using vibropressing technology with Portland cement as a binder. The metallurgical quality of such briquettes meets the requirements of the BF charge. These briquettes qualify for the blast furnace in terms of their metallurgical properties. Vibropressing technology is applied in metallurgical plants in Sweden, where the BF are operating on 100% pellets and briquetting is being used as recycling technology for the agglomeration of flue dust and pellets fines, and carrying out recycling of the flue dust and pellet screenings. Briquetting by vibropressing began to be applied in the United States, Russia, and other countries, and not only for waste processing, but also for the agglomeration of fine ores and concentrates. The presence of carbonaceous materials (flue dust, blast furnace sludge) in the charge for briquetting ensures the self-reducing nature of briquettes, which reduces coke consumption during smelting proportionally to their amount in the charge of a blast furnace.


In addition to vibropressing technology roller presses are used for the production of briquettes from metallurgical anthropogenic materials. Use of organic binders ensures a high cold strength for the briquettes but restricts their application solely to steelmaking processes. The use of such briquettes in BF is possible only in very limited quantities due to the fact of their destruction when heated. To ensure high hot strength of roller-pressed briquettes a cement binder should be applied in an amount that is considerably higher than in the manufacture of briquettes using the vibropressing method.

At the beginning of the twenty-first century a new agglomeration technology of natural and anthropogenic raw materials appeared—Stiff Vacuum Extrusion (SVE), which for many decades was used for the production of bricks. The debut of the SVE in the preparation of agglomerated raw materials for blast furnaces took place in the 90s of the past century, but was not distributed widely. Auger extrusion for agglomeration of ore and metallurgical wastes first occurred in the 1990s, when Bethlehem Steel commissioned a stiff extrusion line for briquetting 20 tons per hour of sludge and flue dust [5]. These briquettes were used in Bethlehem Steel's blast furnaces. The line operated until 1996 when it ceased due to the closure of the plant. This milestone was not thoroughly investigated by metallurgists until 2010, when the authors of the present book began to study the characteristics of stiff extrusion and their influence on the metallurgical properties of extruded briquettes. By April 2011, more iron-making specialists were evaluating industrial briquetting plant production, along with the use of stiff extrusion briquettes as a major component of the blast furnace charge. These briquettes have become known as BREX (BREX-Extrusion Briquette) in technical literature [6].

# 1.2 Briquetting Technology and Metallurgical Properties of Briquettes

Briquetting is the creation of a solid structure of fine natural and anthropogenic materials using adhesives and/or heat strengthening treatment. Briquettes, as a component of the charge for metallurgical aggregates of ferrous metallurgy, must have certain metallurgical properties. The most important of these are cold strength, allowing them to preserve their integrity so they do not crumble with the formation of fines during transportation, discharging, and charging into the furnace; hot strength—the ability to maintain the integrity without disintegration in the process of heating and reduction; and reducibility.

A theoretical interest in briquetting technology followed by strengthening firing, as in the Gröndal project [1], remained until recently. Metallurgical properties of such briquettes (with a basicity of 1.4), produced on an industrial briquetting roller-pressing line, were studied in comparison with the properties of fired pellets with the same basicity [7]. The briquettes firing took place in an electric furnace in an oxidizing atmosphere at temperatures ranging from 1190 to 1250 °C.

Petrographic analysis revealed the similarity of the microstructure of briquettes and pellets (Fig. 1.1).

However, such technology was not widespread in metallurgy. The only methods for the thermal processing of briquettes, currently applicable on an industrial scale, are drying and heat-moisture treatment of vibropressed briquettes. Recently a fundamentally new concept of so-called hot briquetting has been developed. A mixture of fine iron ore and coal is heated to temperatures of 350–600 °C and pressed after the carbon reaches plasticity [8]. It is clear, however, that this reduces the economic efficiency of the technology in general as a result of the expenditure of energy for heating, the absence of which is an important competitive advantage of cold briquetting.

# 1.3 Roller-Press Briquetting

In the 20s of the past century roller presses were widely used for the briquetting of iron ore fines and metallurgical wastes. The frame of these presses has one or two pairs of rollers with steel sleeves on them. These sleeves consist of segments with forming cells. Pressing of the charge occurs in the gap between the rollers as they rotate towards each other. The capacity of modern roller presses can exceed 50 tons per hour and the pressure applied—up to 150 MPa.

The structure of the material pressed by roller presses undergoes changes associated with an elastic and irreversible deformation, with the destruction of the particles of the pressed material and with the formation of cracks within it. The release of energy of the elastic deformation after removal of the applied load can

lead to the growth of the volume of the briquettes. The short duration of the mixture compression process can lead to "pressing" of the air in the briquette's body, which also reduces the strength of a briquette. In the process of roller-pressed briquetting the homogenization of the mix does not take place and the structure of briquette follows the structure of the mixture in the forming cell.

Roller-press briquetting is accompanied by the generation of a sufficient amount (up to 30%) of wastes in the form of a charge mixture, which does not enter the forming cells.

A specific feature of roller-press briquetting are the restrictions imposed on the moisture content of the briquetted material (less than 5–10%) which means that the charge should be subjected to dewatering and/or drying and corresponding facilities should be included in the briquetting plants. The required low moisture content of the charge restricts the utilization of hydrating binders, such as cement. The disadvantages of this briquetting technology are also related to the incomplete closing of forming cells, leading to a deterioration of the strength of the briquette, and with the lack of exposure of the briquette body under pressure, which degrades its properties and leads to the need for so-called "prepressing". However, roller-pressed briquettes were widely used in the early twentieth century in the charges of small blast furnaces and low shaft blast furnaces. Their share in the charge in the BF in the West Kalbe plant reached 30-40%, and in the low shaft BF in the Max Hütte Plant (Germany)—100%. These briquettes were made from iron ore, limestone, and coke breeze [9]. At that time roller-pressed briquettes were also used in the BF of Kushvinskyi's plant (up to 25% in the charge), as well as in the charge in the BF in the Kerch (100 thousand tons per year) and Taganrog metallurgical plants [10].

Interest in roller-press briquetting of raw materials for BF was renewed in the 60-70s in the past century due to the growing need for and relevance of the recycling of accumulated iron containing wastes. The Briquetting factory "Donetskaya" was built in 1961 in Donetsk (Ukraine). Similar briquetting lines at Alchevsk iron works (Ukraine), Nizhny Tagil and Magnitogorsk Iron and Steel works (Russia) were also commissioned. Experience of the operation of briquetting plants owned by Harsco Metals (United States) [11], producing briquettes for blast furnaces in the United States, Europe, and Asia (the total production volume is 1.5 million tons per year), has shown that the achievement of the required metallurgical properties of briquettes for BF became possible only when using a complex multicomponent binder (composition is not disclosed), whose share in the mass of the briquette reached 15–18%. This explains, in particular, the low content of briquettes in the blast furnace charge (10-15 kg per ton of iron). The same low percentage of roller-pressed briquettes is supported in the BF charge used by the ILVA Company (in Italy). Briquettes are produced by Primetals (Austria) with the use of lime and molasses as a binder [12].

The application of roller briquettes in blast furnace production did not enjoy widespread application, not only because of the high mineral binder content, which reduced the iron content in them, but also because of the substantially lower capacities of roller presses (up to 1200 tons per day) compared to the performance

of the sintering machines (1500–15,000 tons per day) and conveyor indurating machines (2500–19,000 tons per day). However, even in the Ferroalloy industry, where the output and quality requirements of briquettes are much lower than in blast furnace production, roller-pressed briquettes have not been widely used, despite the positive results of full-scale testing of briquette utilization in the charge of ore-smelting furnaces for Silicomanganese production at the Zestafoni Ferroalloys plant, held in the 60s of the past century [13, 14]. Roller-pressed briquettes for industrial experiments were produced by a roller press with a capacity of 5 tons per hour from the Manganese ore with a particle size ranging from 0 to 5 mm using sulfite-alcohol vinasse as a binder (8% of mass) with a density of 1.2 g/cm<sup>3</sup>. The testing furnace operated normally and steadily during testing with decreased power and a reducing agent consumption. The results of testing have shown that manganese ore briquettes are of adequate strength and are suitable for use in the charge of Ferroalloy furnaces.

In 1970, scientists at the Dnipropetrovsk Metallurgical Institute (Ukraine) examined the results of silicomanganese production with roller-pressed briquettes and with sinter in the charge of ore-smelting furnaces. The briquettes were made of a mixture of oxide manganese concentrates of I and II grades of Nikopol ore deposit (Ukraine) in equal amounts. The same mixture of raw materials was used for sinter production [15]. Prior to briquetting the charge was pulverized (from 0-10 mm to 0-3 mm). Briquettes were produced at a semi-industrial roller-press at a pressure of 500 kg/cm<sup>2</sup>. A mixture of bitumen, mazut, and sulfite-alcohol vinasse was applied as a binder (10% of the weight of the briquetted mixture). The batch was mixed in steam-heated containers. Two types of briquettes were manufactured and smelted: with an excess amount of reducing agent (a mixture of concentrates—54.5%, fluvial sand—9.1%, coal—27.3%, bitumen and mazut mixture—3.6%, and sulfite-alcohol vinasse—5.5%) and with the stoichiometric amount of reducing agent required for the reduction of silicon and manganese (a mixture of concentrates—60.6%, fluvial sand—10.1%, coal—20.2% coal, bitumen and mazut—3.6%, and sulfite-alcohol vinasse—5.5%). Laboratory tests have shown the benefits in terms of the strength properties and thermal stability of raw briquettes over the fired ones. It was decided to produce the silicomanganese with raw briquettes in the furnace charge. Experimental smelting with briquettes with the composition indicated above and melting with sinter were carried out in a three-phase open ore-smelting furnace with a capacity of 1.2 MVA at a voltage of 81.60-85.89 V and a current of 6000-6500 A in a continuous process with a closed furnace top. Briquettes with an excess of reducing agent showed enhanced electrical conductivity and when smelted gave a significant increase in current load, which led to the rise of the electrodes and to the opening of the furnace top. Smelting of silicomanganese with briquettes containing a stoichiometric amount of reducing agent in the charge was achieved without any complications. The load was kept steady; nothing else was fed into the furnace but the briquettes. The results of this comparative study showed that smelting of silicomanganese on briquettes is more efficient than smelting with sinter.

In the article [16] the results of the development and commercialization of technologies for the briquetting of a mixture of manganese ore concentrates and bag-house dusts and of the subsequent use of these briquettes for ferroalloys production are set out. The need to recycle these dusts stems from the high volume of their generation (up to 50 thousand tons annually). It has been established that to obtain mechanically strong briquettes (with a specific compressive strength of 8-12 MPa) the optimal parameters of briquetting should be as follows: a moisture content in the blend ranging from 4 to 6%, a binder content (sulfite-alcohol vinasse) of 6-8%, while the share of dust and sludge should be at 30%, with a minimum compressive pressure of 19.6 MPa. The kinetics of the reduction of ore-dust briquettes and of manganese sinter was studied comparatively. It was found that the briquettes in the charge provided the maximum degree of reduction at different temperatures. The use of silicon and manganese from waste materials was increased due to the presence of bound carbon within them, which prevented the formation of silicates inevitably generated in sinter. Results of the smelting of high-carbon ferromanganese melts showed that the productivity of the furnace in which briquettes were used increased from 73.33 up to 75.67 t/day, and specific electricity consumption decreased by 90 kWh/t. Consumption of coke breeze decreased by 34 kg/t. The presence of a carbonaceous reducing agent in briquettes dramatically increases the temperature of the softening of the briquettes up to 1250-1400 °C. Manganese ore fines briquettes manufactured using sulfite-alcohol vinasse as a binder had a softening temperature ranging from 750 to 850 °C.

# 1.4 Vibropressing Briquetting

In the 70s of the past century vibropressing technology began to be used for the agglomeration of natural and anthropogenic raw materials for ferrous metallurgy. The briquettes according to this method are pressed at low pressure (0.02–01 MPa), and with a simultaneous vibration (a frequency of 30–70 Hz and an amplitude of 0.2–0.6 mm) of the pressed mixture. Multicell molds are used for briquetting with dimensions ranging from  $20 \times 20 \times 20$  mm up to  $500 \times 1500 \times 1500$  mm. The pressing cycle lasts no more than 30 s. Vibration with a frequency exceeding 50 Hz, sharply reduces the viscosity of the mixture and internal friction between particles, which facilitates their convergence. During the vibration air and excess moisture are forced out of the mixture. All this together leads to a greater degree of compaction of the briquettes at lower pressures than during compression [17]. Portland cement is widely used as a binder in vibropressing briquetting. Its share can reach 10–15% [18].

The capacity of vibropressing equipment depends on the size of the briquettes that are produced, and does not exceed 30 tons of raw briquettes per hour. Green vibropressed briquettes have a very low mechanical strength, which does not allow them to be transported by conveyor to the warehouse, and requires special arrangements for the stacking of pallets with these briquettes on the shelf and their

subsequent transport to the heat-moisture treatment chamber. One of the first commercial vibropressing briquetting lines was put into operation at the enterprise of SSAB Company in Oxelösund (Sweden) [19]. Briquettes that are 60 × 60 mm in size and hexagonal in cross section are used in the blast furnace (60-100 kg of briquettes per ton of iron). Composition of the briquettes, expressed as a %: 25 flue dust; 50—a mixture of scrap, BOF sludge, pellets fines; 5–8—aspiration dust, 10–12—Portland, 5–8—moisture. The particle size of the components of a mixture ranges from 0 to 5 mm. In March 2012 in Finland at the Raahe Works Company, a vibropressing briquetting line for the production of briquettes for blast furnaces was commissioned after the closing of the sinter plant [20]. Briquetted charge consisted of: mixture of pellets fines (71,000 tons), coke dust (12,000 tons), premix of flue dust and steel scrap (59,000 tons), mill scale (59,000 tons), briquettes fines (34,000 tons) and scrap (15,000 tons), and slag cement (17,000 tons) and rapid cement (19,000 tons). The total amount of briquettes recycled via blast furnace process is 283,000 tons per year. Briquette size is  $60 \times 60$  mm and weight is 475 g. After the 48 h of strengthening the cold strength of briquettes according to ISO 4696 was 74% (the share of pieces larger than 6.3 mm). Coke rate was decreased by 6% by feeding 120-130 kg of briquettes per 1 ton of hot metal into the charge of the BF due to the fact that the briquettes contained carbon. It is seen that vibropressing led to the formation of significant quantities of briquettes fines (34,000 tons per year). It was also impossible to agglomerate efficiently BOF sludge (60,000 tons per year; moisture content 33-39%) and BF sludge (30,000 tons per year; moisture content 20-25%) by vibropressing. In 2017, these materials were tested by SVE agglomeration method. It was concluded that the brex made of BOF sludge, pellets fines, and coke dust might be suitable for the blast furnace.

At another SSAB enterprise vibropressed briquettes are manufactured from the mixture of pellets fines, dusts, and sludge from BF and from steelmaking units. Briquettes with two different compositions (93.5% of pellets fines, 6.5% of Portland cement and 62.7% of pellets fines, 30.8% of sludge and dusts, and 6.5% of Portland cement) are produced using the vibropressing method. One peculiarity of these briquettes is a tendency to swell considerably during the reduction process using carbon monoxide at 950 °C, which is linked with a similar abnormal swelling of the indurated pellets [21–23]. The mechanism of the catastrophic swelling of iron ore pellets is associated with the growth of iron whiskers during wustite reduction, which is enhanced in the presence of CaO [24, 25]. The degree of swelling decreased when adding hydrogen to the reducing gas. Something that was also noted was the fact that the tendency to swell in the presence of cement is reduced when its content in the body of a briquette exceeds 10% (mass). The largest degree of briquette swelling took place with a cement share in the mass of the briquette ranging from 4 to 6%. It was noted that at high temperatures the converted phases of cement, olivine, and wustite react with the formation of (Ca, Mg, Fe)<sub>2</sub>SiO<sub>4</sub> (dicalcium silicate, forsterite, and fayalite). The properties of this phase are determined by the relationship between the values content of pellets fines and cement. The formation of the silicate melt at a lower temperature is also possible (1150 °C). These briquettes were also tested in the experimental blast furnace. It is claimed that unlike testing of the briquettes in laboratory conditions, their reduction in the experimental blast furnace was not accompanied by catastrophic swelling. Reduced briquettes, after extraction from the experimental blast furnace, had a significant wustite core even with fairly profound lowering in the furnace. For the explanation, authors indicated the following possible reasons: a large volume of briquettes, creation of a slag system CaO–SiO<sub>2</sub>–MgO–Al<sub>2</sub>O<sub>3</sub>–FeO, and coating of the wustite grains in a molten slag.

Application of the Blast furnace simulator for the study of the behavior of vibropressed briquettes was described in article [26]. The main components of briquettes are—mill scale (41.2%), various scraps (23.4%), flue dust (9.5%), aspiration dust from the dosing and casting units (4.8%), coke dust (6.4%), pellets fines (2.8%), and other anthropogenic materials. Three different combinations of binders were applied: 10% Portland cement; 8% Portland cement +3% crushed granulated slag; 8% of Portland cement +6% crushed granulated slag. Briquettes were manufactured on an industrial vibropressing line, however, for blast furnace simulator tests samples of briquettes were cut into bars with a cross section in the shape of a triangle (Fig. 1.2).

It is clear, however, that in this case, it was impossible to obtain authentic test results, because the specific surface of the briquette sample (the ratio of surface area to volume) was higher than in the original briquette and hence the speed of reduction was different. The following results were obtained in the tests:

(1) Briquettes showed a significantly faster reduction compared with pellets in the temperature range of 780–1100 °C, which can be explained by the presence of carbon in their composition and by a higher porosity, which, according to the authors, was due to the effects of hematite–magnetite phase transition;

(2) Swelling of briquettes (25–50%) was observed during the wustite–iron phase transition at 900–1000 °C;

- (3) The addition of granulated slag had a slight increasing effect on the swelling of the briquettes. The effect was more pronounced with a 3% addition than with a 6% addition;
- (4) The structure of the briquette does not disintegrate in BF conditions even though the cement phases decompose in the high temperature of the BF process. The phase transformation of Ca(OH)<sub>2</sub> first to CaCO<sub>3</sub> and secondly to Ca<sub>2</sub>Fe<sub>2</sub>O<sub>5</sub> may have an effect on this behavior.

In Russia, the first vibropressing briquetting factory was commissioned at the JSC Tulachermet in 2003 [27]. The capacity of the line enabled a monthly production of up to 8000 tons of briquettes. Two types of briquettes were used as charge components of a BF: so-called "washing" briquettes that contained iron and carbon. It is known that in some cases, technologists were faced with "cluttering" of the hearth of the blast furnace due to the deterioration of coke's ability to filter when filling the voids between its particles with pieces of slowly moving smelting products. This can result in combustion of air tuyeres, decrease of hearth heating, and other phenomena, which reduce the melting performance. One of the most effective means of combating this phenomenon is "flushing" the hearth using liquid slag containing FeO or MnO. Typically, the special sinter made using mill scale serves as the "washing" material. Mill scale briquettes can also be used for such purposes. The value for the design compressive strength was supposed to be at least 6.0 MPa. After drying its values were—3.83 MPa, after heat-moisture treatment—6.9 MPa.

In total, during the course of the existence of the line more than 52 thousand tons of briquettes were manufactured (about 50 thousand tons of briquettes containing iron and carbon, and 2700 tons of washing briquettes). During the unloading of the briquettes from the bunker their bridging was noted [28]. The maximum shares of the briquettes in the charge of the blast furnaces were as follows: BF No. 1–32 kg/t of hot metal, BF No. 2–56 kg/t of hot metal. With the application of briquettes flue dust blowout decreased by 4 kg/t.

Factor analysis showed that with the application of iron and carbon containing briquettes the specific consumption of dry skip coke decreased by 14.4 kg/t of hot metal, which corresponded to the coke's replacement in the body of the briquettes with coke breeze by a ratio of 1 to 1. Pig iron production increased by 37 tons/day, which is associated with an improvement in the gas permeability of the charge column due to the improved granular composition of the charge. This helped to increase the blast volume and, as a result, to intensify melting.

After several years of operation, the briquetting factory was closed as a result of changes in economic conditions affecting the availability of suitable carbonaceous materials for briquetting.

A series of campaigns on the use of vibropressed briquettes of varying compositions on a cement binder in the charge of blast furnace with a volume  $1000~\text{m}^3$  was carried out in 2003-2004 by the Novolipetsk Steel Company (JSC NLMK) [29-31].

In the first stage for the evaluation of the effectiveness of the iron-zinc-containing sludge recycling 2500 tons of briquettes were smelted. The composition of the briquettes was as follows: 65% converter sludge, 20% coke breeze, and 15% Portland cement binder. The laboratory tests for optimization of the composition of the briquettes conducted later proved that their carbon content (Table 1.1), was oversized [32]. The coke rate in the (10 day) period of trial melts varied over a range from 50 to 70 kg/t during the first 5 days up to 190 kg/t during the final few days and 121 kg/t of hot metal was produced on average. The economic performance of the furnace operation in trial and in reference periods and the results of the computer simulation of the BF melt using sludge and coke briquettes are shown in Table 1.2.

In the course of the smelting of the briquettes the coke to coke breeze replacement factor was 0.96 kg/kg, and the replacement factor for the carbon in the coke to the carbon in the briquettes was 0.88 kg/kg. The decrease in furnace productivity during the smelting of the briquettes, apart from the decrease of the iron content in the burden, was induced by an increased physical and chemical heating of the melt products, due to an inadequate adjustment of the burden-weight ratio together with the increased rate of the carbon-bearing component in the burden, which was not well known to BF process engineers. The furnace productivity was also influenced by a high basicity, together with a high-melting slag from the waste ore in the briquettes, which was slowly assimilated by ferrous primary slag formed of sinter and pellets, which as a result increased the slag viscosity.

In the second stage, 2475 tons of briquettes made of a mixture of iron ore concentrate, coke breeze, and Portland cement were smelted. The aim of the trial melts using briquettes made of iron ore concentrate was to estimate the feasibility and efficiency of the smelting of cement-bonded briquettes in large quantities for the maximum replacement of coke with coke breeze, which serves as a reductant in the briquettes. Magnetite iron ore concentrate was used for briquette production. These briquettes (Table 1.3), which are the same as the briquettes made from BOF sludge, were produced with an oversized fraction of coke breeze (20%) and cement (15%).

Smelting of a trial lot of iron ore and coke briquettes between August–September 2003 was carried out in three stages with a gradual increase of the briquettes rate (122, 198, and 303 kg/t of hot metal). Fractional analysis of the BF burden in the course of the briquettes smelting essentially differed from the fractional analysis of the burden during the reference period and in essence varied with the briquettes rate increase. This is primarily relevant for pellets, for which the fraction in the burden during the reference period was 23%, and during the briquettes smelting it decreased down to 12.7, 11.8, and 4.3%. The sinter fraction in the burden also fluctuated noticeably: 76.9, 80, 76.3, and 78.4%, accordingly (Table 1.4).

With respect to the overall impact of the briquettes rate on furnace productivity, apart from the decrease of Fe content in the burden, it is induced, in the same way as with sludge and coke briquettes, by the formation of a high-melting slag with high basicity from the waste ore of the briquettes, leading to a viscosity increase in all the primary slag.

The efficiency of the application of coke breeze, contained in the briquettes, was decreasing pro rata to their amount, which was related to the oversized content of carbon in the briquettes, which by 5% exceeded the stoichiometric amount (12.2%) required for reduction of iron oxide in the briquettes. The coke breeze that was not consumed for the reduction of iron in the briquette itself and iron in the primary slag, remained in the coke bed, decreasing its drainage capacity.

The "DMI" calculation confirmed the accumulation of coke breeze in the coke bed. In the BF operating period after the smelting of the briquettes (6–10.09.2003) "DMI" decreased by 1.34 times against the operating period prior to the smelting of the briquettes (21–25.08.2003), showing values of 127 and 170 for these periods, respectively. The coke to coke breeze replacement factor was decreasing with the increase of the briquettes rate due to the reasons given above.

Industrial experience of the utilization of these briquettes in the BF melt enables a conclusion to be made that such briquettes, provided the optimum content of the carbon and the minimum cement content are just enough to reach the required strength of the briquettes, constitutes a full-fledged, ready self-reducing component of the BF burden, and its implementation ensures a decrease in the coke rate in the BF melt.

In the third stage, 2560 tons of vibropressed briquettes made of a mixture of BF sludge (59%), mill scale (20%), coke breeze (10%), and cement (11%) were smelted in a blast furnace with a volume 2000 m³. Increased bridging has been observed during the discharging of the briquettes from the bunkers. In order to estimate the efficiency of such a recycling scheme, a trial lot of such briquettes was produced, which apart from BF sludge (59%) and cement (11%) contained rolling mill scale (20%) and coke breeze (10%). The average chemical composition of the briquettes is shown in Table 1.5.

These briquettes (2560 t) were smelted within a period of 11 days (from 29.11.2004 until 9.12.2004) in a BF with a useful volume of 2000 m<sup>3</sup>. The average briquettes rate for the period was 62 kg/t with a daily variation ranging from 36 kg/t up to 81 kg/t. The efficiency of the smelting of the sludge and coke briquettes was evaluated by way of a comparison of the melting characteristics in the trial period and in the reference period of the operation of the BF. The average characteristics for the furnace operation periods before (6–10.11.04, 26–28.11.04) and after the smelting of the briquettes (11–15.12.04) were taken as the reference period characteristics (Table 1.6).

A slight reduction of BF productivity during the smelting of the briquettes was mainly induced by the decrease in iron content in the burden, as well as by the negative influence of excessive basicity and viscosity of slag, formed out of the waste ore of the briquettes.

With regard to the lower carbon in the coke to the carbon in the briquettes replacement factor, when compared to the value obtained during smelting of the BOF sludge briquettes (0.88 kg/kg), this can be explained by the fact that the carbon content in the briquettes significantly exceeded the stoichiometrically required value (9.3%).

The amount of carbon that is accumulated by the briquettes together with the carbon-bearing BF sludge would be quite sufficient for a complete reduction of contained iron [32].

The results of experimental melts confirmed the effective application of iron and carbon containing briquettes as a new blast furnace charge component. Due to the presence of carbon such briquettes are self-reducing and their utilization leads to a proportional reduction of coke consumption. The main results of the campaigns are as follows: vibropressing can provide the required values for the mechanical strength of briquettes made of natural and anthropogenic oxide materials with a share of the cement binder of not less than 8–10% by weight of a briquette; the value of the compressive strength for most of the briquettes was not less than 30 kgf/cm<sup>2</sup> and ensured their integrity during overloads and transportation with a less than 5–7% fines generation (–10 mm).

The results of the investigation of the metallurgical properties of the laboratory briquettes made by vibropressing, as well as of briquettes used in full-scale testing are described in [32]. In particular, the behavior of carbon-free briquettes made of magnetite concentrate (91.2%), Portland cement (8.8%), BOF sludge (91.9%), and Portland cement (9.1%) whilst undergoing heating in the reducing atmosphere has been studied. Since the cement binder maintains the strength of the briquette up to temperatures of 750–900 °C, the formation of new solid briquette microstructures was attributed to physical-chemical processes that occur in the body when heating





Fig. 1.3 Microstructure of a reduced briquette made of magnetite concentrate. Left: 1—metallic grains, 2—wustite, 3—olivine phase; right: 1—wustite, 2—olivine phase. Reflected light, magnification  $\times$  500

the briquettes in a reducing atmosphere. Such processes are primarily a reduction of iron oxides in the solid-state reaction between wustite, oxides of cement stone, and gangue components of a briquette with the formation of calcium-iron-magnesium silicates. In the briquettes made of magnetite concentrate and converter sludge, a zonal microstructure with a surface layer of metallic iron has been optically determined. This fact is due to the relatively high density of briquettes, their considerable size and the lack of a solid reductant in their composition. In the briquettes made of iron ore magnetite concentrate a magnetite to wustite reduction process is clearly diagnosed throughout the volume of the sample, on the surface there is the layer of metallic iron with a thickness of 3-5 mm, forming a superficial shell (skeleton) of a briquette (Fig. 1.3, left). In the deeper layers (up to a distance of 20– 25 mm from the surface of the briquettes) only small zones can be observed with particles of metallic iron on the edges of the wustite grains. In the central part of briquette, the metallic iron is missing and the entire iron containing phase is represented only by wustite and ferrous olivine. Depending on temperature and duration the conditions of a briquette in a reducing atmosphere in different parts of the briquette iron-silicate phase was either in a plastic or a near-plastic state and was filling the space between grains of ore in the form of a glass phase (Fig. 1.3, right). Due to the large content of  $SiO_2$  in the concentrate (6.3%), the presence of impurities Al<sub>2</sub>O<sub>3</sub>, MgO in the mineral phases of cement, as well as the extended surface of contact between the concentrate (particle size 70–120 µm) and cement stone particles, a large portion of the active wustite—a product of magnetite reduction—reacts with silica and forms a system Fe<sub>2</sub>SiO<sub>4</sub>-Ca<sub>2</sub>SiO<sub>4</sub> comprising an eutectic with a crystallization temperature of 1120 °C (phase diagram CaO-FeO-SiO<sub>2</sub> on Fig. 1.4). Iron-silicate phase has a low reducibility, which together with the diffusive difficulties and large size of a briquette explains the lack of metal iron in its central part. Conservation of the form of a briquette made of magnetite concentrate as it undergoes heating in a reducing atmosphere is provided by the formation of a surface metal iron frame with a thickness of 3–5 mm, which ensures

the strength of a briquette at the stage of dehydration of calcium hydrosilicates in the cement stone. According to the authors, the destruction of a briquette as it is heated up to 1150 °C is also prevented by the formation of an iron–silicate matrix of iron–calcium olivine in the full body of the briquette.

It is known that the system CaO–FeO–SiO $_2$  has a eutectic (25% CaO  $\cdot$  SiO $_2$  and 75% FeO  $\cdot$  SiO $_2$ ) with a crystallization temperature of 1030 °C. There are also fields with a crystallization temperature close to 1150 °C.

Apparently, because of the limited time in the furnace at a temperature of 1150 °C and above, the iron–silicate phase does not reach a liquidus temperature and remained in a plastic condition without violating the integrity of the briquette in the already established frame of metallic iron with a melting point above 1500 °C.

In 2010, the Kosaya Gora Iron works vibropressing briquetting factory (located in Russia) was commissioned for the production of 120,000 tons of briquettes from a mixture of iron ore concentrates and fines, and flue dust with a Portland cement binder (not less than 10% by weight of the briquette). The exposure time of the briquettes in a curing chamber (for heat-moisture treatment)—36 h. The density of briquettes ranged from 2.0 to 5.0 g/cm³. Their compressive strength: not less than 3.5 MPa, and the moisture content was up to 9%. The proportion of briquettes in the ore part of the blast furnace charge—100 kg per ton of hot metal. Bridging was noted during loading [34]. In total, the factory has produced over 300 thousand tons of briquettes. There is almost no information available in open source material concerning a systematic analysis of the results of the operation of this factory. The factory has practically been out of operation since October 2015.

The results of full-scale testing and of the practical implementation of vibropressing briquetting technology confirm the possibility of achieving the required level in terms of the metallurgical properties of the agglomerated products. However, this technology creates some significant technological limitations, which are difficult to overcome, or leads to a significant increase in the cost of a briquette.

# 1.5 Stiff Vacuum Extrusion Briquetting. What's the Difference?

The first attempt to use extrusion for agglomeration of iron ore fines took place in the 50s of the past century. A hydrated mixture of iron ore fines and bentonite was filed in a chamber and then extruded in a vacuum through the die with the production of cylindrical briquettes [35]. However, this method had not enjoyed a wide distribution at that time. Unsuccessful attempts to use extrusion for agglomeration of raw materials in the steel industry were made in the USSR in the 60s of the past century. The first successful experience of extrusion agglomeration of flue dust and sludge for a blast furnace took place at the Bethlehem Steel Company plant (in the United States) in 1993 [5]. A briquetting line with a capacity of 20 tons of raw briquettes per hour was commissioned. The equipment was supplied by J. C. Steele & Sons, Inc. (NC, USA). The line worked until the closure of the plant in 1996. In 1993, an extrusion agglomeration line was commissioned in Colombia at a ferronickel smelter. Gas cleaning and aspiration dusts from ferronickel production and laterite nickel ore fines were agglomerated without a binder. The capacity of the extrusion line is 700 thousand tons of briquettes annually. Currently, the plant is owned by BHP Billiton. Cost of production of one ton of briquettes does not exceed \$2.1.

The lack of published results of a study of the metallurgical properties of these first extruded briquettes explains that the success of the first industrial projects on extrusion agglomeration did not attract wide attention. In the literature on briquetting in metallurgy, the technology of SVE for agglomerating metallurgical raw materials is either not mentioned [1] or the sphere of its application in metallurgy was limited to the manufacture of granules for sintering and its use for briquetting of metallurgical raw materials for blast furnaces was considered to be ineffective [36].

In 2010, the authors attempted to study the experience of the first industrial SVE lines. Based on the results of their operation and data posted on the official Internet sites of briquetting equipment manufacturers, including roller and vibropressing equipment, the process characteristics together with the properties of the briquettes were summarized in a comparative table (Table 1.7).

It is evident that SVE agglomeration technology is superior to existing industrial briquetting technologies in terms of its maximum capacity. None of the known roller and vibropressing briquetting factories have reached the scale of production attained by the aforementioned factory, owned by BHP Billiton in Colombia [37]. SVE requires a lower consumption of the cement Binder and is less demanding on the moisture content of the charge (drying is not required), in addition, it enables production of briquettes of a minimum size (diameter) compared to the size of the sinter and pellets.

### 1.6 Conclusions

In the nineteenth century, briquetting was the first and only industrial technology for agglomeration of fine anthropogenic and natural raw materials for the steel industry. Since the twentieth century, sintering and pelletizing have become the main agglomeration technologies. Manufacture of briquettes for use in iron, steel, and ferroalloys production processes using roller-pressing and vibropressing technologies currently enjoy limited application.

The metallurgical properties of vibropressed briquettes meet the requirements of the blast furnace process (except for their size) and they can be considered as components of a blast furnaces charge, however, a high cement binder content increases their costs and adversely affects the viscosity of the primary slag produced from these briquettes. The cost of such briquettes increases also as a result of the need to apply heat-moisture treatment since the mechanical strength of green briquettes is negligible.

Roller-press briquettes on organic binders are suitable for use in steelmaking units. The big disadvantage of roll-pressed briquetting is the high rate of returns (up to 30%) and the high mineral binder content.

At the end of the twentieth century, SVE agglomeration technology began to be used. The main advantages of the new technology compared with roller-pressing and vibropressing technology lie in their higher performance, reduced consumption of the binder, and the possibility of agglomerating wet materials.

SVE technology has a number of features that led to the emergence of a specific name for extruded briquettes—BREX.

The results of the operation of large-scale briquetting factories using SVE for agglomeration of laterite nickel ore fines and gas cleaning, and aspiration dusts from ferronickel production demonstrated the ability to achieve high levels of productivity from briquetting lines with low capital costs.

The results of the comparative analysis of technical and economic indexes of the three main industrial briquetting technologies enables SVE technology to be chosen rightly as the prospective technology for agglomeration of anthropogenic and natural raw materials in ferrous metallurgy.

# Chapter 2 Features of Stiff Vacuum Extrusion as a Method of Briquetting Natural and Anthropogenic Raw Materials

Stiff vacuum extrusion (SVE) technology is applied in the production of ceramic bricks in 64 countries around the world, including the United States, Britain, Germany, South Korea, and South Africa. The world's largest brick factory in Saudi Arabia produces a million bricks per day using SVE technology [1].

In accordance with brick industry terminology, the word "stiff" is used to describe the process of extrusion, which is carried out at pressures ranging from 2.5 to 4.5 MPa and moisture contents ranging from 12 to 18% (Table 2.1 [2]).

### 2.1 Preparation of Burden Materials for SVE Briquetting

One of the basic criteria determining the suitability of extrusion material is its plasticity—a trait that assures that it can be effectively pushed through the holes in die. A necessary condition for the status of plasticity is complying with the granulometric composition and moisture content requirements for SVE. In some cases, additional pulverization may be required in order to achieve the desired plasticity of material.

Unlike a roller press and vibropress briquetting, shear stress plays an important role in SVE agglomeration. Shear stress occurs when the mixture is processed in the screw feeder, in pug mills, and then in the extruder. In [3], based on a comparison of coal briquette porosity values in various pressing options (compression and its combination with torsion), it was found that more dense briquettes (less porous) are formed in the combined pressing option (under identical values of applied pressure). With full compression, a significant proportion of energy is expended on the elastic deformation of the particles themselves, while, in the presence of shear stress, the convergence of particles on the surface forces activation distance is more effective. In full compression of close-packed particles, each particle only comes into contact with its immediate neighbors and is subjected to a compression load. Under shear stress, the particles of the adjacent layers are subjected to abrasion due

to contact with irregular surfaces, which can lead to crushing, the opening up of new surfaces, and, hence, to an increase in the number of contacts between particles of the mixture.

In order to identify the possible impact of shear stress on the change of particle size distribution of briquetted material in conditions of SVE, we have compared the results of pulverization of coke fines in three different ways: in a hammer mill, in a roller crusher, and by double shearing through shearing plate in the extruder (Fig. 2.1). Samples of original coke breeze had the following properties: 8.97% moisture content; 13.28% ash content; volatile content 3.45%; 0.61% sulfur content. Since coke breeze particle was larger in size than what is usually required for extrusion, they were pulverized.




Fig. 2.2 Granulometric composition of coke breeze in the following states: (1) initial and (2–4) after additional grinding in a hammer mill, in a roll crusher, and double extrusion in an extruder, respectively.  $\gamma$  is the yield of the oversize mass, and a is the mesh size

Wet screens were used to determine particle size distributions of raw materials. Moisture content was measured using a moisture balance. A calibrated electronic scale with a density measuring attachment was used to determine pellet density. The results of the granulometric analysis are presented in Fig. 2.2.

As evidenced above, the grinding of coke breeze is maximized after double extrusion through a shearing plate in an extruder. In this case, the effect of deep grinding is achieved through the application of high shear stresses. The use of a hammer mill for such a material was found to be ineffective, and the granulometric composition of the ground material differed weakly from that of the initial coke breeze.

Based on these results, we decided to study the effects of the grinding method on the strength of the brex produced from coke breeze pulverized in different manners. Three portions of brex of the same composition—94% of coke breeze, 5% of Portland cement, and 1% bentonite—were manufactured. The only difference between the brex was the manner in which the coke breeze was ground. The brex were classified assigned the following numbers in accordance with the method of grinding: No. 1 was coke breeze ground by roller crusher; No. 2 was coke breeze sheared twice through the shearing plate with a plurality of holes; No. 3 was coke breeze ground by hammer mill. Extrusion parameters and physical properties of brex are shown in Table 2.2.

It follows from these data that the extrusion of the first two mixtures was carried out in accordance with similar processing parameters and that the extrusion of the coarser particles in mixture No. 3 (hammer mill) is accompanied by an increase in the temperature of the material. As a result, the brex made of the largest particles turned out to have the minimum strength in axial compression tests. As for energy consumption, the extrusion of mixture No. 1 was most efficient. Its excellent extrusion ability can be attributed to the material particle shape after grinding in a roll crusher, which favors the plane-parallel orientation of particles.

The difference between the tensile strengths of samples No. 1 and No. 2 is insignificant and only indicates an earlier beginning of cracking in brex No. 2. It also follows from this data that the density of brex after double extrusion exceeds



that of brex samples made of ground and milled coke breeze by 2.5%. Obviously, the dense packing of brex No. 2 particles is the result of a high degree of material grinding. In contrast to brex samples No. 1 and No. 3, no mixture dewatering was detected during extrusion in this case. Differences in compressive strengths of brex samples prepared from differently treated coke breeze of the same batch—can result from a number of factors related to different particle sizes, shapes, and surface relief. The shape of a particle after grinding depends on material characteristics and the grinding method, including time [4–6]. For example, it is generally accepted that, after grinding in roll crushers, the material mainly consists of angular particles, whereas the material particles usually maintain the same size and a rounded shape after ball and hammer milling. In roll crushers, grinding occurs under the compressive, shear, and rubbing forces. As a result, you have rough particles with sharp projections, many edges and corners, and (correspondingly) a large contact surface form. When the material is ground by hammer mill, the particle surfaces are polished by way of impact and the particles acquire a rounded shape.


For example, the researchers [7] studied the effect of grinding device on oil coke particle shape of (1) low-porosity coke with thick cell walls without visible cracks and (2) fissured coke whose porosity and cell wall thickness of which were distributed over a wide range. In the first instance, grinding method did not affect the shape of particles  $200-600 \mu m$  in size. In the second instance, it was revealed that the particle shape is dependent on particle size in various ways when ground in a hammer mill and in a roll crusher (Fig. 2.3) [7].

These curves reflect the following dependence of the shape factor:  $\phi = 1.1V1/3N1/6A-1/2$ , where V is the specific particle volume (cm<sup>3</sup>/g), N is the number of particles in 1 g substance, and A is the specific surface area (cm<sup>2</sup>/g). The material particles ground in a hammer mill are characterized by stable high shape factors, which indicate the closeness of most of the particles' forms to a rounded shape in

**Fig. 2.4** Structure of coke breeze particle (scanning electron microscopy)




the indicated size range. For the particles of the material ground in a roll crusher, the shape factors in the 140–600  $\mu$ m particle size range are lower and minimal at a size of  $\sim 350~\mu$ m, which supports the conclusion about a more nonuniform particle shape after grinding in a roll crusher.

As in [7], we used a porous and fissured material. Figure 2.4 shows an image of coke breeze particles taken with a JEOL JSM\_6490 LV scanning electron microscope (SEM). In Fig. 2.5, we compare the particle shapes of the initial coke breeze and the coke breeze after additional grinding. The initial coke breeze particles are characterized by hillocks (rounded projections), which are typical of coke; they belong to internal (not opened) pores located under the upper layers of the carbon material. It is seen that the particles after a roll crusher and double extrusion through an extruder have a nonuniform angular shape, whereas the coke breeze particles ground in a hammer mill have a rounded shape.


The brex samples were subjected to tensile splitting tests on a bench-type one-column electromechanical Instron 3345 tensile testing machine at a load of 5 kN. When studying the statistics of brex orientation distribution in a charge, we [8, 9] found that this type of external load is most probable for a cylindrical brex. Figure 2.6 shows the results of testing specially prepared cylindrical specimens of brex 1–3 25 mm in diameter and 20 mm in height. It is seen that, at approximately the same carrying ability, the brex specimens' reactions to an applied load are different.

The difference in the maximum loads can be related to defects in the specimens. However, the difference in the characters of behavior can have radically different causes. Brex No. 2 demonstrates ductile fracture, which is indicated by the existence of a yield plateau, i.e., the horizontal component of the brex No. 2 curve. This phenomenon is thought to be explained by a "relay-race" grain to grain gliding transfer in accordance with the Hall–Petch equation stipulating an inverse relationship between grain size and yield strength [10]. In this case, a grain boundary is a barrier to dislocation motion, which causes dislocation nucleation and development

in a neighboring grain. In other words, the larger the number of barriers to be overcome, the lower the dislocation motions dynamics and the higher the crack development resistance.

Apparently, there exists a threshold particle size, below which cracks cannot propagate in brex. Obviously, the granulometric composition of the brex No. 2 mixture favors this scenario due to the highest content of thin particles among the other mixtures (see Table 2.2). The integrity of brex No. 2 is retained even after tests; therefore, high impact strength can be expected. At this type of loading, local fracture zones will not cause full fracture and debris formation in a specimen. The load-displacement curves of brex No. 1 and No. 3 decrease significantly after crack initiation, which points to more brittle fracture of these specimens. The brittle fracture in brex No. 1 develops more slowly than it does in brex No. 3 because of a smaller average particle size. Note that these circumstances are very important for briquetting. Several stages of charging-discharging related to throwing down briquettes can be required to supply the briquettes to a furnace even in one enterprise. When the impact toughness of an agglomerated product is increased, the logistics of supplying it to the site, including those that are far away, can be significantly simplified and, hence, be made cheaper. It is important for stiff extrusion that a change in the behavior of brex under external mechanical action was achieved using same agglomeration equipment.




Fig. 2.7 SEM micrographs of the particle surfaces in brex No. 3 (a) and No. 2 (b)

In addition to the physical mechanisms that weaken dislocation propagation, leading to a high strength of brex made of small particles, the distribution of a binder in the brex body also substantially contributes to its strength. It is clear that the low strength of brex No. 3 during compression can be explained by a small amount of contacts between particles. Figure 2.7 shows micrographs of the particle surfaces in brex No. 3 (grinding in a hammer mill) and brex No. 2 (double extrusion through a shearing plate). It is clearly visible that, because of the lower particle surface roughness of brex No. 3 as compared to brex No. 2, the number of hillocks with a binder (cement and bentonite) on their surface (bright aggregates) is significantly lower. (Since minerals contain heavy chemical elements, they manifest themselves as bright precipitates in micrographs.) Therefore, the surface relief of the brex No. 2 particles also favors good adhesion of particles due to the large binder volume that covers the sites of particle–particle contacts.




Fig. 2.8 Bentonite fibers on **a** the particle surface in brex No. 2 and **b** on the surface of glass microspheres [11]




Fig. 2.9 Bentonite particles in brex No. 1 (a) and No. 3 (b)

When studying the particle surfaces of brex No. 2, we detected bentonite fibers, which were described for the first time in [11]. Figure 2.8 shows the surface of brex No. 2 particle and the surfaces of glass microspheres subjected to soft rolling (without crashing) in a roll crusher which imitated shear stresses. This treatment promoted the development of bentonite fibers covering the particle surface. After this preliminary treatment of a magnetite concentrate and bentonite mixture, the fraction of bentonite required for the given strength decreased twofold (from 0.66 to 0.33% concentrate mass). The appearance of this structure in brex No. 2 is likely to result from the shear stress applied to the material during auger extrusion. The effect of the appearance of bentonite fibers is less pronounced in brex No. 1 and No. 3, which is likely to be associated with a lower fraction of thin particles. Brex No. 1 and No. 3 have predominantly lamellar and flake-like bentonite particles (Fig. 2.9).

A mixture becomes suitable for extrusions through the addition of a plasticizing agent, mainly bentonite, to a charge. The fraction of bentonite required to ensure the extrusion of a mixture oscillates in the 0.25-1.0% range of the briquetted material density. An important consequence of the plasticized mixture is an increase in the mechanical strength of brex and a change in the character of its fracture from brittle to viscoplastic fracture.





Fig. 2.10 Stress  $\sigma$ -strain  $\epsilon$  curves for brex based on aspiration dust **a** without and **b** with 0.5% bentonite

Below, we present axial compression test results of first series brex made of a charge of a base composition of 67% dust of the aspiration of ferrochrome production, 15% chromium ore concentrate, 15% coal, 3% Portland cement, and second series brex made of the same charge with an addition of 0.5% bentonite that were performed in a laboratory extruder. The axial compression tests of the brex of both series were carried out on a bench-type one-column electromechanical Instron 3345 tensile testing machine at a load of up to 5 kN. Figure 2.10 shows the stress-strain curves that demonstrate the change in the character of fracture of bentonite-containing brex from pronounced brittle to viscoplastic fracture. This change is also illustrated in Fig. 2.11, which shows that in the case of fracture of bentonite-containing brex, the compression surfaces of the tensile testing machine should be much closer than they are in the case of bentonite-free brex. A comparison of the strengths of the brex of two series showed that the average

ultimate compressive strength of the brex made of a bentonite-free mixture is 1.88 MPa and that of bentonite-containing brex is 2.08 MPa (higher by 10%).

As for traditional methods of briquetting, the favorable effects of bentonite or bentonite in combination with Portland cement on the strength of briquettes is well known [12, 13]. An attempt to determine the optimum ratio of the fractions of Portland cement and bentonite in a charge to be briquetted was described in patent [14]. It was stated that the addition of a bentonite (15–25%) and Portland cement (85–75%) binder enhances the mechanical strength of the corresponding briquette. For briquettes consisting of converter sludge (24.3%), scale (23.4%), blast furnace dust (23.4%), iron ore fines (18.9%), and binder (10%) consisting of 75% Portland cement and 25% bentonite, the result of a drum test (fraction of a size of >6.3 mm)

increased to 76% (it was 67% for briquettes of the same composition but without bentonite).

We studied the influence of this combined binder on both the compressive strength of brex and the rate of strength augmentation during strengthening storage under natural conditions. For tests, we chose the brex that were produced in the industrial line of stiff vacuum extrusion located at Suraj Products Ltd. (India) and contained (%) 47.2 converter sludge, 28.3 blast furnace dust, 18.9 iron ore fines, 4.7 Portland cement, and 0.9 bentonite. Portland cement and bentonite were manually mixed in a dried state and added to a charge mixture before a pug sealer. For brex samples, we measured compressive strength  $\sigma$  (on Tonipact 3000 (Germany) according to standard DIN 51067), open (apparent) porosity  $\eta$  (vacuum method of liquid saturation according to standard DIN 51056), and density  $\rho$  (on Metler (United States) balance) daily. Table 2.3 shows the results of our daily measurements over the course of 9 days.





Fig. 2.12 Changes in compressive strength and porosity of brex during strengthening 9-day storage

Figure 2.12 shows the brex porosity and strength curves measured during structuring storage. A pronounced local maximum is clearly visible in the brex strength curve on the third day. On the next day, this changes into softening. The strength increases over the course of further storage. Note that, before softening, the brex strength accounts for  $\sim 84\%$  of the brex strength after strengthening storage for 1 week. The change of open porosity almost repeats the change of strength, except for the first day of strengthening. The decrease in the porosity at that time is obviously related to the swelling of bentonite, which fills the pore space [15].

We obtained similar results for brex strength during compressive strength and splitting strength tests performed on a strength-testing machine consisting of a hand-power press, a strain gage, and a recording device (Fig. 2.13).

On the third day of strengthening, the brex samples retained their integrity through the end of testing and demonstrated a viscoplastic character of fracture during compressive and tensile splitting tests. On the third day of strengthening, both halves of the brex were connected despite the development of almost a

complete crack in the tensile splitting test. The compression and splitting of brex led to the release of moisture on the bottom. Moisture release was absent during compression on the seventh day of strengthening. When samples were subjected to compressive and tensile splitting tests on the seventh day of strengthening, the viscoplastic character of fracture was substantially lost.

This effect of nonmonotonic strengthening of briquettes with a cement binder, characterized by a local strength maximum and accompanied by viscoplastic

behavior at a breaking load, had been neither detected nor described previously. The strengthening of monomineral cement stone and concrete is known to be of a monotonic character [16]. This nonmonotonic character is well noted in the process of increasing the strength of binderless brex or of brex with an alternative (no cement) binder. Ozhogin [17] presents data on the impact fracture (analog of dropping strength) oscillations of briquettes having no binder and having different compositions upon drying under natural conditions (at a temperature of 20 °C). The detected softening was thought to be caused by recrystallization, and it was recommended to limit the transportation and transfer of briquettes at this time and to store briquettes in closed vessels.

The application of a cement-bentonite binder changes the behavior of brex substantially during a braking action, increases its impact strength, and decreases the probability of brittle fracture.


This behavior of brex can be explained by cement–bentonite binder properties related to the formation of coagulation structures in the cement-bentonite-water system, which leads to the modification of the properties of the binder. Such structures are known to form in the gel-cement solutions used for the cementation of boreholes. The properties of the gel-cement solutions and the theoretical and practical aspects of the formation and fracture of cement-bentonite systems are well known and systematized in, e.g., [18]. The driving force of the formation of such structures is the attraction of negatively charged bentonite particles to positively charged Portland cement particles, which results in their rapid coagulation and the formation of a suspended cement particle structure. Hydrated cement particles are gradually coated with an impermeable shell of flaky bentonite particles. The number of adsorbed bentonite particles is proportional to the activity of cement. During hydration, Portland cement particles grow in size, which leads to tension, a break in the integrity of bentonite shells, and the penetration of water to cement particles (i.e., to further hydration of cement and, apparently, the adsorption of a larger amount of bentonite).

The fracture intensity of such a coagulation structure depends on the cement activity. The application of slag Portland cement is likely to retard this process. The coagulation structure begins to fail gradually as a result of the coagulation effect of calcium ions and changes into the structure of a hardening cement stone. The decrease in the strength after the peak at the third day is explained by the decomposition of the coagulation structure (Fig. 2.12). The further increase in strength is completely determined by the hydration of cement stone.


Fig. 2.14 Water-cement-bentonite phase diagram [19]. (Light gray) region of formation of a stable mastic suspension and (dark gray) region of a stable and mobile suspension. (1–4) compressive strength values, kPa: (1) 69, (2) 345, (3) 689, and (4) 1378

The possibility of such a stable structure forming is supported by the conclusions of work [19]. The range of the relative content of bentonite and Portland cement in the binder used for the production of brex (80% Portland cement, 20% bentonite) corresponds to the dark gray region in the water–cement–bentonite phase diagram (Fig. 2.14 [19]).

Note that the local moisture content near coagulated particles exceeds the moisture content of the as-prepared brex substantially (by 11–12%) due to differences in the permeability of minerals. An increase in the fraction of bentonite in the binder up to 30–40% favors the formation of a stable mastic suspension.

The effect revealed in this work can be important for practice: brex based on a cement–bentonite binder can be used as a charge component for a metallurgical furnace within 3 days of drying under natural conditions. As a result, the required sizes of brex storage can be decreased. The threshold level of compressive strength can be easily achieved by a simple increase in the fraction of this combined binder. Note that the total fraction of a binder in the brex produced at Suraj Products Ltd. accounts for at most 5.6% of the brex mass, which is significantly lower than the required content of Portland cement used for vibropressing briquetting (10–12%). The use of bentonite in the binder composition changes the character of fracture of briquettes and makes it viscoplastic, which simplifies the transportation of brex to the site of its application. A quantitative description of the detected effect is the subject of further investigation.

The moisture release during the briquette strength tests on the third day can be related to restructuring in the agglomerates formed in cement during its hydration, which is accompanied by the release of part of chemically fixed water. It is known that, at a sufficiently high content of volume capillary moisture in cement, intense nucleation and growth of acicular aggregates take place on the third day of hardening [20]. It is these aggregates that are responsible for the connection of cement grains and prevent crack development in primary aggregates, and these aggregates were experimentally detected in the cleavages of commercial brex. The experimental investigation was carried out using a high-resolution scanning electron microscopy (SEM) on an Auriga CrossBeam (Carl Zeiss) analytical working station equipped with an INCA X-Max energy dispersive spectrometer. The accelerating voltage was 20 kV. During the hydration of cement, ettringite forms as a result of the reaction between calcium aluminate and sulfate:  $3\text{CaO} \cdot \text{Al}_2\text{O}_3 + 3\text{CaSO}_4 \rightarrow \text{Ettringite}$ .

Using SEM, we were able to reveal the elements of the decomposed coagulation structure. Ettringite particles surrounded by bentonite plates are visible in Fig. 2.15.

The change in the properties of brex induced by the addition of bentonite to the composition of the mixture to be briquetted also manifests itself after the preliminary homogenization of the mixture to be briquetted during its "souring" (storage of the moisturized mixture with added bentonite for within a certain time). This method allows achieving a high degree of homogeneity of mixture properties for subsequent briquetting. In some cases, the mechanical strength of brex made of homogenized charge can significantly increase. Consumption of plasticizer for briquetting the charge without prior homogenization, in this case, can decrease significantly. We studied the effect of souring on the strength of brex of various compositions (Table 2.4). Table 2.5 gives the results of tensile splitting tests of brex 1 week after its manufacture. These results demonstrate that the use of bentonite in combination with Portland cement improves the strength properties of brex. The strength of brex increases substantially in some cases. Furthermore, the manner of their fracture also changes and signs of viscoplastic fracture appear. In this case, brex can better withstand the impact loads that appear during their transportation to the sites of their application.

The results of the study on the effects of shearing stress on the properties of extruded mixture allow using shearing through the shearing plate for the homogenization of the mixture prior to its agglomeration with binder.

To demonstrate the effect of such operations on the homogenization of the mixture, we have compared values of compressive strength on brex composed of manganese ore concentrate with added baghouse dust resulting from silicomanganese production with and without homogenizing the earlier-sheared mixture.

The granulometric composition of brex components is listed in Table 2.6. The composition of brex is given in Table 2.7.

A laboratory extruder has been used for brex sample production. The sheared mix was subjected to the souring over the course of 4 h. Table 2.8 shows the results of the measurement of the compressive strengths of brex No. 1–3 produced from this mix with and without souring. The increase in compressive strength a week after manufacturing was 14.2% for brex No. 1; 7.62% for brex No. 2, and 54.5% for brex No. 3.

Study of the brex structure by means of scanning electronic microscopy revealed differences in the structure and distribution of pores. Figure 2.16 presents the structure of the brex No. 2.


One can see that pore size is significantly smaller in the brex made from a sheared and soured mix. Our results confirm the efficiency of using a shearing extruder in preparing the briquette charge for souring.

# 2.2 Technological Process of Briquetting by Method of Stiff Vacuum Extrusion






Fig. 2.17 Typical layouts of SVE briquetting line

Typical layouts of the SVE briquetting line is shown in Fig. 2.17.

Prepared in the warehouse of the raw material mixture of the main components of the brex mix is being fed by an even feeder (Fig. 2.18), equipped with spirals cast of chrome alloy.

Next, the prepared mixture with added binder and plasticizer is fed for mixing in the pug sealer. The line can also contain primary open pug-mill. The pug sealer consists of a large open part and the sealing node. The open part (Fig. 2.19) consists of a trough and system blades for mixing. The blades are fastened to the steel rod shaft by bolted clamps, making it possible to rotate the blades to adjust the angle at which the processing takes place and, thereby, change the machine's performance.

The pug sealer is combined in a single unit with the extruder and is positioned above it (Fig. 2.20).

The mixture enters the vacuum chamber partially agglomerated (Fig. 2.21) and due to the high vacuum inside the chamber and removal of air and moisture, the pieces of the mixture immediately crumble into isolated particles, which fall down on the blades of the auger. It is known [21] that the air adsorbed by the surface of the particles of plastic material in the form of multi-molecular layers held by van der Waals forces slow the rate at which they wetten, prevents the mass's uniform



#### CONTINUOUS MIXING

compaction, and promotes elastic deformation, which results in lamination and micro-cracks detected during the drying and firing of products. In filling the pores, the air also prevents moisture from penetrating, separates the particles of the mass, and acts as a leaner. The vacuum removes air from the pores and promotes the closer contact of particles.




Fig. 2.22 Vacuum area in extruder and pug sealer

The vacuum is maintained throughout the working volume of the extruder up to the die. The pressure of the vacuum is at least 100 mm Hg (in absolute value). The area of the vacuum in the working chamber of the extruder and pug sealer is shown in Fig. 2.22. The combination of mechanical pressure and vacuum in the working extruder chamber helps to remove almost all compressible air from the material before densifying, which leads the green brex to have high values of compressive strength of and to immediately be transported by conveyors and stockpiled, practically without fines. In addition, as is well known, the vacuum slightly decreases the viscosity of the cement paste, which facilitates its uniform distribution in the briquetting mass and improves its interaction with water [22]. This, combined with a higher density of mass resulting from the removal of air, leads to a decrease in cement binder consumption.

## 2.3 The Movement of the Briquetted Mass in the Extruder




Fig. 2.23 Stages of densifying in the working zone of the extruder. 1—conveying, 2—densifying, 3—metering, 4—pressure distributing, 5—die

Due to rotation of the auger blades in the working chamber of the extruder, formable mass performs translational and rotational motion, which is slowed by the walls (Fig. 2.23).

In the conveying zone, the material is loose and moves along the barrel without densification. Bulk density remains unchanged. Zone 2 is the densifying region where the loose material is compacted. In zone 3, metering is achieved by way of the special geometry of the wings of the point auger. Zone 4 serves the purpose of distributing the pressure generated by the metering zone more evenly over the die, thus tending to yield a more even flow through it.

Bizhanov et al. made a preliminary assessment of the briquetted mass movement in the working chamber of the extruder from the point of view of basic continuum mechanics [23]. The rotating mass of a wet, continuous medium has an isotropic molecular pressure field [2, 24] and is subject to the fundamental laws of conservation of mass, momentum, and energy [25–27] with an appropriate rheology for the coefficient of dynamic viscosity  $\mu$  [28–30].

Contact stresses of matrix P are naturally attributed to the source of liquid strains  $u_r$  for particles of the wet mixture in dynamic equilibrium (Eq. 2.1), which replaces

static equilibrium (Hooke's law) for small displacements in the solid particles of the dry material [33].

The distortion of the velocity field assessed using measurement of liquid deformation [32],

Let us simplify the initial problem. As already noted, in addition to transportation, the main purpose of the extruder is to compact the material in zone 2 (Fig. 2.20). We will limit ourselves to the portion (length) of zones 3 and 4, suggesting constant density of material, approximated by Newtonian rheology:




Fig. 2.24 Profiles of axial (left) and azimuthal (right) component of the considered spiral flow at two subcritical (1 and 2) and one supercritical (3) values of dynamic factor

Considered SVE extruders [30] are operated with the usually moderate values of  $\varepsilon \approx 0.5$  and mostly at the subcritical value of  $0 > \delta < 1 - \varepsilon^2$ , rarely, at the supercritical factor  $\delta > 1 - \varepsilon^2$ , that is illustrated by the dimensionless dependence Z(X) in Fig. 2.24, left.

At the subcritical dynamic factor and the maximum possible speed of material transportation by the auger w(r) is limited by value

$$w_* = \max_{\varepsilon a \le r \le a} w(r) = w_p \max_{\varepsilon \le X \le 1} Z(X) = w(r_*),$$

close to the speed of viscous flow  $w_p$ , achieved within the field of flow:  $\varepsilon a < r_* < a$ . With the growth of the factor  $\delta < 1 - \varepsilon^2$  this value approaches the speed  $w_p$ , shifting simultaneously on the internal radius of the cylinder  $r = \varepsilon a$  and reaches  $w_p$  on the border of flow area, i.e.,  $r_* = \varepsilon a$  at  $\delta = 1 - \varepsilon^2$ , remaining maximum speed of the transported mass  $w_* = w_p$  and at any superficial factor  $\delta \ge 1 - \varepsilon^2$ .

Thus, increasing the speed of displacement  $w_-$  at superficial factor  $\delta$  does not increase the speed of transportation w(r) in the flow area  $\varepsilon a < r - a$ , reaching the maximum value  $w_*$  on the border of this area  $r_* = \varepsilon a$  and equal to the speed of viscous flow  $w_p$ .

The above concepts came from the central assumptions of continuum mechanics about the presence of the molecular pressure p in such materials and produced by its flow  $\mathbf{u}$  liquid deformations  $\mathbf{u_r} = (\nabla \mathbf{u})_*$ , which together generate contact strain  $\vec{\mathbf{p}}$ , balancing the resulting acceleration of the particles in the Navier–Stokes Equations (2.1). The original premise of the mechanics of viscoplastic deformation seems to be the opposite: there is a solid body and the tension applied to its surface is defined as  $\vec{\mathbf{p}}$  (Shear stress), which produce deformation  $\mathbf{u_r}$  (Shear rate) upon reaching of a critical level—the so-called plasticity limit  $\|\vec{\mathbf{p}}\| = const$  (Yield stress). But details of the dependence between tension and deformation are reduced to the above classical formula for  $\vec{\mathbf{p}}$ . The same viscoplastic state of the material is described by the above-mentioned dependence of dynamic viscosity  $\mu = \mu(\gamma)$  on measure of deformations  $\gamma = D[\mathbf{u}]$ , reduced to the constant  $\mu = const$  at the

superficial level of tension in well-known Bingham's model [28], which we also accept here for the flow of the material in extruder [36].

The mass is not only mixed, but also compressed. Therefore, we will consider in the simplified variant that


The received analytical dependences allow one to qualitatively assess the flow of the formable mass in the extruder and can be used for further numerical simulation.

In zone 5, the brex are squeezed out of the holes in the die (Fig. 2.25), which completes the process of their formation.

## 2.4 The Length and the Cross-sectional Shape of Brex

The considerable length of the brex at the die exit is notable. In work [9], we carried out a finite-element simulation of exit of elongated brex from an extruder using the SIMULIA Abaqus software complex [37]. This modeling allowed us to offer a satisfactory description of the mechanism by which an elongated brex breaks into several brex of shorter length. When bending an elongated brex under the force of its own weight, zones of maximum stress and sources of further breakage are formed in its body. Figure 2.26 shows the results of mathematical modeling of the various stages of product breakage, both at the exit from the extruder and upon falling on the supporting surface (floor, conveyor belt, etc.).

In extrusion agglomeration, it is possible to produce brex of practically any shape by means of simply changing the shape of the orifice through which it passes in the die.




Fig. 2.27 Possible stresses on oval brex (left and middle) and circular cross sections, and the distribution of equivalent stresses in the body of the brex

Earlier, we investigated the effects of the shape of the brex on its strength [8]. Our experiment demonstrated that there was a significant difference in the strength between brex from the same batch depending on whether it has round or oval shapes. The strength of oval-shaped brex is dependent on the direction in which pressure is applied to it. When applying a crushing force along the minor axis of the oval, it may take almost twice as much pressure to achieve the same stress levels as it does when applying a pressure along the major axis. It can be assumed that the difference in the values of the strength can be attributed to the difference in the area of contact surface during crushing. For circular cross sections, the contact patch has a smaller area than it does for the oval samples if applied along the minor axis. Thus, when the load is equally distributed along the minor axis, the acting stresses in the oval-shaped brex are smaller than they are in the round shape. It is also clear that when the crushing force is directed along the major axis of the oval, the magnitude of stresses will be correspondingly higher. We performed a finiteelement simulation of a full-scale brex-crushing experiment using the SIMULIA Abaqus software. The objects of our focus were brex of the same area with round and oval shapes. The ratio of the length of the major and minor axes of the oval is 2:1. Finite-element modeling was performed using a linear-elastic material model. As a result of mathematical modeling, we were able to evaluate the distribution of the equivalent von Mises stress over the cross section of the briquettes (Fig. 2.27). If the pressure required to split a round brex was 1, then the relative splitting pressures for an oval brex were 1.33 and 0.67 respectively along the minor and major axes.

## 2.5 Migration of Fines




Fig. 2.28 Brex with a layer of fine fraction on the surface. Left: coal (surface layer) and fine fraction of construction materials. Right: coke brex with epoxy resin as binder

Another feature of SVE is the possibility of extrusion of the fine fraction of the mixture during the production of brex on its surface, as illustrated by photos of brex made from a mixture of carbon-based material and construction fines (Fig. 2.28, left). It is evident that the carbon-based portion of the mixture formed the outer layer of the brex. The image on the right depicts coke brex bound by epoxy resin, the smallest particles of which are pushed out during the process of extrusion.

To understand the process that occurs when a mixture of large and small particles is moved, we proposed a simplified hydrodynamic model to describe the motion of large particles in a liquid. A similar model was developed for separating particles in dust-cleaning systems [38]. When applying the hydrodynamic model, we allowed for a simplification in which the fine phase is replaced by a liquid. In reality, the behavior of a fine solid phase differs from the behavior of a liquid, mainly because the solid phase is difficult to deform and does not flow as easily as a liquid, especially around obstacles. For a complete assessment, it is necessary to take into account the effect of particle shape and a number of other factors. However, for a general understanding of the principles of particle motion and of the forces that affect particles, such a simplification is permissible.


When the molded mass passes through the opening of die, we see a flow profile resembling that of the Poiseuille law on the flow of water through pipes (Fig. 2.29). A characteristic feature of such profiles is a large velocity gradient near the wall and a zero gradient at the center of the tube.

When finite-dimensional particles move in a gradient flow in an ordinary (Newtonian) environment, the resulting lift force is similar to that which acts on the wing of an aircraft. The latter occurs due to the difference in pressure under and above the wing of the aircraft ([26] and Fig. 2.30).

As per Bernoulli's principle, an ideal fluid of zero viscosity maintains pressure equal to the sum of its hydrostatic and dynamic pressures (the so-called Bernoulli integral) along its streamline [26].




Fig. 2.31 a Flow around the particle near the wall extending from the hole; **b** The particle rotated by the flow

Since air moves more slowly beneath the wing, the hydrostatic pressure must be greater to keep the Bernoulli integral (5) constant, with the reverse being true of the environment above the wing. For a particle in a flow with a velocity gradient (Fig. 2.31), an analogous situation arises: the pressure below the particle will be

greater than it is above it. In this case, the particle may be pulled into rotation as a result of the velocity gradient. In this case, we will see a secondary lift force in the form of the Magnus effect, which surrounds a rotating particle (Fig. 2.31b).

As per Joukowski's theorem, lift is determined by the flow density  $\rho$ , circulation of velocity around the particle J, and the velocity of the oncoming flow u (the stream is assumed to have a horizontal velocity of u and a vertical velocity of u = 0) [26]:

The circulation around the particle as it rotates in the flow is given by:

In reality, it is necessary to take into account that the particle is carried by the flow and has a horizontal velocity U (i.e., a relative velocity u–U). Therefore, we ultimately have the following:

As can be seen from formula (2.9), the magnitude of the lift is larger for larger particles. Force also increases as the velocity gradient increases. The latter reaches its maximum value along the wall of a pipe, while amounting to zero at the center of the stream. Therefore, the greatest displacement of large particles toward the center will be observed near the wall, while the smallest particles being displaced toward the wall. As a result, there should be a nonuniform distribution of particles, with the largest ones at the center and the smallest ones near the wall.

When the particles move slowly relative to the "liquid" (in our case, relative to the fine phase), the Stokes' frictional force is observed [26]:

where  $\mu$  is dynamic viscosity (analogous to the friction of a small particle against a large particle), (u-U) horizontal velocity relative to the flow.

Now we can make a qualitative assessment of the relative displacements of large and small particles. We can say that in (2.12) the difference (u-U) characterizes the velocity of small particles relative to large particles. The velocity gradient du/dy is the same for small and large particles. Let us take, for example, the particles "large" and "small", where "large" is three times are large as "small"  $(r_{\text{large}} = 3r_{\text{small}})$ . Since  $V \approx r^2$  and all other factors are equal, the transverse velocities of large and small particles will differ by a factor of nine.

The "minus" sign is necessitated by the multidirectional motion of large and small particles in accordance with formula (2.12). In reality, we can assume that small particles remain in place and large ones are squeezed into the center of the stream.

The velocities of the relative transverse displacement of the particles are proportional to the square of the ratio of the particles' volumes.

The phenomenon of small fraction displacement is explained by the proposed hydrodynamic model using particles of two different sizes.

## 2.6 Transportation, Warehousing, and Storage of Brex




Fig. 2.32 Loading of freshly formed brex onto a dump truck and its subsequent unloading 5 min later

The high density of freshly made (green) brex enables them to be delivered immediately to the storage site by conveyor or loaded onto dump trucks (Fig. 2.32) for transport to the warehouse.

Due to the viscous or plastic reaction of a mass of brex to external mechanical action described in Sect. 3.1.—a reaction attributed to the granulometric composition of the mixture and the presence of bentonite—the brex show a sufficiently high impact strength. In the technological cycle of production of the brex for the smelting of ferromanganese (12.4% of aspiration dust from the production of ferromanganese, 40.8%—manganese containing sludge, 43.4%—screening of manganese pellets, and 3.4% bentonite as a binder) can withstand dropping from a height of 5 m onto the concrete floor of the bunker (Fig. 2.33).

Using the SIMULIA Abaqus software complex, it is possible to simulate the process of unloading oval-shaped brex in order to calculate the statistics surrounding the placement of brex on a pile (Fig. 2.34) [9]. Our results revealed that 56.25% of brex have a "flat" orientation (in which the long axis of an oval lies horizontally), 12.5% are oriented with the long axis perpendicular to the base, 12.5% are on the bottom, and 18.75% on the "edge." Thus, we were able to show that fewer than 13% of the brex in any given stack would lie in the direction in

**Fig. 2.34** Simulation modeling of placement of oval brex on the bed of the furnace




which the crushing force would theoretically be directed along the oval's long axis. We also noted that when an oval shape is formed, the free surface area increases (for brex with a 2:1 axis ratio, the surface area growth amounts to 5.8%), which would positively affect the process of its reduction in the reducing atmosphere.




Fig. 2.35 Models of possible manners in which brex may fall onto a surface

In accordance with Russian standard 2787 (GOST 2787) [40], brex are dropped three times (freefall) from a height of 1.5 m onto a metal or concrete slab to determine their frailness. They should not generate more than 10% (mass) of fines. From every five brex dropped, four must pass the test. To simulate the process of brex breakage under impact loading, we evaluated the fall of brex onto an absolutely rigid flat surface from a height of 1.5 m. The specimens were then assessed from numerous angles: from the lateral surface, the front, and the edge (Fig. 2.35).


The simulation was carried out using the elastic or plastic model for the brex behavior and keeping in mind the possibility of its destruction in the SIMULIA Abagus software [41]. The physico-mechanical parameters of the material were determined by way of experimental data of the brex samples with a composition of 15% chromium ore concentrate, 15% coal, 67% aspiration dust resulting from ferrochrome production, and 3% Portland cement. In the experiment, the following properties of materials were noted using a bench-type single-column electromechanical Instron 3345 (USA) test machine with a loading capacity of 5 kN: a Young's modulus of 123 MPa, a Poisson's ratio of 0.3, and an ultimate strength 2.1 MPa. The results of the simulation are related in Figs. 2.36, 2.37 and 2.38. Results of simulations in which the brex fell from a height of 0.5 m and 2.0 m were also provided for the sake of comparing the damage parameter. The damage parameter is a conventional value characterizing the degree of material damage (0 for intact, 1 for completely destroyed). In the above simulation, regions of irreversible (inelastic) deformation were observed in contract zones in the body of the brex. A fall from a height of 0.5 m resulted in the complete destruction of the edge

of the brex only if it were to fall onto its front. This is due to the small area of contact and a resulting higher degree of mechanical stresses in the model. In the remaining cases, the fall of brex led to an irreversible degradation of its strength in the contact zone without initiating the elements' progressive destruction. At a drop from a height of 1.5 m, the destruction of the brex's thin superficial layers was observed in practically all cases. It is worth noting that when brex falls onto its front (Fig. 2.37), damage (without destruction) is localized at its center. This is explained by the interference of compression-extension waves upon impact. The application of mathematical modeling to assess the destruction of brex under impact loading gives us an idea of the frailness of brex and allows us to predict its strength upon impact.

Figure 2.39 shows the results of sieving portions of brex No. 2 (Table 2.7) after the brex was dropped four times from a height of 1.5 m. The test produces an insignificant amount (less than 2%) of fines of less than 5 mm, as well as a single fragment exceeding 12.5 mm.

In accordance with Russian standard 25471-82 (GOST 25471-82) [42], in order to determine the durability of iron ores, agglomerates, and pellets upon impact, the materials must be subjected to a test of triple falls from a height of 2 m. A test of ore-sludge brex (consisting of 27% iron ore concentrate, 34% sludge, 32% dust, 6% Portland cement, and 1% bentonite) showed that fine formation did not exceed 2.7% after 48 h in the absence of a preliminary homogenization of the moldable mixture. In the presence of a preliminary homogenization, fine formation was at

2.1%. When the material was dropped five times, these values were at 5.6% for non-homogenized brex mixture and 3.7% for homogenized brex mixture (Fig. 2.40). These results were obtained 48 h after the brex were manufacture. It is known that the strengthening of the cement binders bonded briquettes is achieved upon a 16–20 h heat treatment or by means of natural strengthening (at a temperature of no less than 20 °C) for a period of 7 days [43]. An important feature of the SVE method is that, during the first 4 days of hardening, the brex show a viscous-plastic character during tests, which is evidenced by their high impact strength. Furthermore, as mentioned previously in this Chapter, within 48 h, cement-bentonite binder brex achieve a maximal local compressive strength.

One of the shortcomings of SVE that manifests itself in cold conditions is the need to maintain the temperature of the building in which the extrusion equipment is located at least 5 °C. Otherwise, the very extrusion of the wet mass will be difficult if not impossible, and, in the event that the mixture contains Portland cement, the hardening of the brex will slow down or cease entirely.

In order to estimate the temperature in a pile of freshly made brex over a 2-day period of storage, we sought to measure nonstationary heat conduction in the natural convective heat transfer with the environment, taking into account the physical heating of the brex during extrusion and ignoring the heat released during cement hydration.

Our variable was ambient temperature at 0, 5, and 10  $^{\circ}$ C. The initial temperature of the brex at the time of storage is 25  $^{\circ}$ C.

The thermophysical properties used are shown in Table 2.9.

The evaluation of the heat fields in the pile of brex was carried out over the course of 5 days (432,000 s) under unchanged external conditions. In accordance with the technological conditions of the SVE line operation for blast furnace unit, the brex are taken to charge after two days of storage.




Fig. 2.41 Temperature field distribution. Day one is on the left-hand side; day two is on the right-hand side. The room temperature is 0  $^{\circ}$ C

Figure 2.41 shows the temperature distribution in the stack of brex at a room temperature of 0  $^{\circ}$ C after 24 and 48 h of storage.




Fig. 2.42 Temperature field distribution. Day one is on the left-hand side; day two is on the right-hand side. The room temperature is 5  $^{\circ}{\rm C}$

Figure 2.42 shows the temperature distribution in the stack of brex at a room temperature of 5 °C after 24 and 48 h of storage.




Fig. 2.43 Temperature field distribution. Day one is on the left-hand side; day two is on the right-hand side. The room temperature is  $10~^{\circ}\text{C}$

Figure 2.43 shows the temperature distribution in the stack of brex at a room temperature of 10  $^{\circ}$ C after 24 and 48 h of storage.

Starting from a room temperature of 5  $^{\circ}$ C, the physical heat of the brex in the stack helps maintain sufficient temperatures for the hydration of cement. To verify the validity of this conclusion, we tested the durability of brex kept at 5  $^{\circ}$ C in a refrigeration chamber for 48 h by dropping them from a height of 2 m. The composition of this brex was as follows: 62.4% ore-sludge mixture, 30.6% blend of

blast furnace dust and dust resulting from aspiration, 6% Portland cement, and 1% bentonite. The amount of fines (particle less than 5 mm in size) formed after a three drop this the specified brex was 7% after 24 h of preparation at 5 °C, 4.3% after 48 h of preparation at 5 °C, and 4.2% after 72 h of preparation at 5 °C. If the brex are taken for charging into the blast furnace after 48 h of hardening at a room temperature of 5 °C, the strength of the brex is an acceptable level for use as blast furnace briquettes.

At temperatures close to zero, a significant number of brex will cool during the first 48 h to the temperatures at which hydration slows down or ceases entirely.

### 2.7 Conclusions

- 1. Allowing the briquetted material to develop plasticity is one of the most important aspects of preparing it for the production of brex. In many cases, it is sufficient to simply further grind the material. The method of grinding material for briquetting can affect the size, shape, and topography of the particle's surface. The degree to which these traits are affected depends on the features of the material (first and foremost on its porosity). The granulometric composition of briquetted material affects not only its compressive strength, but also determines the degree of damage that the brex will undergo under static and dynamic pressure. Depending on the degree of grinding, the fragility of the brex can be replaced with a viscous-plastic destruction, which will, in turn, increase the brex's resistance to impact.
- 2. Preliminary homogenization of a briquetted batch leads to an increase of its mechanical strength or to a decrease in the amount of binders and plasticizers necessary for its production. It is recommended to use a shearing extruder with a shearing plate to prepare the briquetted batch for homogenization.

- 3. The flow of a briquetted mass in the extruder is complex and not fully understood. The authors of this paper introduced a simplified model to assess the flow of a compressible mass in an extruder to obtain, for very first time, an exact analytic solution of the Navier-Stokes equations. This approach can be used as a template solution for numerical assessment. Practically all of the known results of mathematical modeling are based on the assumption that a medium is incompressible, which, actually, stands in conflict with the results of this study.
- 4. The mechanical strength of the brex is affected by their shape. Oval-shaped brex have a different splitting strength depending on the direction at which force is applied to them. The splitting force along the minor axis of the oval is great. The breakdown processes of elongated brex are well described using the SIMULIA Abagus software, which is based on the finite elements method.
- 5. In a number of cases, the fines can be carried to the surface of the brex upon their productions. The same phenomenon is well noted in brick production through stiff extrusion. The authors proposed a hydrodynamic model to offer a satisfactory explanation of why a fine fractions may be displaced both in brex and brick production.
- 6. An analysis of the process of stacking the brex using SIMULIA Abaqus software allows you to model the distribution the brex by orientation in the stack. Knowledge of such distribution allows us to judge the effect of various crushing loads on the brex (axial compression, splitting during stretching).
- 7. Stiff extrusion agglomeration with the use of cement binder in combination with bentonite, leads to rather high values of impact strength of the brex already at the initial stage of strengthening. The formation of insignificant amounts of fines in brex after three drops from a height of 2 m after 48 h of preparation is due to the viscoplastic nature of their destruction in the first 4 days of strengthening.
- 8. The possibility of a stiff extrusion line operation on a cement binder is dependent on the necessity to keep the temperature in the room where the briquetting line is located at least 5 °C. Our study showed that after 48-hour strengthening of cement-based wet brex manufactured at 5 °C their drop-strength meet the requirements for blast furnace briquettes.

# Chapter 3 Metallurgical Properties of the Brex and Efficiency of Their Use in a Blast Furnace

# 3.1 Behavior of the Experimental Brex Under Heating in a Reducing Atmosphere

The debut of SVE technology in blast furnace applications took place in 1993 at Bethlehem Steel (USA). The briquetting line with a capacity up to 20 tons per hour produced brex consisting of basic oxygen furnace (BOF) dust, blast furnace sludge, and coke plant lime sludge. The binder was Portland cement, lignin was used as an extrusion aid. The line operated successfully for 3 years, but was closed once the Bethlehem Steel Corporation stopped operating.

In 2011 a small steel plant of Suraj Products Ltd. (India) started applying SVE technology in their blast furnace unit, and built a line to produce brex using imported converter sludge, blast furnace dust and high-grade iron ore fines. Three years after brex production had commenced they became the main component of the blast furnace charge. At the same time, Novolipetsk Steel Company (JSC NLMK) began to carry out a design study to examine briquetting of blast furnace sludge, blast furnace dust and iron ore concentrate using SVE technology to produce brex for its further use as a blast furnace charge for all the blast furnaces of the company. This method of recycling dispersed iron-bearing waste was a result of the concept of blast furnace, and converter iron-zinc-bearing sludge recycling by briquetting and melting them in Blast Furnace No. 2 with a volume of 1000 m<sup>3</sup>, using a special technology allowing zinc to be removed from the blast furnace with blast furnace dust [1-5], which had previously been developed and industrially tested. In connection with the construction of a new large Blast Furnace No. 7 and the decommissioning of Blast Furnace No. 2, use of the converter sludge in the furnace charge for brex production was replaced by a concentrate, since it limited the zinc content in brex and allowed brex to be used in all the blast furnaces at the plant. Blast furnace sludge is normally used in sinter burden, but its amount cannot exceed 6–7 kg/ton of sinter due to high levels of zinc content. However, even this amount of sludge in sinter burden degrades the quality of sinter. During sintering, the fine carbon contained in the sludge does not work as a fuel. Consequently, it is proposed that the sludge be withdrawn from the sintering mixture and used as the charge for brex production.

## 3.1.1 Reducibility and the Hot Strength Mechanism of Using Brex for Blast Furnaces

We have investigated the metallurgical properties of the brex made from iron-zinc-containing sludge [6, 7], as well as brex made from iron ore concentrate (Stoilensky mining plant, SGOK, Russia) and coke breeze (Tables 3.1 and 3.2) which are considered as promising components of the BF charge, enabling a partial or complete replacement of sinter [8].

Experimental brex were produced by a laboratory computerized extruder, which is able to provide a complete simulation of SVE technology. The brex had a circular section with a diameter of 25 mm and a length ranging between 1.5–2.0 of their diameter. The moisture content of the freshly formed brex was 12.4% (No. 2) and 11.9% (No. 4). The working chamber of the extruder had a vacuum level of 20.2 mm Hg. (No. 2) and 45.72 mm Hg (No. 4). The temperature of the brex when pushed through a die was 30–31  $^{\circ}$ C.

The compressive strength assessment has been conducted using brex samples with a length of 30 mm. The load was applied along the axis of the samples. The samples were tested before and after the heat treatment in a reducing atmosphere (50% hydrogen + 50% nitrogen) with heating up to 1150 °C at a rate of 500 °C per hour (the temporal temperature gradient is similar to the gradient in a blast furnace shaft), followed by cooling the samples in a nitrogen atmosphere. Five samples of each type were used for the assessment. It was noted that all heat-treated samples kept their shape and dimensions. Despite the significant difference in the component and chemical composition of the two types of brex, i.e., the sludge brex and the brex from concentrate and coke breeze, their strength before heat treatment was practically the same, respectively: 89.4–166.3 kgF/cm<sup>2</sup> (in a sample of 5 brex an average is 119.3 kgF/cm<sup>2</sup>) and 103.8–124.7 kgF/cm<sup>2</sup> (in a sample of 5 brex an average is 111.4 kgF/cm<sup>2</sup>). After heat treatment in a reducing atmosphere, the strength of the brex decreased, respectively, by 8.2% and by 14.5%. Due to the excess carbon content in brex No. 2 and brex No. 4 and the same reduction mode (the two types of brex were processed simultaneously in the same furnace), the degree of brex metallization ( $\eta_{met}$ ) achieved is also practically the same (Table 3.3). At the same time, the atomic ratio of residual carbon content to residual oxygen content (C/O) in metallized brex No. 2 and brex No. 4 is 3.5 and 3.9, respectively. In relation to carbon demand for direct reduction of iron oxides, such atomic ratios indicate excessive amounts of carbon found in the brex in the present study.

However, considering the amount of carbon needed for both direct reduction, and for carburizing iron brex into iron carbide, the excess amount of carbon in brex No. 2 is 2.3%, while brex No. 4 lacks 1.15% to carbonize iron to carbide (when calculating the composition of metallized brex). Thus, the carbon content in the iron ore and the coke-breeze brex appear optimal to meet the carbon demand for direct reduction and its further carburization.

The reducibility study has been performed in accordance with Russian standards —GOST 28657-90 [9] and GOST 21707-76 [10]. The higher rate and higher degree of reduction in iron ore-concentrate-based brex results from the increased oxygen level of iron oxides in this brex (24.6%) compared to the sludge brex (18.1%). Thus, it is possible to conclude that these two types of brex have practically the same reducibility during the process of reduction by gas (with a temperature of up to 900–950 °C, when carbon does not yet take an active part in the reduction process).

These findings allow us to draw an essential conclusion about the desired carbon content in both ore-coke brex and sludge brex ( $C_{\rm br}$ ). From the point of view of the participation of carbon in the reduction of iron oxides and considering the average degree of direct reduction of iron from partially reduced wustite ( $r_{\rm d}$ ) which is equal to 0.4 for the blast furnaces with high rates of fuel injection [11, 12], this content should correspond to a stoichiometric atomic ratio of C/O = 0.3-0.5. With this in mind, and taking into account the presence of metallic iron in brex, the carbon content required for the reduction of the partially reduced wustite ( $C_{\rm brex1}$ ) should be equal to:

However, considering that the carbon contained in brex is required not only for reduction of iron from residual wustite, but also for carburization of gas-reduced and carbon-reduced iron, it is proposed the amount of carbon in brex which is sufficient to meet the increased demand for both processes of iron reduction and iron carburization be determined. The carbon content required for carburizing iron to carbide equals  $C_{brex2} = 0.0716\%$  Fe<sub>t</sub>. Thus, the total carbon content in brex ( $\Sigma C_{brex}$ ) that meets the requirements in carbon for the reduction of iron from wustite, for the carburization of iron, and for the formation of cast iron, is:

In comparison with the amount calculated by using the above formula, an excessively high carbon content of coke breeze or coal particles can remain in blast furnace slag. As a result, it can increase slag viscosity and have a negative impact on furnace performance, as mentioned by Bolshakova and Kurunov [13].

Sludge brex and concentrate brex were tested to determine their hot strength properties in accordance with the ISO 4696. The test showed a great advantage of the concentrate brex (RDI<sub>+6.3</sub> is 96.5%) over the sludge brex (RDI<sub>+6.3</sub> is 61.8%). These results can be explained by the fact that the concentrate brex contains no hematite, while the sludge brex contains secondary hematite. The presence of secondary hematite in the sludge brex is found in the particles of both blast furnace and converter sludge. The crystal lattice of the hematite rearranges under low temperature and slow reduction, which creates mechanical stresses and disintegration of a hematite-containing material.

For the purposes of a comparative analysis, the hot strength levels of sinters with a basicity (B4) of 1.2, 1.4, and 1.6 produced from a conventional burden used at the NLMK, were simultaneously measured using the same standard. The hot strength level of sludge brex is comparable to that of a sinter with a basicity of 1.2 and 1.4 (64 and 60%), which can be explained by the similar secondary hematite presence in both materials. The hot strength level of a sinter with a basicity of 1.6 (77%) is higher than the hot strength of sludge brex due to the fact that at a basicity of 1.6 or more, sinters enter a new phase by forming calcium ferrite, which strengthens the sinter structure and reduces its disintegration at low-temperature reduction. At the same time, the hot strength level of concentrate and coke-breeze brex significantly outperforms the corresponding characteristics of all tested sinters. This fact is one of the reasons why this brex should be considered as the main component of a blast furnace burden.




Fig. 3.1 Microstructure of the raw brex No. 4; reflective light;  $100 \times \text{magnification}$

The samples of raw and reduced brex were petrographically analyzed on polished sections in reflected light using a Leica DM ILM laboratory microscope with high-resolution optics HC, manufactured by Leica Microsystems. The analysis showed that the structure of the raw brex No. 4 is represented by grains of magnetite, quartz, and coke fines bonded by cement stone—the basis of the strength of raw brex (Fig. 3.1).




Fig. 3.2 Microstructure of the reduced brex No. 4; reflected light;  $100 \times magnification$

The microstructure of the sample of the reduced brex No. 4 (Fig. 3.2) is represented by a number of metallic iron grains sintered with the partially crystallized glass-phase of the iron-olivine composition, and also includes unreacted coke breeze. The strength carrier in the partially reduced brex No. 4 is not only the iron-silicate phase, but also a metallic iron matrix created by sintering metal grains on the surface of the brex.






Fig. 3.3 Microstructure of raw sludge brex. Reflected light;  $100 \times \text{magnification}$  (left);  $200 \times \text{magnification}$  (right)

In addition to particles of sinter, coke, pellets, and slag, the raw sludge brex No. 2 contains ball-shaped metallic beads that are found separately in the cement stone alongside the above-mentioned particles of blast furnace and converter sludge (Fig. 3.3).


The composition of the reduced brex No. 2 consists of random fine grains of metallic iron, wustite; coke and a silicate phase (see Fig. 3.4). A prominent metal frame, which is observed in the reduced concentrate brex, is absent in the surface layer of the sludge brex. This happens due to lower iron content in the sludge brex, compared to the concentrate brex, and due to a higher content of dispersed coke breeze (Table 3.3).

The silicate phase is the strength carrier of this type of brex, which is similar to brex No. 4. Based on this fact it becomes clear that the formation of a matrix from the iron–silicate phase helps maintain the integrity of the sludge brex when heated in a reducing atmosphere. The integrity in the brex from iron ore concentrate and coke breeze, which has a higher iron concentration, is due to the iron–silicate matrix as well as due to the formation of the metallic iron surface frame formed in the process of gas reduction. The core of the iron ore concentrate brex contains only scattered grains of metallic iron.

For the purpose of a comparative analysis, we studied the metallurgical properties of ore coke brex extruded from hematite iron ore (iron ore—79%, coke breeze —15%, Portland cement—5.55%, bentonite—0.45%). The particles of this high-grade iron ore (Fe<sub>total</sub>—67.5%; SiO<sub>2</sub>—1.5%; A1<sub>2</sub>O<sub>3</sub>—0.3%; CaO—0.2%; MgO—0.3%; S—0.05%; P<sub>2</sub>O<sub>5</sub>—0.05%) have a plate-like structure. When used in sinter production, this iron ore shows poor pelletizing ability due to its structure and may downgrade the quality of sinter. However, this very quality of the iron ore does not adversely affect the quality of the brex extruded from it.

As shown in mineralogical studies the major mass of ore minerals is represented by hematite (Fe<sub>2</sub>O<sub>3</sub>), less often by intergrowths of hematite and magnetite (Fe<sub>3</sub>O<sub>4</sub>). Silicates are most often found in intergrowths with iron-containing minerals. Figure 3.5 shows the microstructure of the raw brex, the component composition of which is described above.

In order to assess the progress of the iron ore coke brex reduction process, polished sections of brex samples were analyzed after being heated to temperatures of 900, 1100, and 1200 °C in a reducing atmosphere.




Fig. 3.7 Formation of the metal framework in place of large grains of iron ore hematite (1) on the periphery of brex (temp = 900 °C); reflected light; 200 × magnification

In its center the brex, reduced by heating to a temperature of 900 °C, the iron-containing phase is mainly represented by wustite and magnetite (Fig. 3.6), while in the peripheral part of the brex one can see interconnected metallic iron particles with small silicate inclusions (see Fig. 3.7).





Fig. 3.8 Microstructure of the periphery of the reduced brex at 1100 °C; reflected light; White areas—metal; gray areas—reduced mineral phases of the cement binder; 200 × magnification

In the peripheral part of the brex sample, heated to 1100 °C, iron oxides get completely reduced to metal, and one can clearly see a metal frame that has formed (Fig. 3.8).

Further heating of brex to a temperature of 1200 °C completes the process of iron reduction to its full extent. The bulk of iron from the central part of brex is metal and only partially is it wustite. Traces of inclusions of unreacted coke breeze particles (Fig. 3.9) indicate its excess in the charge used for brex production even

from high-grade ore (67.5% Fe). The carbon content in this brex was 12.9% with an iron content of 53.3%. Taking into account a chemical composition of the brex such as this, according to the stoichiometric equation given above (3.2) the optimal carbon content in it is 8.5–9.5%.

Thus, with the temperature increasing over 900–1000 °C, the coke breeze carbon has a dominant role in the process of iron oxide brex reduction; at the same time, a framework of metallic iron, reduced from oxides by gas, is formed in the peripheral part of the brex. These findings lead to a conclusion that the brex made from anthropogenic materials with low iron content, requires the addition of a natural or anthropogenic component with high iron content. The presence of coke breeze particles in the brex heated in a reducing atmosphere to 1200 °C supports the conclusion that it is necessary to maintain a carbon content in brex in accordance with its stoichiometry in respect of the iron content in the brex.

# 3.1.2 Metallurgical Properties of Brex Made of Mill Scale and Blast Furnace Sludge

Due to its high iron content, mill scale is the most valuable kind of anthropogenic raw material, which is being recycled at the integrated steel mills with sinter plants by using it in the sintering charge. It is only the oily mill scale that is difficult to recycle. Generally, the oily mill scale is limed and also used in sintering. There are emerging mill scale de-oiling technologies, or technologies in which scale is used as a component of liquid fuel blown into blast furnaces [14] that have no industrial application yet. At the same time, steel mills with no sintering plant face a problem when recycling even oil-free mill scale. The best solution to this problem is to sell scale to third-party consumers. However, one way or another, mill scale can be an effective component of the charge for briquetting in accordance with industrial briquetting technologies, including stiff vacuum extrusion technology. Being sufficiently strong mill scale briquettes can be transported and used as a component of the blast furnace charge; composite briquettes made from scale and coke breeze could be used in electric arc furnaces [15].

Metallurgical properties of the mill scale brex for the blast furnace charge were evaluated with a focus on the mechanical strength and reducibility. Using a laboratory extruder all test brex samples were produced from a mixture of a mill scale (MS) and blast furnace sludge (BFS), with 6% Portland cement (PC) as a binder and 1% bentonite (B) as a plasticizer. The chemical composition of the brex differs primarily in the content of carbon, iron, and oxygen levels ( $\Sigma O_2$ ) of iron oxides (see Table 3.4).

We have tested the reducibility of this brex by continuous weighing the samples in a tube furnace in a stream of hydrogen at a temperature of 800 °C. This test showed similar results to those obtained in determining the reducibility of the brex based on a mixture of converter and blast furnace sludge and the brex from iron ore




Fig. 3.10 Reducibility of mill scale and sludge brex

concentrate and coke breeze (Table 3.3 and Fig. 3.1). The reduction rate of the samples of 4 types of brex is directly proportional to the iron and oxygen content of iron oxides in these samples (Table 3.5). Figure 3.10 shows the dynamics of the reduction in the tested brex samples.

The reducibility of the brex from a mixture of mill scale and blast furnace sludge differs significantly due to the different degrees of reducibility of its components. The iron oxides of the blast furnace sludge are mainly found in the sinter particles with a lower degree of reducibility than in mill scale iron oxides.

The near-linear character of the deceleration of brex reduction can be explained by the diffusion-kinetic mode of brex reduction [16], which has a sufficiently high specific volume of pores despite their small diameter. The high carbon concentration in the brex with an increased content of blast furnace sludge at a temperature of  $800~^{\circ}\text{C}$  did not affect the results of the reducibility assessment of the hydrogen-reduced brex, when there was no carbon dioxide (CO<sub>2</sub>) in the gas phase and the gasification of carbon present in the brex did not occur. According to the Eq. 3.2 mentioned above, it is clear that brex B3 and B4 had excessive carbon levels, which prevents their use in a blast furnace for reducing oxides of iron, and for carburizing iron within the brex.

These findings enable us to conclude that it appears more efficient to briquette blast furnace sludge in a mixture with a richer iron content and hardly reduced iron-containing components, e.g., in a mixture with a magnetite concentrate. It will contribute to a more effective use of the carbon contained in brex, i.e., the use of carbon in direct reduction and in the carburization of iron, which, as a result, reduces coke consumption in the process.

## 3.2 Metallurgical Properties of Industrial Brex for Blast Furnaces


In April 2011 the industrial brex making line was commissioned at the metallurgical plant belonging to Suraj Products Ltd (Rourkela, India). The line produces brex for use in small-scale blast furnaces. The main components of the brex are LD (Linz-Donau) sludge, flue dust, iron ore fines, Portland cement, and bentonite (Table 3.6).

The company's decision was based on the results of the study of the metallurgical properties of brex [17–25] and on the results of the computer simulation of blast furnace smelting performed in a small-scale blast furnace with briquettes in the charge. The main objective of the project was to increase the economic efficiency of blast furnace performance by replacing the purchase of iron ore with cheap brex made of a blast furnace dust and sludge from steelmaking. The layout of Suraj Products Ltd stiff extrusion line is shown in Fig. 3.11.

Green brex are transported by a conveyor belt to a stacking system and unloaded in a pile where they are stored for 2–3 days under natural conditions, and then transported to a blast furnace unit or to outdoor warehouse storage. Due to the high extrusion pressure and vacuumizing in an extruder, the freshly formed brex has a dense structure, high plasticity, and sufficient mechanical strength, which enables the brex to be transported, and stored without disintegration, and the generation of fines. The productivity of the brex making line is 200 t/day with a two-shift operation. In addition to conventional brex used as the main component of a

small-scale blast furnace with a working volume of 45 m<sup>3</sup>, the brex production unit produces brex from manganese ore fines, which are used to reduce slag viscosity and to improve the drainage capacity of the coke bed.

Before the metallurgical plant started producing brex, its blast furnace unit operated on a charge of 100% rich hematite ore using limestone and dolomite as fluxes.

The study of the physical and mechanical properties of the industrial brex with the composition described above (Table 3.6) has been done in order to comply with all the requirements for charge materials used in blast furnace smelting. These properties of the brex include mechanical strength and porosity, which determine the integrity of the brex during handling and descending in the furnace shaft and their further reduction. The compressive strength of brex has been tested on the Tonipact 3000 equipment (Germany) in accordance with the standard DIN 51067. The apparent porosity has been measured in accordance with the standard DIN 51056 by using the vacuum method of liquid saturation.




Fig. 3.12 Distribution of pores larger than 5 μm in brex volume

To examine pore volume distribution in brex we used Phoenix V|tome|X S 240, an X-ray microtomography system equipped with a 240 kV/320 W micro-focus tube and an 180 kV/15 W high-power nanofocusing tube. Datos|x reconstruction software was used for the primary data processing and for 3D (voxel) model creation from the X-ray images (projections) of the test samples. VG Studio MAX 2.1 and Avizo Fire 7.1 software were used to visualize and analyze the data on elements of the 3D image. The findings from the study showed a uniform pore volume distribution in brex (see Fig. 3.12).

The change in the structure and composition of industrial brex heated to  $1500\,^{\circ}\mathrm{C}$  in a CO atmosphere has been studied in comparison with the change in the structure and composition of the rich hematite iron ore. The samples of both materials were heated in a reducing atmosphere simultaneously. When a temperature of 1000, 1100, 1200, 1300, 1400, and  $1500\,^{\circ}\mathrm{C}$  was reached the samples were drawn to determine the reduction and the degree of metallization in the ore and brex. The duration of each test was  $2\,^{\circ}\mathrm{h}$ . The chemical composition of the samples of iron ore and brex is given in Table 3.7.

An X-ray diffractometer ARL 9900 XRF was used to identify the phase composition of brex charge components, which includes:

- Iron ore—hematite, goethite, gibbsite, pyroxene, kaolin;
- blast furnace dust—magnetite, hematite, wustite, graphite, quartz, dicalcium ferrite;
- LD sludge—magnetite, wustite, wollastonite, calcite.

The reduction rate of the samples was determined by measuring the weight loss in the sample during the reduction process and by the initial oxygen content of iron oxides in the samples.



The degree of metallization in iron ore samples and brex samples was measured by the ratio of the metallic iron content to the total iron content. At all temperatures, the reducibility and metallization of the brex samples exceeded the reducibility and the degree of metallization of the iron ore (Table 3.8). The higher reducibility of the brex during the reduction at a temperature ranging from 500 to 1000 °C can be explained by the higher porosity of the brex (33.7% at 500 °C and 37.4% at 1000 °C) in comparison with the porosity of the ore (19.4 and 29.2%, respectively). Moreover, at temperatures above 1000 °C, the higher rate of oxygen removal from the iron oxides in brex is due to the carbon presence in the brex. The carbon is actively involved in the process of reduction of iron oxides at the above-mentioned temperatures [26].

The reduced samples of industrial brex were analyzed petrographically by using a Leica DM ILM laboratory inverted microscope with high-resolution optics HC produced by Leica Microsystems (Germany). In addition, the samples were studied using scanning electron microscopy methods using an ECLIPSE LV100-POL polarized microscope equipped with a DS-5M-L1 digital photomicrography system.


The structure of the brex sample that was reduced at 1400 °C (Figs. 3.13 and 3.14) is represented by the metallic iron grid with the micro zones in the wustite. The metal is released from the glass phase, which has been recrystallized to silicates. Continuous fields of metal and differently colored glass phases are observed.

Thus, the integrity of industrial brex heated in a reducing atmosphere after the loss of cement stone strength is achieved by the formation of a surface metal frame during the reduction of iron oxides by a gaseous reducing agent. In addition, the formation of an iron–silicate matrix, with iron reduced by coke breeze carbon at temperatures above 1100 °C, contributes to the integrity of the brex.

## 3.3 Blast Furnace Operation with 100% Brex Charge

The small-scale blast furnace (volume 45 m³) at Suraj Products Ltd is equipped with a skip hoist with a volume of 0.5 m³, a double-cone charging device, and hydraulic equipment for notch servicing, recuperative stoves and a two-stage dry gas-cleaning system (dust collector + the seven modules of the bag house filters) and sludge granulation equipment. The furnace has external watering and eight air tuyeres. The hot metal (foundry and pig iron) is immediately casted by the casting machine. The daily production pf the blast furnace is 100–130 tons of pig iron.

The extrusion line of the blast furnace unit began operating in May 2011, using 10% of brex in the blast furnace charge. Gradually, the brex content of the charge increased to 80%. From the end of 2013, the blast furnace has been operating using 100% brex charge. Table 3.9 presents the main furnace operating parameters with brex in the charge at Suraj Products Ltd.

The data shows that when working on the charge made up of 80% brex and 20% iron ore coke consumption decreased by 150 kg per ton of hot metal (22%) compared with operation on 100% iron ore. The decrease in coke consumption was due to the carbon contained in brex and its involvement in the iron reduction process, as well as to the removal of limestone and dolomite from the charge. The productivity of the blast furnace that used 80% of brex in the charge decreased mainly due to a 7.2% decrease in iron content in this charge compared with the charge based on iron ore and raw fluxes. The transition to a mono-charge blast furnace operation resulted in a further decrease in coke consumption due to the additional carbon input. The increase in the blast temperature by 100 °C also contributed to the decrease in coke consumption. In addition, the use of "washing" brex from manganese ore reduced the sludge viscosity and improved the processing of smelting products. As a result, it contributed to the blast furnace performance gain along with the improvement in the structure of the stock column and the increase in the overall pressure drop. The decrease in coke consumption was also a result of specific heat loss reduction.

The development of new of blast furnace smelting technology with the use of brex meant switching to a decreased stock level of blast furnace charge due to the difficulties in the operation of dry gas-cleaning system. The gradual increase in the share of brex in the charge led to a significant increase in the moisture content of the furnace top gas due to the added hydrated moisture resulted from the brex in the blast furnace and due to a drop in the temperature of the top gas below the dew point. The moisture condensation on the bag filters caused them to become clogged with finely dispersed top dust. As a result, the filters could not be regenerated by inverse pressure pulses. Lowering the burden level enabled an increase in the temperature of the top gas and stopped the bag filters from sealing. This change in burden level had no significant effect on the blast furnace performance due to the fact that the lower iron oxide (FeO) in brex gets reduced directly by the carbon from brex coke; meanwhile, the high reduction potential of the hearth gas and its temperature allows for a fast reduction of iron oxides to wustite.

Despite high specific heat losses due to the small volume of the blast furnace and low blast temperatures, the blast furnace coke consumption does not exceed 500 kg/ton when using the charge with brex. Similar results are obtained by modern high-efficiency blast furnaces that use a charge containing 58-59% of iron, and have a blast temperature of  $1200\,^{\circ}\text{C}$  with an excessive top gas pressure of  $180-250\,\text{kPa}$ . This is achieved by the self-reducing nature of brex which contains carbon from furnace flue dust. Finely dispersed coke particles in brex are in close contact with dispersed particles from steelmaking sludge and iron ores, which provides a direct reduction of iron oxides without the participation of coke carbon. In addition, due to the high basicity of LD sludge and cement, the resulting high basicity of brex (B2=1.76, B4=1.48) requires no raw limestone and dolomite to obtain a specified basicity of blast furnace slag. To adjust the slag basicity and to optimize the

content of magnesia in the slag, it is necessary to modify blast furnace charge by adding small quantities of quartzite and dolomite. As a result, using the 100% brex charge reduced the coke consumption for iron smelting by almost 200 kg/ton compared to the blast furnace operation with 100% rich iron ore, with limestone and dolomite.

The results obtained during over 6 years of the industrial brex making line operation support the fact that the brex made from natural and anthropogenic dispersed raw materials has a controlled and optimum size, a controlled chemical composition, high metallurgical properties, which makes the brex a fundamentally new component of blast furnace charge. Unlike sinter and pellets production, brex production is environmentally friendly and completely waste free, with no gaseous or solid emissions. There are practically no fines left after loading and unloading brex into the blast furnace (see Fig. 3.15). When using a single-component charge consisting of 100% brex the small-scale blast furnace demonstrates uniquely low coke consumption (490–500 kg/t) at a blast temperature of 1000 °C and with an iron content of 45.5% in the fluxed charge.

## 3.4 Assessment of Potential Usage of Brex Made of Iron Ore Concentrate with Carbon Addition in Blast Furnaces

Preliminary qualitative assessments of the possibility and efficiency of brex used on a large scale as a new component of blast furnace charge were based on both the research conducted into the metallurgical properties of brex from various components, and on the unique experience of using a single-component brex charge in a small-scale blast furnace. This assessment was completed by using the numerical simulation of a blast furnace process, based on the DOMNA computer program developed by I.F. Kurunov, S.B. Yaschenko and L.A. Fursova in National University of Science and Technology MISiS (Moscow, Russia) [27]. The process of blast furnace smelting was simulated in a furnace with a volume of 4297 m<sup>3</sup>, operating at Novolipetsk Steel, NLMK. The process of blast furnace smelting using a charge from three components, i.e., sinter, pellets and brex were modeled with respect to the brex basicity, the level of which depends on the proportions of cement and bentonite used as a binder and plasticizer. The pellet content is determined by the capacity of the Stoilensky GOK pelletizing plant built by NLMK (6 million tons of pellets per year). The basicity of the brex made of iron ore concentrate and caking coal depends on the content of cement (6%) and bentonite (1%) in the brex charge mixture, the content that was determined by experiments on brex from this charge mixture, and by the coal content in the charge mixture. The basicity of the brex (B2) with the above-mentioned cement and bentonite contents is 0.50-0.55. The basicity of sinter is determined in accordance with an accepted approach of replacing sinter with brex and brex basicity. When replacing 50% of sinter by brex in the blast furnace mixture, the basicity of the sinter must be within a range of 2.8–3.2. It should be noted that with this basicity, calcium ferrites predominate in the structure of the sinter, and increase sinter strength in comparison with the basicity of 1.5–1.7 in the sinter produced at NLMK [12].

Rated sinter compositions with the basicity of 1.70 and 3.02, brex from the SGOK concentrate and caking coal with two different carbon contents (see Table 3.10) were used to simulate different variants of blast furnace operation. The carbon content in brex B1 is determined by the Eq. (3.1), i.e., it corresponds to the need for a carbon reducing agent with a degree of direct reduction that is equal to 40%, and corresponds to the degree of direct reduction of 30–50%, which is observed in the intensively operated blast furnaces of Novolipetsk Steel with a high consumption of injected natural gas [12, 28, 29].

The carbon content in brex B2 is determined by the correlation (3.2), and corresponds to the total need for carbon for the process of iron reduction from wustite, and for the carburization of iron, i.e., for cast iron production from the iron contained in brex.

The simulation was carried out for the same composition of hot metal and its temperature ([Si] = 0.4%; [C] = 4.8%;  $T_{iron}$  = 1500 °C) and for the same reduction efficiency (the degree of approximation to the equilibrium composition of the gas in

the wustite reduction zone). The results of the experiment showed that at a brex consumption rate of 557 kg per ton of hot metal, each 1% of carbon in brex [carbon content is calculated by the dependencies (3.1) and (3.2)], reduces coke consumption by 6.7 kg/ton. The blast furnace that uses B1 brex and 125 m³ of natural gas per ton of hot metal consume less coke, the amount of which decreases from 391–354 kg/t in comparison with the basic variant. When pulverized coal is injected in an amount of 160 kg/t and 35 m³/t of natural gas is used, brex B1 reduces coke consumption to 284 kg/t (see Table 3.11).

#### 3.5 Conclusions

- 1. The cement-bentonite binder in iron ore and sludge brex provides sufficient mechanical strength, which simplifies the transportation of green brex using a conveyor belt to a stacking system without disintegration or fines generation. After 48 h of strengthening brex is strong enough to be loaded into wagons for further transportation to a blast furnace unit and to be loaded into the furnaces bins without forming fines as well. The viscous-plastic character of brex destruction is maintained during compression tests performed in the course of 4 days of strengthening.
- 2. The level of hot and cold strength of the types of brex that were investigated meets the requirements for the components of a blast furnace charge. The hot strength of brex from anthropogenic raw materials is comparable to the hot strength of fluxed sinter. The hot strength of brex from magnetite concentrate and coke breeze is much higher than the hot strength of fluxed sinter.
- 3. The formation of an iron–silicate matrix helps maintain the integrity of sludge brex when heated in a reducing atmosphere to 1150 °C. In the brex from iron ore concentrate and coke breeze in addition to the iron–silicate matrix formation a metallic iron surface frame is also formed in the process of reduction.
- 4. Effective use of carbon which is contained in brex requires carbon levels to be below or equal to the amount determined by the stoichiometric dependence of carbon content in brex on the iron content within brex: C<sub>br</sub> = (0.086...0.1076) (Fe<sub>t</sub> Fe<sub>met</sub>) + 0.0716Fe<sub>t</sub>.
- 5. The reducibility of brex from a mixture of mill scale and blast furnace sludge in the hydrogen atmosphere depends on the share of blast furnace sludge, decreasing as its increases.
- 6. Industrial brex from blast furnace dust, converter sludge, and iron ore fines with a cement-bentonite binder have a sufficiently high and evenly distributed porosity, which provides for their high reducibility.
- 7. Many years of successful operation of a small blast furnace with the charge of 100% of the brex made from a mixture of natural and anthropogenic raw materials with a blast temperature of 1000 °C and with the coke consumption

smaller than 500 kg/t enables a conclusion to be made that brex are a new effective component in the BF charge and can be considered as a partial, or complete alternative to sinter.

8. The results of the numerical simulation of blast furnace smelting using brex from iron ore concentrate and caking coal with a brex carbon content of 9.5% showed a high efficiency of partial (by 50%) replacement of a sinter production which can lead to reduction of coke consumption by 15% and to a 50% reduction of gaseous and dust emissions during sinter production.

# Chapter 4 Metallurgical Properties of Brex and the Efficiency of Their Use in Ferroalloys Production

Significant volumes of finely-dispersed, effectively-recyclable materials are created in the process of extraction and beneficiation of raw materials for ferroalloy production during their transportation to ferroalloy plants and ferroalloy smelting.

In particular, large reserves of manganese ore with below commercial grade manganese content have been stored at mining and processing plants. When additionally ground, this material becomes easy to process by magnetic and gravitational beneficiating methods, with the possibility of achieving a manganese content of 35–40% Mn in the concentrate.

One of the most common types of anthropogenic raw materials resulting from ferroalloy production are dust and sludge, obtained in gas cleaning of ferroalloy furnaces. Dust emissions from ferroalloy furnaces occur at a rate 8–30 kg/t of ferroalloys. The manganese oxides content of dust formed in the production of silicomanganese and ferromanganese are 21.0–34.3% and 30–35% respectively. The chromium oxide content of dust formed in the production of ferrochrome is 22–30% [1]. The use of finely-dispersed raw materials without their agglomeration in submerged electric arc furnaces (SEAF) disrupts the normal course of the process leading to increased dust generation, reduced productivity and metal extraction rate, increased risks of accidents and hot-idle hours, and as a result, an overall decrease in the technical and economic performance of the furnace.

Sintering is a traditional method of agglomerating such finely-dispersed materials. Ferroalloy factories did not have sintering plants until 1973 [2]. The first sintering plant was opened at Nikopol Ferroalloy Plant in 1973 (Ukraine). In 1979, a sintering plant was commissioned at the Zestafoni Ferroalloy Plant. The average productivity of sinter machines is 100 t/h (specific—1.2 t/m² per hour).

Another industrial method of agglomeration is pellet calcination at a temperature of 1150–1220 °C. Pellet strengthening is ensured by the formed liquid phase. At the "Kashima" plant (Japan), for high-carbon ferromanganese smelting in SEAF with a capacity of 40 MVA, manganese concentrates are agglomerated in a 110 t/h capacity pelletizer and then calcined in a 75 m long rotary kiln with a diameter of 3.5 m [3].

The industrial application of roll briquettes for the agglomeration of anthropogenic and natural raw ferroalloy industry materials was described in Chap. 1.

The first successfully implemented project with the use of SVE technology in the ferroalloy industry was the production of brex and their use in the charge for ferronickel smelting at BHP Billiton in Cerro Matoso (Montelibano, Colombia [4] in the framework of the RKEF (rotary kiln—electric furnace) process [5]. The nickel content in this ore is usually small and ranges from 0.8 to 3.0%. During the RKEF process, laterite ores are sieved, ground and added into a charge with a certain iron, nickel, SiO<sub>2</sub> and MgO content. After that, the charge material is roasted and partially metallized with coal or coke fines. This semi-product and residual coke are then delivered to the electric furnace where ferronickel is smelted. In Cerro Matoso, the RKEF process entails the use of briquetted fines of nickel laterite ore.

Initially, the plant, which has been in operation since 1992, used pelletization and roll briquetting to agglomerate fines of nickel laterite ore and dust procured through the gas cleaning of electric furnaces. In 1996, after a number of comparative tests of various agglomeration and processing methods for these materials (pelletizing, agglomeration, plasma furnaces and SVE), the final choice was made in favor of SVE technology. This technology allowed for an agglomerated product with a cold and hot strength sufficient to maintain brex integrity when roasted in tube kilns (1150 °C) and thermal stability when smelted in electric furnaces. Moreover, SVE allowed for high productivity while maintaining minimal production cost. BHP Billiton Ltd commissioned three Steele 90 Series extruders to produce 700,000 tons of brex per year from laterite nickel ore fines and gas cleaning dusts for the further metallization of brex in rotary tube kilns and then for its use as a component of the charge for ferronickel smelting in electric furnaces. When using the SVE technology for sintering laterite nickel ore fines and dust, it becomes possible to obtain strong brex without the use of a binder. The production of nickel from ferronickel by BHP Billiton in Cerro Matoso is 50,000 tons per year, including 10,000 tons attributed to brex. The nickel content in commercial materials is 35% [6]. The successful results of this industrial use of the SVE technology attracted the attention of VALE, one of the largest mining companies in the world. This Onca Puma-based company (Brazil) has commissioned three extrusion lines for agglomeration of laterite nickel ore fines, with an annual brex production of 700,000 tons.

SVE technology had not been used previously to agglomerate manganese and chromium ores. In 2010, we were the first to attempt to use SVE technology for such purposes. We planned to conduct a full-scale pilot testing of this technology using brex in the charge of industrial SEAF. The rationale for the pilot study was to select the optimal method for using manganese ore fine and for recycling dry gas cleaning manganese-containing dust generated during the production of silicomanganese. The possibility of applying the SVE method to the production of ore brex and ore and dust brex has been studied.

## 4.1 Brex from Manganese Ore Concentrate

Brex from primary oxidized manganese ore concentrate produced at the Zhairem mining plant (Kazakhstan Republic) was tested for the purpose of this study. The brex was manufactured on the industrial SVE line. Portland cement (5% of weight) was used as a binder; bentonite (1% of weight) was used as a plasticizer. The appearance of the brex at the exit of the die is shown in Fig. 4.1.

Table 4.1 shows the chemical composition of the primary oxidized manganese concentrate of Zhairem mining plant.

The share of particles larger than 0.071 mm is 22%; the manganese content of these particles is 35.4%. The share of particles smaller than 0.071 mm is 78%; the manganese content of these particles is 38.77%. Iron particles distributed in the samples of the concentrate in both size ranges evenly—3.81–3.86%. The surface area of cement particles exceeds 4000 cm<sup>2</sup>/g. The chemical composition of cement is: CaO—62–64%; MgO—2.5% (max.); SiO<sub>2</sub>—22–24%; Al<sub>2</sub>O<sub>3</sub>—4.5%; Fe<sub>2</sub>O<sub>3</sub>—4.5%; SO<sub>3</sub>—1.8%; alkali—0.6%. The chemical composition of bentonite (%) is: SiO<sub>2</sub>—58.4; Al<sub>2</sub>O<sub>3</sub>—12.6; CaO—0.8; Fe<sub>2</sub>O<sub>3</sub>—10.6; alkali—4.4.


Physical and mechanical properties of the brex were measured after three-day strengthening period in an open warehouse. The compressive strength amounted to 30 kgF/cm<sup>2</sup> and was measured on the Tonipact 3000 equipment (Germany) in accordance with the DIN 51067 standard. The open porosity was determined in accordance with DIN 51056 and amounted to 14.39%. The density of the brex was an average of 2.59 g/c<sup>3</sup>.


A specially designed unit was used to study the behavior of industrial brex samples from primary oxidized manganese concentrate from the Zhairem mining plant during heating heated in a reducing atmosphere. The test chamber was a hollow corundum tube with an outer diameter of 85 mm and an inner diameter of 75 mm. The brex samples were placed in a graphite crucible placed inside the chamber and covered with coke breeze particles with 1-5 mm in width. The thickness of the coke breeze layer covering the entire crucible was 25 mm. After that, perforated inserts were used to block the crucible from both ends, which provided heat insulation. Water-cooled metal clips were installed on both sides of the corundum tube. The vacuum pump was connected to one of the clips together with an air supply system and a flow meter. Before heating, the internal volume of the corundum tube was evacuated to 0.5 mbar. Then, the heating process started (10 °C per minute) and after the temperature reached 800 °C, the air supply was switched on at a flow rate of 10 L per minute until the end of the test. The brex samples were subjected to reducing roasting (in the CO atmosphere) in 1000-1500 °C temperature range at intervals of 100 °C. The test was performed at a fixed temperature for the duration of 2 h. The installation diagram and the sample positioning method are shown in Figs. 4.2 and 4.3.

The physical and mechanical properties of brex after heating at different temperatures are given in Table 4.2.

The Rigaku MiniFlex600 X-ray diffractometer was used to perform a phase analysis of original brex samples and the brex samples that were heated in a reducing atmosphere for 2 h. The main phases are presented in Table 4.3.

It can be seen that iron-manganese melt was formed in the presence of iron oxides. Manganese was subsequently recovered from the melt.

## **4.2** Brex from Manganese Ore Concentrate and Gas Cleaning and Aspiration Dusts

Chiatura manganese ore concentrate (Republic of Georgia) and baghouse dust from silicomanganese production were used as raw material for brex production. The chemical composition of the manganese ore concentrate and silicomanganese production baghouse dust is given in Table 4.4. The main minerals of the

concentrate are pyrolusite, psilomelan, and manganite. Pyrolusite from Chiatura manganese ore has a finely-spherulitic (oolitic) and clastic brecciate structure. Spherulites fragments do not exceed 0.25 mm in size. Pyrolusite is partially recrystallized up to hundredths of a millimeter during grain coarsening. The Chiatura oxide concentrate softening point is 1049 °C according to the data in [7]. 85% of baghouse dust particles are smaller than 10  $\mu m$ . Primary particles have a spherical shape due to phase transitions during particle formation.




Fig. 4.4 Granulometric composition of mixture for brex production

Two types of mixtures from the above materials were prepared for brex making: 1—a mixture of an equal mass (50:50) of concentrate and dust, and 2—a mixture of 70% concentrate and 30% dust. The granulometric composition of the second mixture is shown in Fig. 4.4.

Coke breeze was used as a reducing agent; it was provided by the company by whom ferroalloy smelter is owned. The coke breeze has the following composition ratio: carbon—68.72%; volatiles—7.53%; ash—23.75%. 88.46% of coke breeze particles are smaller than 0.635 mm in size. Its moisture content is 9.86%. Three brex mixtures with low binder content were tested in the study (Table 4.5).

Test samples of brex were produced using a computerized laboratory extruder that simulates the processing of a briquetted mixture in commercial even feeders, pug mills and the extruder itself. The brex had a circular cross section of 2.5 mm in

diameter and 1.5–2.0 mm in length. The average moisture content of freshly formed brex was 11%. The vacuum level in the working chamber of the extruder was maintained at 38–48 mm Hg.

Due to the cylindrical shape of brex, its cold strength was determined by measuring both compressive strength and tensile splitting strength, since these types of stress would be exerted on brex during actual transport and stacking. These properties were measured using an Instron 3345 system (USA). The compressive and tensile splitting strength tests were performed using six specially-prepared brex samples with a diameter of 25 mm and a length of 20 mm which were subjected to compression and tensile splitting.




Fig. 4.5 Compression test of brex No. 3




Fig. 4.6 Tensile splitting test of brex No. 3

Figures 4.5 and 4.6 illustrate the behavior of brex and the mechanism of brex destruction during compressive and splitting strength tests. At the initial stage (1), the elastic loading of brex shows a linear dependence between the applied force and the displacement of the active pressing surface. The beginning of the second stage is characterized by a sharp decrease in the applied force due to the formation of surface fractures. At this stage, the "near-surface" layers of the brex are destroyed and peeled (15–20% of the radius). However, the "core" (central part) of the brex

continues to endure the pressure, as evidenced by the core's growth. A clear zonal structure of the brex can be observed in the radial direction. The near-surface layers of the brex have a relatively higher stiffness than its "core". This statement is supported by the difference in slopes of the curves at Stage 1 and Stage 2.

In the third stage, once the applied force reaches its maximum, the "core" of brex is destroyed with a complete strength loss.




Fig. 4.7 Compression test of brex No. 2 (for three different samples of the brex No. 2)




Fig. 4.8 Tensile splitting test of brex No. 2 (for three different samples of the brex No. 2)

Brex No.1 and Brex No.3 demonstrated similar behavior (Figs. 4.7 and 4.8).

Table 4.6 illustrates the average compressive strength and splitting strength.

Subsequently, compressive strength of samples of industrially-manufactured brex No. 2 was tested by independent laboratory L. Robert Kimball & Associates, Inc (USA). The compressive strength of a sample with a diameter of 32.3 mm and a length of 57.7 mm was 206 kgF/cm<sup>2</sup>. It is clear that the results obtained for compressive strength significantly exceed the compressive strength of briquettes for SEAF. The above-mentioned results for brex compressive strength were achieved by using a relatively low Portland cement content compared with that of vibro-pressed briquettes (8–9% of weight). Most of a batch of brex manufactured for pilot testing contained only 3% of a binder.

The brex porosity was examined by a LEO 1450 VP scanning electron microscope (Carl Zeiss, Germany) with a resolution of 3.5 nm in combination with X-ray computer tomography using the Phoenix V|tome|X S 240 high-resolution micro focus computed tomography system (General Electric, USA). Computer tomography determined that the sample porosity was in the range of pores above 100 µm in diameter. Scanning electronic microscopy was used to study the porosity


represented by pores with dimensions less than  $100 \, \mu m$ . The results of the microscopic studies were processed by computer program STIMAN [8]. The porosity of brex was determined to be 18.5% (5.6%—the porosity, measured by computer tomography, and 12.9%—the porosity measured by electron microscopy). Subsequently, the porosity of manufactured brex with the same content of basic components (3% of Portland cement) amounted to 18.7%, as measured by independent laboratory L. Robert Kimball & Associates, Inc (USA).

Thermal analysis of powdered samples with a mass of 50–70 mg using the STA 449 C Jupiter® (Germany) in an argon atmosphere, in the temperature range of 20–1400 °C at a heating rate of 20 °C/min, made it possible to determine the character of the brex phase transformations. In addition, the results of the analysis showed that the thermal effects on the DSC curve for brex No. 1 and brex No. 2 are almost identical (see Fig. 4.9).

The manganite (MnO (OH)) dehydrates to form pyrolusite or  $\beta$ -kurnakit (2MnOOH = Mn<sub>2</sub>O<sub>3</sub> + H<sub>2</sub>O) in the temperature range 300–450 °C. At temperatures above 400 °C, psilomelane of manganese ore transforms to hollandite or hausmannite. Exothermic peaks with a maximum temperature of 795.8 °C in brex No. 1 and 801.0 °C in brex No. 2 are most likely associated with the dissociation of pyrolusite and the formation of  $\beta$ -kurnakit which is accompanied by oxygen release and mass loss. The same peak in brex No. 3 at a temperature of 742.8 °C is not followed by a loss of mass; it can be explained by the effects of recrystallization of amorphous phases.  $\beta$ -kurnakit decomposes in the temperature range 900–1050 °C, and the formation of  $\beta$ -hausmannite takes place [9]. In the range 1080–1250 °C,  $\beta$ -hausmannite is polymorphically converted to  $\gamma$ -hausmannite.






Fig. 4.10 Mössbauer spectra of raw brex No. 3 and of brex No. 3 after heated to STA conditions to temperatures: a crude; b 850  $^{\circ}$ C; c 1065  $^{\circ}$ C; d 1175  $^{\circ}$ C; e 1250  $^{\circ}$ C

In brex No. 3, the endothermic peak in 150–200 °C temperature range is accompanied by mass loss due to sorption moisture removal. In 300–500 °C temperature range there are no pronounced endothermic peaks, but there is a loss of mass associated with the reduction of  $MnO_2$  to  $Mn_2O_3$ . A phase transformation of manganite (MnOOH) into kurnakit ( $Mn_2O_3$ ) occurs in the same temperature range. The endothermic effect with a maximum at 1031.7 °C is associated with the reduction of  $Mn_3O_4$  to MnO due to mass loss; the effect at 1056.1 °C is determined by the ferric phase change. Mössbauer analysis was performed to determine the phase composition of the iron-containing components in the original brex and the products of its heat treatment, and to clarify the results of the thermogram. Figure 4.10 shows the Mössbauer spectra of raw brex and the samples after heating at different temperatures. Table 4.7 illustrates the results obtained after processing the spectra using the computer program Univem.

The Mössbauer spectrum of the initial brex sample (Fig. 4.10a) is a superposition of two doublets, with the isomeric shift of the doublets being smaller than that of iron oxides and iron hydroxides. These doublets can be attributed to the intermetallic iron and manganese compound. Due to the isomeric shift being close to 0 and a small quadrupole splitting, the doublet D2 can be attributed to the iron atoms localized in the cubic face-centered lattice. These iron atoms do not have manganese atoms in their environment and the doublet D1 is attributed to iron ions with

manganese atoms present in their coordination sphere. As a result, the quadrupole splitting of this doublet D1 is notably higher.

The Mössbauer spectrum of the initial brex sample heated to 850 °C and cooled in the STA conditions (Fig. 4.10b) has shown no significant difference from the initial sample. There was practically no change in the isomeric shift and the quadrupole splitting of doublets (see Table 4.7). However, the ratio of the doublet areas has changed; this implies that there could be only a small change in the

positional distribution of iron and manganese atoms in the sample. Therefore, the thermal effects described on the DSC curve are not related to the iron-containing phase, but to the manganese phase. The changes in the spectra occurred due to thermal effects at 1031.7 and 1056.1 °C, which is reflected in the spectrum after heating up to a temperature of 1065 °C under STA conditions. Meanwhile, the quadrupole splitting of the doublet D1 and the doublet area decreases, but the corresponding parameters of the doublet D2 increases; this can be attributed to the sample phase transformation and change in the density of structural positions. After phase transformations at these temperatures, no significant changes occurred in the spectra. Consequently, the thermal effects observed at 1122.7 and 1213.2 °C are associated with the phase transformations of the manganese component in brex.

The endothermic peak with a maximum at 1122.7 °C is determined by forming manganese carbide Mn<sub>3</sub>C, where carbon recovers manganese from MnO. The coke breeze in brex provides for intensive iron and manganese reduction, marked by endothermic peaks at 1122.7 and 1213.2 °C.

The brex structure has been studied by electron microscopy. Figure 4.11 illustrates the structure of brex No. 2.

Portland cement is known to lose its binding properties at 750–900 °C. Therefore, it is important to understand what provides for the hot strength of brex at temperatures higher than the above-mentioned temperature range. A previous studies [10] explored the behavior of a pyrolusite sample of manganese concentrate from the Chiatura mine when heated in a reducing atmosphere (helium 40% and hydrogen 60%; heat at a rate of 20 °C per minute). A cubic sample measuring  $5 \times 5 \times 5$  mm was observed to gradually expand by a considerable amount up to 0.8 mm; the thermal expansion was accompanied by sample cracking. Cracks were first observed at 500 °C, with the number of cracks increasing with heating. The fractures formed during the tests are characterized by a certain orientation pattern.




Radial and concentric cracks are found within the spherulites. Cracks in random directions are found in the inter-spherulites cementing mass. Despite this fracture pattern, the sample maintained integrity at 800 °C. After that, a slow and irreversible compression process began. In our opinion, a dense silicate phase (olivine or Wollastonite) was the cementing binder that safeguarded the sample from destruction. The formation of the phase in the indicated temperature range corresponds to the well-known phase diagrams of systems Ca<sub>2</sub>SiO<sub>4</sub>–Mn<sub>2</sub>SiO<sub>4</sub> and CaSiO<sub>3</sub>–Mn<sub>2</sub>SiO<sub>3</sub> (Figs. 4.12 and 4.13 [11]). A glass phase and manganese silicates (tephroite-Mn<sub>2</sub>SiO<sub>4</sub> and rhodonite-MnSiO<sub>3</sub>) were discovered in the intervals between the oxide phase's grains of the Chiatura concentrate sample.

The dense structure of the above-mentioned silicate phases provides the strength of brex at a temperature up to 1250 °C. At a higher temperature, two eutectics are formed in the MnO-SiO<sub>2</sub> system: (1) tephroite + rhodonite + liquid (1251 °C) and (2) tephroite + manganosite + liquid (1315 °C). These eutectics contribute to brex strength retention (see Fig. 4.14) [12], due to the presence of the liquid binder.

An important property of brex for smelting ferroalloys in SEAF is the specific electric resistance. The measured specific electrical resistance of brex samples at a room temperature is given in Table 4.8.

The measuring system used in the study made it possible to investigate the dynamic pattern of brex resistance at a temperature up to 800 °C. As a result, the behavior of brex resistance was studied up to the first exothermic peak described in Fig. 4.9. It corresponds to a relatively deep brex immersion in the furnace to levels where lower manganese oxide is formed. Due to the low electric resistance of brex No. 3 (with 15% of coke breeze), which is lower than the resistance of lump manganese ore of the same deposit [13], this type of brex was excluded from further study.

**Fig. 4.14** Phase diagram of the MnO–SiO<sub>2</sub> system






Fig. 4.15 Specific electric resistances of brex No. 1 and brex No. 2

Figure 4.15 shows the results of resistance measurements in brex No. 1 and brex No. 2 when heated to  $800 \, ^{\circ}$ C.

The increase in resistivity of brex in 300-500 °C temperature range coincides with the above-mentioned endothermic effects of mass loss, which is associated with manganite dehydration and with kurnakit formation.

It is clear that the resistivity of brex No. 1 is lower than that of brex No. 2 because of the higher carbon content in brex No. 1 resulting from a higher baghouse dust content that adds carbon to brex No. 1.

Based on the above-mentioned conclusions regarding the physical and mechanical properties of brex, the behavior of brex during heating, and measurements of the specific electrical resistivity, brex No. 2 was selected as a component of the SEAF charge.

## **4.3** Full-Scale Testing of Silicomanganese Smelting with Brex

To manufacture a brex batch lot of 2000 tons a brickmaking plant equipped with a J. C. Steele industrial extrusion line was selected in Ragland (Alabama, USA). One thousand four hundred tons of the Manganese ore fines from the Republic of Georgia (Chiatura) and 600 tons of the baghouse aspiration dusts from the Client's

ferroalloys plant in West Virginia were delivered for brex production. The production process consisted of blending the dust and ore volumetrically via a front-end loader into blending stockpiles. Because the ore came in coarser than desirable, the material blend was fed into the plant through the grinding facility where the material was reduced to minus 8 mesh (2.25 mm). The blended and ground material was transferred into the feed tanks in the extrusion plant. The blend was further fed into Steele 75ADC Extruder where it was mixed with water and 3-5% of PC. The extruder and its vacuum mixer had a combined 338 KW capacity. The Extruder was equipped with multi-hole extrusion die with round openings of 25 and 30 mm diameter. Typical production parameters were as follows: production rate 55 metric tons per hour; moisture content of the green brex 10.5%; vacuum level: 100 mm Hg. The appearance of the brex on the outlet of the extruder and in the storage area after just 5-15 min after production is shown in Fig. 4.16. As expected, the green brex handling procedure did not require any special protective measures or special treatment (steam curing, palletizing to preserve the integrity, etc.). The brex were shipped to the smelter by barges discharged at the berth of the Ohio River (Fig. 4.17) Trucks were then used to transport the brex from the pier to the open batch stockyard a conveyor then carried them directly to the furnace bunkers. In total, the transport of the brex to the ferroalloy (2000 km) withstood 20 handling operations in a period of 30 days: manufacturer—extruder, conveyors, dumps truck, stockpiles, wheel loader, truck; port of loading-stockpiles, wheel loader, hopper, bucket, barge; port of discharge—grab, hopper, conveyors, truck; ferroalloy plant ore storage yard stockpiles, front loader, factory warehouse, furnace. Total fines (less than 6 mm) generated during these operations did not exceed 10%.

To initiate a full-scale industrial trial, a stable 27MVA capacity and 85-tons/day-average industrial submerged EAF was selected to run with a specific average energy consumption of 4200 kWh/t, manganese recovery rate of 80%, and manganese dump slag content of 12–14%. The chemical composition of manganese-containing charge components is shown in Table 4.9.





**Fig. 4.16** Production of the brex by Steele 75 Extruder (left) and discharge of the green brex after 5–15 min at the storage area (right)



Scraps are the internal wastes generated while deslagging the surface of metal in a ladle, cleaning buckets and furnace notch, sorting at slag dumps, and casting Silicomanganese. Only the total manganese content in slags was determined; these values are given in Table 4.10. Briquettes made from Silicomanganese fines are produced through the process of vibropressing (unconditioned fines fraction 0–6 mm). To impart the necessary strength to the briquettes made from these fines, significantly more Portland cement was required than is for brex (10%).

A preliminary calculation of the charge composition was made in order to achieve stable manganese content in the ore part of the charge (Table 4.11). With the increase in the share of brex in the ore part of the charge, it was decided to reduce the supply of ore-2, which is a drop-in replacement, because the average manganese content of brex was 31% against 29% in the said grade.

For the accuracy of the comparison of the results of the furnace operation with and without brex, a month-long period of furnace operation was observed.

A weeklong period of the furnace operating without brex immediately preceding the beginning of the pilot period was taken as a reference.

We decided to begin with 5% of the brex share in the ore part of the charge to get a first experience with the agglomerated burden. Over the course of 3 days of observation, no visible changes had been registered in the process of Silicomanganese smelting; the furnace worked smoothly, with a constant and uniform current load during the period of brex use. The slight 0.3% decrease in manganese extraction during this period was due to furnace downtime associated with the tap-hole unit repair (1.5 h downtime). Then, for four consecutive days, the brex share in the charge was maintained at 10%. Improvement in the furnace top functioning was visually apparent. Gas flames throughout the furnace's top area confirmed an improvement in gas permeability of the column of the charge and the uniformity of the temperature distribution over the surface of the furnace top. Deeply submerged electrodes functioned without producing surface blowholes in the electrodes circle and in the surrounding area. No sintering in the electrodes circle was observed. During the next 3 days, brex share in the charge was increased up to 20%. The furnace operated smoothly, the electrodes were deeply submerged, the current load had no visible abnormalities or tremors, and the gas permeability of the charge was good for the entire area of the furnace top. Throughout the next week, the brex share of the charge was increased to 29%. The furnace worked well. An increase in the rate of the charge descent in the electrodes circle, especially during the tapping, indicates an increase in the melting rate of the charge in the active zone of the furnace. The furnace top functioned smoothly without surface blowholes with a constant load current, smooth, without bumps and drops. Melt out was good, metal and slag were sufficiently warmed up. However, in the end of this period, there was a furnace downtime for 4 h due to reasons not related with the brex presence in the charge (electrical problem in the transformer).

The beginning of the next phase of the pilot period, when the brex share rose to 35% substituting the ore-2, was associated with a problem caused by a disruption in the tap-hole electrode bypass, resulting in its shortening and the deterioration of the melt. The bulk of the slag remained in the furnace. This resulted in an increased coke rate and scraps withdrawal from the charge along with briquettes of Silicomanganese fines. During this period, a deterioration in the technical and economic performance of the furnace had been registered, namely an increase in specific energy consumption and specific consumption of manganese ore raw materials, as well as a reduced extraction of manganese. To restore its normal functioning, the furnace heating rate was increased so as to warm up the slag and ensure its normal tapping. In the final phase (week) of the pilot operation period, the furnace worked with the brex share in the charge up to 40%. The furnace operation was characterized by a good current load, top gas release was smooth, with no surface blowholes and furnace charge downslides, and with a normal tapping.

Based on the results of the full-scale trial, we made a comparative analysis of the technical and economic performance of the furnace with and without brex in the charge. Technical and economic performance of the furnace and the chemical

analysis of the fusion products are presented in Tables 4.12 and 4.13. All the numbers are taken from the foundry journals recordings.

The main positive aspect of the full-scale campaign with the brex in the charge for the smelting of merchandise Silicomanganese is that the furnace operated in a stable, smooth regime. Furnace top operation was characterized by good gas permeability all over the surface, without any charge downslide. Current load was uniformly distributed among three electrodes. Electrodes were submerged deep and

stably. Melt tapping took place according to the schedule, the chemical composition of the metal and slag showed no significant changes. Replacement of the substantial part of the lumpy manganese ore by brex based on ore fines and aspiration dust led to the improvement of technical and economic indicators of the process as a whole. Specific energy consumption during the test period decreased significantly. In the reference period, consumption per basic ton of the alloy was 3977 kWh with the brex share in the charge ore equal to 40%; the specific energy consumption decreased up to 3675 kWh per basic ton (-7.6%).




Fig. 4.18 Manganese extraction as a function of the brex share in the ore component in the furnace charge

Another positive result of the full-scale trial is related to increased manganese extraction from the ore. In 29% of brex in the charge, manganese extraction was at 83.6%, against an average extraction of 80% in the reference period of the furnace operation without brex in the charge (Fig. 4.18). Decreased extraction in the period preceding the final phase was not associated with the presence of brex in charge, but was, instead, the result of furnace downtime and problems with the electrode.




Fig. 4.19 Specific productivity, B.t./1000 kWh of consumed energy

It is also important to know the relationship of the brex share in the ore part of the charge and the specific productivity of the furnace expressed in base tons per unit of electricity consumed. Figure 4.19 shows that the best performance is achieved when the brex share in the ore part of the charge is in 20–30% range. In general, the results of full-scale trials give grounds to consider that it is appropriate to use brex based of manganese ore fines and baghouse dust from gas cleaning as the essential charge component for Silicomanganese smelting.

### 4.4 Stiff Extrusion Briquetting of the Ferroalloys Fines

Before shipping to consumers, ferroalloys are crushed and screened to obtain a required piece size. During such processing ferroalloys fines and aspiration dust are generated. One of the ways to utilize the ferroalloy fines and the dusts is briquetting. The basic requirements for quality of commercial briquettes made from fines of ferroalloys are reduced to the necessity to provide the required mechanical strength at lowest possible binder content and high thermal stability, i.e. the ability to maintain integrity when placed in the environment with high temperature. Briquetted ferroalloys used as components of the SEAF charge must have sufficiently high values of hot strength and of specific electrical resistance. In order to increase the specific electrical resistance, dust of aspiration systems can be added to metallized ferroalloys fines. In addition, aspiration dusts of ferroalloys production, as shown above, can exhibit binding properties which can significantly reduce binder consumption.

The field experience in using roller presses for agglomeration of manganese-containing, and hence abrasive ferroalloys fines, confirmed that this method has a number of disadvantages. In August 2003, Nikopol Ferroalloys Plant (Ukraine) launched the experimental production of ferroalloys-fines-based briquettes using an organic binder. The capacity of the briquetting line allowed producing 40,000 tons

of briquettes per year [14]. It was projected that 70% of the briquettes would be produced from silicomanganese fines and 30% from ferromanganese fines. In the process of the production of silicomanganese-fines-based briquettes, the following parameters were achieved: productivity, t/h—4.5 ... 5.0; briquette volume, cm<sup>3</sup>—22 ... 25; briquette density, g/cm<sup>3</sup>—4.5 ... 4.8; briquette moisture, %—0.8 ... 1.7; moisture content in briquetted charge, %—2.5 ... 4; temperature of charge before pressing, °C—60–80; drop strength of briquettes (+5 mm size fraction when tested in accordance with the Russian Standard GOST 25471-82), %—94 ... 96.

When implementing the briquetting technology, an increased wear of the sleeves surface was noted. As a result, the first set of sleeves was worn out after briquetting 1100 tons of high abrasive silicomanganese fines.

The Assmang plant in Cato Ridge (South Africa) had a successful experience in using vibropress briquetting technology to agglomerate manganese-containing anthropogenic materials, including ferroalloys fines [15]. The initial composition of the tested briquettes consisted of 69.2% ferromanganese fines, 26.8% of aspiration dust and 4% of cement binder. Mechanical strength was tested using a drop test procedure, which showed that less than 10% of fines with smaller than 0.5 mm size particles are formed. However, the tests that were carried out in a muffle furnace with heating in the range of 200-800 °C showed that the briquettes of the above-mentioned composition do not have hot strength. As the temperature increased with the interval of 200 °C, the briquettes were removed from the furnace and subjected to a strength test. It was noted that the briquettes completely lost their strength at 400 °C. At the next stage briquettes with alumina cement as a binder were tested, which allowed achieving specified hot strength. However, the mechanical strength of this type of briquettes did not meet the requirements. In addition, the use of alumina cement would lead to a significant increase in the briquette cost. The mixture of cement and clay rich in alumina (3% by weight) was decided to use as a binder, which eventually resulted in the production of briquettes with the sufficient strength for a 12-h long stacking and with acceptable mechanical strength after 48 h of storing. In addition, the briquettes had sufficient hot strength. Since the cost of clay is 50% lower than the cost of alumina cement, the final composition of the briquettes is the following: 67.0% ferromanganese fines, 26.0% aspiration dust, 4% cement binder and 3% aluminum-rich clay. The chemical composition of the briquette is given in Table 4.14.

After that, the briquettes were used as charge components for SEAF (11.5 MVA). The briquettes replaced two grades of manganese ore, namely Nchwaning and Gloria. The share of briquettes in the furnace charge was 10%. During this full-scale testing, no rise of electrodes was observed; no charge sintering occurred. The use of ferromanganese fines-based briquettes as charge components resulted in an improvement in the technical and economic parameters of the furnace operation.

In order to study possible ways of using the SVE technology for agglomeration of similar materials, the following types of brex were tested: brex from metallized crushing fines and brex with the addition of aspiration dusts of the ferroalloys crushing units.

The briquettes were manufactured on a laboratory extruder with the hole size of 15 mm and the cylindrical shape of brex. The vacuum was 37.5–62.5 mmHg. The brex composition and the physical and mechanical properties of brex are given in Table 4.15. The mixture for Brex No. 4 was subjected to a 24-h homogenization. Figure 4.20 illustrates silicomanganese crushing fines and brex based on them.

It is evident that the brex achieved sufficiently high compressive strength and impact strength, and homogenization did not have an obvious effect. The increase in cement content from 5 to 6% and in bentonite content from 1 to 2% improved compressive strength by 28% and impact strength by 12%. Applicable strength level was achieved with a minimum content of cement (5%) and bentonite (1%).

The composition of brex based on ferroalloy fines with addition of the aspiration dust collected at the ferroalloys crushing unit was tested as well: (1) silicomanganese fines—80.2%, aspiration dust of silicomanganese production—14.2%, Portland cement—4.7%, bentonite—0.9%; (2) silicomanganese fines—66.1%, aspiration dust of silicomanganese production—28.3%, Portland cement—4.7%, bentonite—0.9%).

The crushing strength of these brex was, on average, according to the results of measurements on 10 samples 244.6 kgF/cm<sup>2</sup> and of 116.8 kg/cm<sup>2</sup>, respectively.





Fig. 4.21 Dynamics of changes in the electrical conductivity of brex based made of manganese fines when heated

The dynamics of the electrical conductivity of the brex from the first batch was examined during the heating of the sample till 800 °C (Fig. 4.21).

For this type of brex the room temperature electrical conductivity is 101.2 (Mohm m)-1. For the brex used in the above-described industrial pilot tests of silicomanganese smelting, the electrical conductivity was 207.7 (Mohm m)<sup>-1</sup> at 20 °C. When heated to a temperature of 750 °C, the conductivity of both types of brex were 4,463,670.5 (Mohm m)<sup>-1</sup> and 120,328.2 (Mohm m)<sup>-1</sup>, respectively. The

electrical conductivity of the silicomanganese fines-based brex was 37 times higher than that of the brex from manganese oxides. To reduce the electrical conductivity, it is necessary to increase the content of aspiration dust in the brex.

The thermal stability tests of the brex were carried out in a Tamman furnace by holding the brex above the melt for 15 min at a temperature of 1200 °C. All samples passed the test and maintained their integrity. In addition, the brex were also smoothly melted after being dropped into a slag melt at a temperature of 1580 °C. It took 10 min to melt a single brex unit (with a diameter and length of 25 mm) (Fig. 4.22).

In recent years, a number of ferroalloys producers have fostered efforts to develop an efficient technology for briquetting ferrosilicon crushing fines. The paper [16] examines the results using liquid glass (sodium silicate) as a binder to produce strong briquettes from this material. The required strength of the briquettes was achieved by adding liquid glass in the amount of about 6% of the weight of a given briquette batch; however, use of the same binder (2%) in combination with starch (about 3.0%) resulted in strength gain. It has been stated that the results of the study provided the basis for the design and construction of three industrial lines for briquetted ferrosilicon production. The briquetting line of Silingen Polska [17] is known to produce about 18,000 tons of these briquettes per year. The maximum compression strength of such briquettes is 14 MPa. The briquette dimensions are  $66 \text{ mm} \times 55 \text{ mm} \times 35 \text{ mm}$  and composition is 68% silicon and up to 2% carbon, due to the use of an organic binder, which exceeds the carbon content limit in ferrosilicon. The content of liquid glass-supplied Na<sub>2</sub>O is not indicated.

We tested briquettes from ferrosilicon FS 75 grade crushing fines with added aspiration dust from FS 75 crushing units. The exterior appearance of the briquetted material is illustrated in Fig. 4.23. Composite binder comprised of different grades of lignin and starch was used in the testing.

The chemical composition of the aspiration dust is given in Table 4.16. More than 99% of the particles are smaller than 0.125 mm in size.

Three brex mixtures have been developed and tested with 4-h preliminary homogenization and without it. The brex exterior appearance is shown in Fig. 4.24. The component composition of the brex and the extrusion parameters of brex production are presented in Table 4.17.

Prior to the tests, the FS-75 fines were sieved through a 2.36 mm mesh size screen. Once sieved, the material was prepared further by mixing the components with water in a Hobart laboratory mixer. After a double batch of mixture was prepared, the charge was passed through the shearing plate of the laboratory extruder. Half of one batch was subsequently agglomerated in the laboratory extruder, while the other half was subjected to souring for 4 h. The extruder was equipped with a steel flat die with 4 holes of  $\sim 20$  mm in diameter. Samples were collected immediately from the die and tested to determine moisture content and density.

The samples were subjected to drop tests. The samples with a weight of about 500 g were placed in a plastic bag and dropped 12 times onto a concrete surface from a height of 1 m. The amount of the fines formed during the tests was measured. The fines consist of particles that are smaller than 4.75 mm in size.

The effects of forced drying versus prolonged drying under natural conditions were studied by placing one sample from each batch in a dryer at a temperature of 150 °C until the moisture content of the brex reduced to 1%. The rest of the batch was stored in a laboratory at constant temperature and humidity, which simulates natural storing conditions. The temperature in the laboratory is about 20 C throughout the year. When dried, the brex were subjected to drop testing and axial compression testing. The briquettes were tested after 24 h, 3 days and 8 days of storing. The properties of the brex and the test results are given in Table 4.18.

As indicated by the extrusion parameters, there are several significant differences between lignin bonded samples and samples with a starch binder. Electric current in the extruder reached its maximum when producing samples with lignin. As for samples with starch, electric current was much lower. This decline in the rate of electric current is mostly likely due to the difference in moisture content. The relative moisture content in extruded samples with starch is higher than that in the samples with lignin, which can be explained by the fact that starch has a higher water absorption capacity than lignin. Starch presumably serves as an internal lubricant in the mixtures, as evidenced by lower temperature of the extruded masses.

The compressive strength in all the samples that were forced dried was much higher than in those samples that underwent 3-day storage in natural conditions. A sharp increase in strength was observed after a week of storing. The strength of the samples after storing exceeded the strength of the samples that were forced dried.

The drop test results of freshly agglomerated samples show significant differences in strength between samples containing lignin and samples containing starch. The drop test results of the lignin-based samples vary in the 20-30% range, while these values were 1-2% for the samples with starch.

The drop test results of forced dried samples are acceptable for all samples. After 3 days of storage, samples containing lignin showed good results in the drop tests, except for sample No. 2 (11%). These results can be due to the samples relative moisture content at this stage of the test. Samples without preliminary souring had lower moisture content and greater impact strength, which indicates a low efficiency of this procedure when agglomerating crushed ferroalloys fines.

Samples with a starch binder showed consistent results in drop tests. Such brex can be of sufficient strength for transport. Moreover, the starch binder content in the brex is lower than in the above-mentioned Silingen Polska briquettes (3%), while starch was only a part of the binder in these briquettes (in addition to 2% of liquid glass, by weight), and the compressive strength was 14 MPa (42% lower than in brex).

The results of the above-mentioned studies led to the construction of several SVE agglomeration plants in different countries of the world for the agglomeration of manganese ore fines and baghouse dusts, chromium ore fines and aspiration dusts as well as different anthropogenic materials generated during production of ferroalloys. The first smelts already confirmed the justification behind our recommendation for the brex as an effective charge component for SEAF.

In 2017 SVE plant for production of brex made of chromium ore fines and aspiration dusts (Fig. 4.25) was commissioned in Kazakhstan (TNC Kazchrome, Aktobe). Brex are being successfully used as a charge component of SEAF for ferrochromium smelting.




Fig. 4.26 Chromium ore fines mixed with aspiration dust of ferrochromium production

The decision to build this line was made according to the results of the laboratory tests. Raw materials for testing (chromium ore fines and aspiration dusts, Fig. 4.26) and the bentonite were combined with water and mixed in a Hobart laboratory mixer, then processed through the laboratory extruder under vacuum. The intent was to simulate the typical extrusion scenario of processing material through a pug sealer and then extruder. The brex composition was as follows: chromium ore fines and aspiration dusts—97%; bentonite—3%. Figure 4.27 shows the appearance of the green brex.

Within one hour of extrusion, 500 g of each sample was placed in a sealed plastic bag and dropped four times from a height of 1 m. The results were then screened and the fraction of particles below 4.75 mm was determined (Fig. 4.28). Less than 1% of fines were generated during this testing.

Currently, the brex are used in the charge of SEAF of the company.

4.5 Conclusions 127

#### 4.5 Conclusions

1. Manganese ore concentrate and the baghouse dust can be efficiently agglomerated by the SVE agglomeration technology.

- 2. Brex has sufficient mechanical strength to withstand the distant transportation including multiple loading-discharging operations. The mechanical strength of brex is significantly higher even with the addition of relatively small amounts of the Portland cement binder than the strength requirements to the charge components of the Submerged EAF. Furnace baghouse dust is also exhibiting binder properties. A 30% or more increase in baghouse dust content reduces the mechanical strength of brex.
- 3. Brex have sufficient porosity to ensure good reducibility. Porosity level is comparable with that of commercial manganese ores.
- 4. Brex exhibit high thermal stability and sufficient hot strength ensuring the stable and smooth operation of the furnace.
- 5. Brex with the baghouse dust content up to 30% will exhibit sufficient specific electric resistivity comparable with the specific electric conductivity the lumpy ores.
- 6. Brex can be efficiently used as one of the essential charge component (up to 30% of the ore part of the charge) for the Silicomanganese smelting thus improving technical and economical parameters of the furnace and decreasing the self-cost of Silicomanganese production.
- 7. The hot strength of brex in the up to 700–800 °C temperature range is achieved by a cement binder, and the hot strength in 800–1250 °C temperature range is achieved by the density of the formed silicate phase.
- 8. SVE technology can be used in the production of competitive commercial brex made of the ferroalloys.
- Ferroalloys fines and ferroalloys crushing unit aspiration dust can be efficiently agglomerated by means of the SVE method to produce a charge component of SEAF with acceptable metallurgical properties.

# Chapter 5 A Laboratory Study and Full-Scale Testing of Brex in Direct Reduction Iron (DRI) Production

## 5.1 Analysis of the Results of the Application of Brex in the Charge of a Midrex Reactor

The process of mini steel mills using oxidized pellets as a feedstock includes production of metallized pellets, which are used further for the production of direct reduction iron (DRI), production of steel in electric arc furnaces (EAF) and its continuous casting and rolling. Companies that are importing large amounts of iron ore pellets annually for DRI production and also during the course of the transportation, stockpiling, and charging of the pellets into metallization reactors, as well as the discharging of the metallized pellets, generate tens of thousands of tons of fine materials containing iron every year. Pellets fines and DRI sludge are usually dumped in piles and EAF dust and mill scale are sold to a third party. The results of a preliminary analysis indicate that the recycling of such materials in the form of briquettes would help to produce additional quantities of steel, and would also free up a significant area occupied by dumped wastes. Recovery of these wastes would generate additional revenues, surpassing revenue from direct sales of wastes.

We have studied the possibility of using stiff vacuum extrusion to produce agglomerated products suitable for use as charge components in DRI reactors. The experiments were conducted in an industrial Midrex reactor operated by one of the customers of the J.C. Steele&Sons, Inc. This company imports 3.5 million tons of iron ore pellets annually to produce 2.35 million tons of hot-briquetted iron (HBI). Tens of thousands of tons of finely dispersed iron-bearing wastes are formed each year during the unloading, storage, and subsequent charging of pellets into metallization reactors, and also during the discharging of the metallized pellets, and their briquetting.

## 5.1.1 Tests with Brex in a Rigid Steel Basket in the Charge of a Midrex Reactor





Fig. 5.1 Steel baskets (a) and packets (b) for charging brex together with pellets into a Midrex reactor

We conducted two series of basket tests that entailed the reduction of brex in an industrial Midrex reactor. In the first series, 25 to 30 strengthened brex were placed inside a rigid steel basket (Fig. 5.1a) that were then charged into the reactor together with pellets. The brex were extricated from the reactor after the tests were concluded in order to be able to visually evaluate the condition of the reduced briquettes, and study their composition and properties. The mechanical strength of the brex did not play a significant role in this case, since they were not subjected to pressure from the column of charge materials.

The stiffness of the basket completely prevented the brex from being subjected to pressure from the layer of pellets and thus possibly be deformed or fractured. In the second series of tests, brex were placed inside deformable gas-permeable steel packets (Fig. 5.1b), which made it possible to study their behavior under conditions similar to those encountered inside a layer of pellets in a Midrex reactor. The results of the first series of tests are discussed below.

To conduct the tests, we used brex produced from a mixture of pellets fines—55.6% (no more than 92% of which were 6.3 mm or smaller in size), metallized DRI sludge—27.8% (also with a 92% particle content no coarser than 6.3 mm), and mill scale—16.6% (with 99% no coarser than 10 mm). The main goals of the investigation were to evaluate the reduction properties of brex in the Midrex process and to select a binder that would give the brex the necessary strength and maximize their metallization. The mixture was subjected to additional pulverization (Fig. 5.2) on a roll crusher before it was briquetted. Table 5.1 shows the chemical composition of the components of the mixture.

Four types of experimental brex were tested (Table 5.2). The types differed negligibly from one another in terms of their chemical composition and differed only in the type, and the amount of binder that was used. The brex was made by J.C. Steele&Sons on a laboratory extruder. The mixture was prepared and

homogenized by using a Hobart laboratory mixer that simulated the processing of the charge in a pug sealer.

There was a substantial difference (Table 5.3) between the green brex and the brex after strengthening (that is to say after they had been strengthened over the course of 14 days).

The porosity of brex is one of their most important properties and determines their reducibility. The microstructure of the specimens and the specifics of their porosity were investigated with the use of a scanning electron microscope (SEM) LEO 1450 VP (Carl Zeiss, Germany) with a guaranteed resolution of 3.5 nm, and STIMAN software [1] to quantitatively analyze SEM images obtained in the backscattered electron regime. The porosity of briquette specimens 01-01 and 01-03 was studied on material that was freshly cleaved from the specimens' surface. Morphological studies of the microstructure were performed in the secondary electron regime and allowed us to obtain high-quality halftone images over a broad range of magnifications. The STIMAN method makes it possible to obtain correct images with distinct boundaries between the pores and the particles. The morphological parameters of brex 01–01 and 01–03 that were measured in this way, together with the characteristics of the pores are shown in Table 5.4. This information clearly shows that the only significant difference in the porosity of the specimens was with respect to the anisotropy coefficient. This difference was probably due to the type of binder.

The distribution of the macropores (with sizes greater than  $100 \,\mu\text{m}$ ) can be determined by computer-assisted X-ray tomography. The images in Fig. 5.3 illustrate the difference in the distributions of the macropores in green brex specimens 01–01 and 01–03. The images were captured with a Yamato TDM-1000 X-ray computer microtomograph (Japan). The magnification was 32 and the resolution



was 11  $\mu$ m. It is possible to conclude that the 01–01 brex had a higher percentage of pores larger than 100  $\mu$ m than the 01–03 brex.

The degree of open porosity determined by the STIMAN method is very consistent with the open porosity measured by liquid saturation in a vacuum in accordance with the standard DIN 51056 (GOST 26450.1–85). The porosity values were within the range 21–24% for the specimens that were examined.

Cracks could clearly be seen on brex specimens 01–02 and 01–03 after they were removed from the reactor (Fig. 5.4).

Both specimens had been prepared with the use of a cement binder. There were more cracks in the specimens with the 01–03 designation, which had higher binder content (Table 5.2). It is possible to conclude that the hot strength of brex is related to their crushing strength. Brex specimens 01-02 and 01-03, which were weaker and less dense in the cold state (see Table 5.3), also had a lower hot strength. The lower value for their hot strength manifested itself in the formation of surface cracks in the brex, which is consistent with the results obtained from studying the hot strength of iron ore pellets and comparing it to their crushing strength [2]. In the case of the pellets, there was also a negative dependence of hot strength on the ratio Al<sub>2</sub>O<sub>3</sub>/SiO<sub>2</sub>. An increase in this ratio decreased the pellets' hot strength. Brex specimens 01-02 and 01-03, which exhibited a lower hot strength than brex prepared with a lime binder, had the highest value for elastic modulus due to the substantial amount of alumina in the cement and, in particular, in the bentonite (brex 01-03). At the same time, the presence of lime and hematite (pellet fines and scale) in brex 01-01 and 01-04 helped calcium ferrites form at just 400-500 °C during the course of the briquettes' heating in the Midrex reactor. These ferrites, which have low melting and softening points, strengthen the structure of brex and improve their reducibility [3].

After the brex were extracted from the rigid steel baskets, we determined their chemical composition, total iron content, content of metallic iron, and degree of metallization (Table 5.5). The highest degree of metallization was seen for the 01–01 brex with 5% lime content, while the lowest degree of metallization was registered for the 01–03 brex with the maximal (8%) content of cement binder.

The changes in the porosity of the brex during their reduction were evaluated by using a Phoenix V|tome|XS 240 X-ray microtomograph with two X-ray tubes: a micro-focus tube with a maximum accelerating voltage of 240 kV and a power of 320 W; a nanofocus tube with a maximum accelerating voltage of 180 kV and a power of 15 W. The initial analysis of the data and the construction of a three-dimensional model of the specimens based on the X-ray photographs (projections) were done using the datos|x reconstruction software, while the VGStudioMAX 2.1 and AvizoFire 7.1 software was used to visualize and analyze the data based on elements of the three-dimensional image. The photographs were taken at an accelerating voltage of 100 kV and a current of 200 mA; the resolution during the recordings was 5.5 µm. Table 5.6 shows the results obtained from measuring the volume and number of pores in the brex before and after reduction.




Fig. 5.5 3D-model of the pore space in a 01-01 brex (a) and a 01-03 brex (b)

Figure 5.5 depicts the visualization of the pore distribution in the form of a 3D-model.

It is apparent that the porosity of the brex which were examined (and had coarse and ultra-coarse pores with a size of 1–100  $\mu$ m or larger) changed in different directions. The total volume of the pore space decreased by a factor of 1.6 in the 01–01 brex and increased by 20% in the 01–03 brex. The increase in the porosity of the reduced brex with a cement binder can be attributed to the disintegration of the cement stone at 850 °C, and the accompanying decrease in the strength of the brex. The brex remained intact thanks to the formation of a metallic matrix composed of reduced iron. Conversely, the reduction of the brex with a lime binder was accompanied by a decrease in their porosity. This can be attributed to the agglutination of fine pores during the formation of the metallic matrix composed of reduced iron. Basket tests of brex made from a mixture of pellet fines, mill scale, and finely dispersed wastes from HBI production in an industrial Midrex reactor showed that they can be effectively metalized without loss of integrity. The brex

with a lime binder displayed the highest degree of metallization and the greatest strength. While the brex with a cement binder remained intact, cracks were formed on their surface. The number of cracks was found to be greatest in the brex with a higher binder content.

## 5.1.2 Tests with Brex in Deformable Steel Packets in Charge of Midrex Reactor

At the second stage of testing, experimental brex were placed inside deformable steel packages that were gas permeable for the reducing gas (Fig. 5.1b). This input method allows brex behavior to be simulated adequately in actual reactor conditions, including the mechanical pressure of the surrounding traditional charge. At the end of the process, these packages were drawn out of the reactor, which enabled the condition of the reduced brex to be determined visually and their reduced chemical composition and properties to be explored.

The prepared mix of pellets fines (52.6%), metallized sludge from DRI production (26.4%), mill scale (15.8%), and EAF dust (5.2%) has been used.

The chemical composition of the mix components is given in Table 5.7.

All test samples were extruded using a 25 mm round pelletizing die. A Hobart laboratory mixer was used to simulate the mixing with water and pugging of the ground feed material in the open tub of the pug sealer. The laboratory extruder simulates the processing of the material through the sealing auger and die, into the vacuum chamber, and then final extrusion. The laboratory extruder consists of two chambers with a sealing die between them. The rear chamber is fitted with a 3-in. diameter sealing auger that pushes material through the sealing die. The second chamber can be subjected to a vacuum. It is also fitted with a 3-in. diameter auger that extrudes material through a pelletizing die. A PC-based data system monitors and records extrusion data. All mixes were extruded immediately after mixing. Three types of the experimental brex were produced with the compositions given in Table 5.8.

A magnesium sulfate-based binder was composed using the magnesium sulfate heptahydrate (MgSO4·7H2O). The binding properties of magnesium sulfate were first described by Zhuravlev and Zhitomirskaya [4]. The change in form that occurs when a dehydrated inorganic salt is converted to the hydrated crystal form is the basis for the recommendation that a partially dehydrated magnesium sulfate be used

industrially as a binding material. Setting begins in 3 min and is complete in 6 min. Chemical composition of the brex is given in Table 5.9.

A calibrated electronic scale with a density measuring attachment was used to determine brex density. A compression tester was used for sample strength measurements, tensile splitting strength has been measured in accordance with ASTM (American Society for Testing and Materials) C1006-07, Paragraph 7.1. Porosity has been measured in accordance with DIN (Deutsches Institut für Normung) 51056. Moisture content was measured using a moisture balance. The physical and mechanical properties of the raw brex are given in Table 5.10.

Experimental brex with the above compositions were placed into the deformable and gas-permeable steel packages (each type of brex was placed in a separate package) and these packages were added to the traditional charge of the Midrex reactor. The tests were conducted during the course of a night shift from midnight to 8:00 a.m. The reducing gas temperature was around 900 °C. At the end of the process, the packages were removed from the reactor due to the presence of so-called cold discharge (with a discharge temperature of 40 °C) thus enabling the condition of the reduced brex to be visually determined (Fig. 5.6) and their chemical composition and properties to be examined.

An observation can be made that the brex that used a magnesium sulfate-based binder demonstrated the highest degree of integrity. The cement-bonded brex demonstrated the largest degree of fines generation. The brex that used lime binders were destroyed to a markedly lesser extent.

The mechanical strength values of the reduced and non-destroyed brex were defined in the course of splitting tensile testing (0.4 N/mm<sup>2</sup> for lime-bonded brex and 1.2 N/mm<sup>2</sup> for brex with a magnesium sulfate-based binder). The strength of the brex with a magnesium sulfate binder has not changed compared to its original value (Table 5.10). Thus, the brex with the lowest values for the cold mechanical strength showed the highest values for hot strength. Respectively, the brex with the magnesium sulfate-based binder also showed the highest reducibility. The decrease in the reducibility of the lime- and cement-bonded brex is related to the decrease in the permeability of the steel packages after the particles of the generated fines have blocked the holes. The chemical composition of the reduced brex and their degrees of metallization are presented in Table 5.11. One can see a serious discrepancy in terms of the total iron contents in the reduced brex. This, in turn, comes from a difference in metallic iron content. The reason for this is related to the different hot strength levels of the brex and to the aforementioned blocking of the holes by fines from partially disintegrated brex (No. 1 and No. 2), which prevents the intake of the reducing gas.

The Midrex reactor, which has been used for full-scale testing, produces DRI that has the following guaranteed parameters: a degree of metallization of 94%, total iron content—91%, metallic iron content—85%, carbon content—1.3%, sulfur—0.005%. It follows from the testing results that the brex with the magnesium sulfate-based binder reached a higher degree of metallization (96.71%), and almost the same level of metallic iron and carbon content, but this was smaller than in the DRI total iron content. The sulfur content is significantly higher in this brex. This is evidently a limiting factor for the utilization of brex with a magnesium sulfate-based binder in Midrex reactors. Sulfur will partially go to the flue gas and, in the absence of the flue gas desulfurization, it could spoil the quality of the catalyst. A lime-bonded brex has much lower sulfur content.

We can compare these results with those obtained in the Midrex reactor of the ArcelorMittal in Hamburg with roller briquettes of the following composition: 37.6% DRI filter cake, 47% oxide fines, 9.4% return fines, and 6% of hydrated lime and molasses as binders [5]. The total iron content in the raw briquettes amounted to 59%, in the reduced—77%. The degree of metallization of the briquettes extracted from deformable steel packages was 86% [6]. The brex with a magnesium sulfate-based binder revealed a greater degree of metallization (96.71%) with a lower initial value of the total iron content (62.61%) in the raw brex and with a smaller binder content (5%).

#### 5.1.3 Mineralogical Study of the Reduced Brex

The structure of the reduced samples of brex has been studied using light microscopy methods with the "Nikon" equipment (a polarized ECLIPSE LV100 POL microscope equipped with a digital photomicrography system DS-5 M-L1) (Nikon, Tokyo, Japan). Analysis of mineral phases in polished sections of briquettes was conducted by MLA 650 (FEI Company, Hillsboro, OR, USA), including an FEI Quanta 650 SEM scanning electron microscope. The main mineral phases were determined by a diffraction analysis using an analytical complex ARL 9900 Workstation IP3600 (combined X-ray fluorescence spectrometer) (Thermo Fisher Scientific, Waltham, MA, USA). Reduced brex with a magnesium sulfate-based binder and retained integrity samples of the reduced brex with lime and cement binders were tested.

Fines from pellets with a low basicity (CaO/SiO<sub>2</sub> = 0.3–0.5) are represented by fragments with a different mineral composition: cores in the form of residual magnetite with a glass phase and shells consisting of splices of hematite with calcium ferrites. The mill scale has a magnetite composition—a solid solution (Fe,Mn)O·Fe<sub>2</sub>O<sub>3</sub>. A special role in the composition of the brex is played by EAF dust, which consists of the main melt generating components: CaO, MgO, MnO, SiO<sub>2</sub>, and Na<sub>2</sub>O.

In the reduced and non-destroyed cement-bonded brex, iron is represented by partly recovered iron-containing minerals made from pellets fines and mill scale.






Fig. 5.7 SEM-image of the reduced cement-bonded brex. 1, 3, 4—binary metasilicates; 2—silica containing calcium ferrite; 5—dicalcium ferrite

In the major body of the cement-bonded brex extracted from the steel mesh packages, there are the areas with the phases that are close in terms of their composition to the binary metasilicates  $2Na_2O\cdot CaO\cdot 3SiO_2$  ( $N_2CS_3$ ) and  $Na_2O\cdot 2CaO\cdot 3SiO_2$  ( $NC_2S_3$ ) without any presence of iron (Fig. 5.7).

 $N_2CS_3$  melts incongruently [7] (melting starts at 1141 °C with the creation of 78.5% of the melt and 21.5% of  $NC_2S_3$ , and ends at 1203 °C).  $NC_2S_3$  melts congruently with an extensive field of primary crystallization. In the Midrex process temperature range, only two eutectics exist (Fig. 5.8): 755 °C— $N_3S_8 + NCS_5 + S$  ( $N_2O$ —22%; CaO—3.8%;  $SiO_2$ —74.2%); 827 °C— $N_2CS_3 + NC_2S_3 + NS_2$  ( $N_2O$ —36.6%; CaO—1.8%;  $SiO_2$ —60.7%).


**Fig. 5.9** Diagram of system Na<sub>2</sub>O·2SiO<sub>2</sub>– Na<sub>2</sub>O·2CaO·3SiO<sub>2</sub>

In the phases detected by the X-ray spectral microprobe analysis, CaO content exceeds 10%, indicating that limited melt formation takes place in these areas. The phase detected at temperatures ranging from 870 to 950 °C can be in an amorphous state with low amounts of liquid phases, as illustrated in Fig. 5.9.

In the cement-bonded brex, the alkali silicate phase is predominantly associated with the smallest, dusty fractions, which are contained in the alkali. The silicate bonding is not fully developed in the sample's body. Optical study of the samples of the reduced brex shows the pieces of dicalcium silicate  $(Ca_2SiO_4)$  crystals.

Lime-bonded brex have a higher degree of metallization and a deeper interaction between charge components. Such samples are characterized by a variation in the composition of iron–silicate melts in different parts of the body of the brex. The most prevailing is the combination of the primary melt with iron. In this case,

creation of the melt is related to the enveloping of the pellets fines particles by the dust fractions. The primary iron–silicate melt composition is close to olivine phases. The melt has a high basicity ( $CaO/SiO_2 = 0.8-0.9$ ),  $Na_2O$  content in different parts

of the sample ranges from 1.0 to 10%, magnesium and manganese oxides content does not exceed 1.0–2.0 mass%. Under the conditions of the Midrex process as the pellets fines contact the melt, metallic whiskers are generated (Fig. 5.10).

Rarely are mineral formations with a high content of calcium oxide (up to 40%), silicon oxide content (25–26%), and the same amounts of bivalent iron observed in brex with lime as a binder. No other oxides are found in the composition of the amorphous iron–calcium phases with high calcium content. The composition of such phases is close to the Melilite phase ( $Ca_2Fe_3 + Si_2O_7$ ).

The predomination of the fine fraction within the brex is of particular interest. It consists of a combination of metal with calcium ferrites. Apparently, in pellets fines, consisting of the combination of hematite with calcium ferrite, the hematite phase was the first to reduce and such reduction took place without breaking contact with the ferrite.

Brex with magnesium sulfate binder exhibited the highest degree of metallization and a well-developed melt generation process.


For the first time in this study it was found that, during the metallization, the original microstructure of brex does not persist. Brex is close to a two-phase system: a metal and a silicate phase. However, the composition of the silicate part remains nonuniform in the adjacent volumes of the reacted fines. According to X-ray spectral microprobe analysis, among the studied melts, two mineral species are dominant—close to the olivine and Melilite structures, but each with a different content of iron oxides, magnesium, and manganese. This conclusion has also been confirmed by the results of an optical microscopy of the brex samples (Fig. 5.11).

The areas of the melt, which have reached equilibrium, are of particular interest. The mineral phase in combination with residual melt is observed in these areas (Fig. 5.12).


Thus, it is clear that the mechanism of the strengthening of brex samples in each case has its own specific characteristics. For cement-bonded brex, a lack of hot strength during heating in the reducing atmosphere is associated with their swelling and with the limited formation of silicate bonding. The strength of lime-bonded brex during the reduction process is provided by formation in the solid phase of the iron–calcium silicates, similar in composition to the olivine phase with a low melting temperature. Brex with the magnesium sulfate-based binder has the highest degree of generation of the two-phase metal–silicate system at the end of the metallization process.

During the process of reduction of the brex placed in deformable steel packages, their porosity changed in a different way. With the aim of studying the nature of

such changes, we have investigated the structure of the porosity of the original and reduced brex. The microstructure of samples was studied using a scanning electronic microscope (SEM) 1450 LEO VP (Carl Zeiss, Jena, Germany) with a resolution of 3.5 nm. For morphological studies of the microstructure of the samples, the secondary electrons mode has been used, which allows high-quality halftone images to be obtained across a wide range of magnifications. Quantitative analysis of microstructure was conducted using STIMAN software by two different methods: The first—is based on a series of SEM images obtained in backscattered electrons, which enables the correct picture to be obtained with clearer boundaries between the pores and particles; the second—by a complex analysis based on a set of SEM images, and images captured using Yamato TDM-1000 (Yamato Scientific, Tokyo, Japan) computed tomography. The results of the morphological studies are given in Table 5.12.

During the process of metallization, the total porosity of brex with a magnesium sulfate binder increased by 19.5%, cement-bonded brex by 13.15%, and brex with lime as a binder only by 2.6%. The porosity increased due to large and mega-pores (larger than 100  $\mu m$ ): for brex with magnesium sulfate binder—they increased by 6.9 times, and for lime-bonded brex—they increased by 2.43 times. In cement-bonded brex, the growth of share of large share was 1.24 times. The maximum diameter of pores in brex with a magnesium sulfate binder has increased by almost three times and in brex with a lime—by 1.23 times. The difference in the nature of changes of porosity between the original and reduced brex can also be clearly seen on images captured by computed tomography (Fig. 5.13). In brex with magnesium sulfate- and lime-based binders, the development of internal cracks took place. This contributed to the formation of coherent porous systems and the increase in the reduction rate.


It can be assumed that the driving mechanism for the development of porosity in the brex was the crystal lattice type changes during the hematite—magnetite phase transformations, which results in an increase in the volume of the brex. This increase in volume is accompanied by mechanical stresses, which may lead to the partial destruction of brex, which leads to an increase in the proportion of large and mega-pores and to the formation of internal cracks. The stronger the brex is mechanically, the less it is prone to such partial destruction.

The brex with the magnesium binder were further manufactured at the industrial SVE briquetting line belonging to Suraj PL (Rourkela, India). Phase analysis of the industrial brex was done in Rikagu Miniflex600 X-ray diffraction system using copper target and nickel filter. Figures 5.14, 5.15, 5.16, 5.17, and 5.18 show the phase composition of the brex after reduction at different temperatures. The testing has been performed with the help of the experimental facility described in Chap. 4 (Figs. 4.2 and 4.3) and adjusted for the conditions simulating blast furnace process. Heating of the brex samples in a reducing atmosphere was carried out to temperatures of 1000, 1100, 1200, 1300, and 1400 °C.

Mineralogical study of the reduced samples was done on polished section under reflected light in Leitz Universal microscope with the image analyzer. Figures 5.19, 5.20, 5.21, 5.22, and 5.23 show the different stages of the brex metallization.

The results of this study show clearly that magnesium bonded brex could be considered as candidates for the BF charge.

As an appendix to the study of the properties of the brex as a charge component in Midrex reactors, we studied the properties of brex made from direct reduced iron (DRI) fines, that is formed in the course of the classification process designed to classify the pellets and the hot-briquetted iron that are manufactured at the Stock Company «Lebedinsky GOK» (Belgorod region, Russia). The entire metalized product is subjected to screening in terms of its classification: less than 4 mm and less than 25 mm. In order to obtain a competitive and economically viable product,




Fig. 5.14 Phase composition of brex sample after reduction at  $1000\,^{\circ}\text{C}$ . Main phases: magnetite, hematite




Fig. 5.15 Phase composition of brex sample after reduction at 1100 °C. Main phases: magnetite, wustite, iron

the brex must be used as a charge component in an arc furnace, and correspondingly its size, density, and binding agent should be such that the briquette does not float in the slag, but descend down to the melt and does not bring any components that are harmful to the steel. The durability should be sufficient to prevent any destruction during the course of transportation (either by vibration, or friction), and during its storage in the stockpile, or in the hold.

From the DRI fines formed at the «Lebedinsky GOK», brex with the following composition were prepared and tested by ourselves (Fig. 5.24): DRI fines 92%, molasses—4%, lime—4%, bentonite—0.5% (in excess of 100%).




Fig. 5.16 Phase composition of brex sample after reduction at 1200 °C. Main phases: iron, wustite




Fig. 5.17 Phase composition of brex sample after reduction at 1300 °C. Main phases: α-iron, wustite

The value for the crushing strength of the brex was on average 122 kg/cm<sup>2</sup>. The porosity of the brex was 27.36%.

Thermal testing in the Tamman furnace during the melting of the brex at a temperature of 1513 °C demonstrated their high thermal stability. The brex melted smoothly and was immersed fully into the melt. The duration of the melt of a single brex was 10 min.




Fig. 5.18 Phase composition of brex sample after reduction at 1400  $^{\circ}$ C. Main phases:  $\alpha$ -iron, wustite




Fig. 5.19 Photomicrograph of Briquette-1 fired at 1000 °C 1—magnetite; 2—hematite; magnification  $\times 200$ 

### **5.2** High Temperature Reduction of Brex

We have investigated the behavior of the iron ore and coal brex in a neutral atmosphere at a temperature range of 1350–1370 °C partially simulating the conditions of the reduction of the iron ore and coal pellets in the ITmk3 process developed by «Kobe Steel» [8, 9]. This process is implemented in the annular chamber rotary hearth furnace (RHF). Green (unburned) iron ore and coal pellets are loaded in one or two layers onto a rotating hearth covered by a refractory. The heating of pellets and reduction of iron oxides is performed per single revolution of




Fig. 5.20 Photomicrograph of Briquette-1 fired at 1100 °C 1—iron; 2—wustite; 3—magnetite; magnification  $\times 200$ 




Fig. 5.21 Photomicrograph of Briquette-1 fired at 1200 °C 1—iron; 2—wustite; magnification  $\times 200$ 

the hearth over the course of 10–15 min at a maximum temperature that is higher than 1350 °C. Iron oxides are reduced by carbon in the iron ore and coal pellets or briquettes. The reduced iron in the pellets or briquettes is carbonized with its particles being coagulated and melted to produce bean-shaped cast iron drops (3–12 mm) inside the softened slag shell. When cooled in a neutral atmosphere these drops harden forming cast iron pellets (or "nuggets"). The metallurgical properties of pellets or briquettes must maintain their integrity during heating, and reduction and the slag shell that is produced should prevent the spread of liquid droplets of iron.





Fig. 5.22 Photomicrograph of Briquette-1 fired at 1300 °C 1—iron; 2—wustite; magnification  $\times 200$

For the production of the experimental brex, we have used the hematite iron ore concentrate (63.13% of iron content;  $Fe_2O_3 = 90.18\%$ ,  $SiO_2 = 4.63\%$ ,  $Al_2O_3$ —3.11%, MnO—0.807%, CaO—0.346%), the Globe coal (bulk density 768 kg/m³; moisture content 7.8%; ash 4%; volatiles 37.7%; and where 73% of particles are less than 0.6 mm in size), and the Shubarkol coal (bulk density 800 kg/m³; moisture content 10%; ash 7.1%; volatiles 38.5%; S 0.40%; P 0.021%.; and where 99% of the particles are less than 0.3 mm in size). The Type I Portland cement (general use) has been used as the binder. Volclay DC-2 Western (Sodium) Bentonite was used as the binder and plasticizer. We have manufactured brex with




Fig. 5.24 Brex made from DRI fines (at the «Lebedinsky GOK»)

both round and oval cross sections (with diameters of 1/2" and 1"; and a length equal to 1.5–2.0 diameters). The laboratory extruder simulates the processing of the material through the feeder to the pug mill and then to the sealing auger and die, into the vacuum chamber, and then final extrusion. Moisture content was measured using a moisture balance. A calibrated electronic scale with a density measuring attachment was used to determine brex density (Mettler MS603S and Mettler MS-DNY-43).

The results of the sieve analysis of Globe coal and Shubarkol coal are set out in Fig. 5.25.

Table 5.13 shows the chemical composition of iron ore concentrate (w-content).

Table 5.14 gives the brex compositions, shapes, and their physical properties. Wet base moisture of the brex No. 1 and No. 2 was 18.5%. For the brex No. 3, moisture content was equal to 15.2%. The vacuum applied for the production of the brex No. 1 and No. 2 was at the level of 48.26 mm Hg and for the brex No. 3 the value was 38.10 mm Hg.

For the production of the brex No.3, we have applied a 24-h souring using Bentonite. This procedure enhances the plasticity of the mix and can lead to an increase in the mechanical strength of the brex (or to the corresponding decrease of the binder consumption).

We have measured the compressive strength of the cured brex. These values were measured based on the Instron 3345 device (USA). For the measurement procedure, we have prepared the required amount of the specially shaped brex samples and subjected them to compression. The values of the compressive strength for the brex were as follows (kgF/cm<sup>2</sup>): sample No. 1—59.0; sample No. 2—24.0;

sample No. 3—49.0. We have observed the influence of the shape of the brex on the mechanical strength. For the brex No. 1 and No. 2 with the same chemical composition, we attained a significant increase in the compressive strength for the oval-shaped brex when compared with the regular cylindrical form of the brex. As far as the values for the tensile splitting strength are concerned, this increase takes place when the applied pressure is perpendicular to the main axis of the oval. When the applied pressure is perpendicular to the short axis of the oval, we observe a corresponding decrease in the strength value. It is clear, however, that the most probable orientation for the oval-shaped brex lying on its side is with its long axis parallel to the flat surface. The mathematical and physical modeling of this phenomenon has been described and studied previously (Chap. 2). It is also worth mentioning that the transition to the oval shape increases the value of the external brex surface when compared with the round brex of the same length and volume.




Fig. 5.26 Spatial distribution of the pores in brex No. 2 (X-ray computed tomography; dark and black—pore space; light and transparent—brex body; resolution 6  $\mu$ m)

We expected that the increased density of the brex might prevent their carbothermic reduction. However, the results of the porosity study show that for all brex compositions that were considered, the value of the porosity favors their reducibility. We used an LEO 1450 VP (Carl Zeiss, Germany) Scanning Electronic Microscope with a resolution of 3.5 nm together with the X-ray computed high-resolution computed tomography system Phoenix V|tome|X S 240 (General Electric, USA). Computed tomography has been used to detect the share of the macropores (larger than 100 µm in size). For the smaller size pores, the SEM has been applied. The approach based on STIMAN [1] computer software has been used to calculate the porosity detected by SEM. The results of these measurements showed that the total porosity of the brex No. 1 was equal to 34.8% (10.9% measured by X-ray computed tomography and 23.9% by SEM) and brex No. 2 was equal to 36.9% (12.3% measured by X-ray computed tomography and 24.6% by SEM). For the brex No. 3, the same value was equal to 36.4% (10.8 and 25.6% correspondingly). The spatial distribution of the pores detected by the X-ray computed tomography is illustrated by the image given in Fig. 5.26.

The reduction tests of the iron ore and coal brex following the conditions of the ITmk3 process were conducted by ourselves in laboratory resistance electric furnaces with a controlled atmosphere based on the Electric Furnace SSHVE-1.2, 5/25-I2 (Russia) with a vertical arrangement of the graphite heater and with an inside diameter equal to 65 mm. We positioned a working removable Alumina Crucible (98%  $Al_2O_3$ ) in the isothermal zone of the heater. We regulated and stabilized the temperature in the furnace with the help of the thermocouple BP (A) 5/20 located in the isothermal area of the furnace on the outside of the heater. We measured the true value of the temperature using the thermocouple 2 BP (A) 5/20, located inside the heater and lowered from above into the working Alumina Crucible. According to available data on the process of ITmk3, we have selected 1360 °C as the working temperature, which we maintained with an accuracy of  $\pm 10$  °C (1350–1370 °C).

Before the test, the furnace with the working replaceable Alumina Crucible was pumped out using the forevacuum pump until the residual pressure reached a value of  $10^{-1}$  Pa and was then filled with a high-clean grade argon. Then, we opened the gas discharge to atmosphere and kept the argon consumption through the furnace at

the level of 0.5 l/min. We switched on the heating of the furnace, reached the desired temperature level and stabilized it, and then dropped the brex sample through the dosing gateway into the crucible. This very moment was considered as the test start of the test. Thus, we have subjected the sample brex to the rapid heating from the ambient temperature to the working temperature of the furnace. During every single test, we recorded the process on a video using thermal imaging infrared camera «Pyrovision M9000» ("Micron", USA). This device records the film and also shows the temperature at each point of each frame. Sample exposure time was around 15 min; if necessary, we extended it up to 20 min. After that we depressurized the furnace, extracted the crucible with the products and tempered them in air, installed a new working crucible into the furnace and the new sample brex into the dosing gateway. We closed the furnace, washed it out using argon, and after setting the required temperature, we repeated the cycle.


Figures 5.27 and 5.28 show the photos of the consequent stages of the brex melting (volatiles release, solid-state reduction, melting and hot metal, and slag drop creation) based on the visual data obtained by «PyrovisionM9000».




Fig. 5.29 Brex No. 3 at temperatures T = 1100 °C, left; and T = 1250 °C, right

In all cases, the high density of briquette and large amounts of volatile coal did not interfere with the solid-state reduction of iron. During the heating, the cracks at the brex surface appeared however the brex did not decompose and kept its integrity (Fig. 5.29). Finally, the brex was transformed into liquid metal (nuggets) and slag drops. In the event of an excess of reducing agents, we observed that the formation of metallized shells mixed with drops of slag.




Fig. 5.30 Products of the brex reduction. From left to right: brex No. 1, brex No. 2, brex No. 3

Figure 5.30 shows the appearance of the products of the brex reduction.

Chemical composition of the reduced products (nuggets and shells) is given in Table 5.15. Due to the high content of coal in the brex, the carbon concentration in the metal was at the level of 3.3–4.8%. Metal samples (nuggets and shells) were

studied using a Jeol JSM 6490 LV Scanning Electron Microscope. All samples except the samples No. 3 have a similar microstructure: small island-type nonmetallic inclusions in a metal matrix. The smallest size of inclusions is observed in the sample No. 2 (10–20  $\mu$ m), in the sample No. 1, the inclusions are 50–60  $\mu$ m in size. There are no oxide inclusions in the No. 2 sample. Sample No. 3 is characterized by nonhomogeneous inclusions of a linear form with a width of around 5–10 µm and a length of 200–300 µm. As can be seen from Table 5.15, the C and Si content are high in sample No. 2. This shows that the reduction material in sample No. 2 is excessive compared to samples No. 1 and No. 3. The decrease of the amount of the reduction material in sample No.2 could help to improve the strength of the brex. Synchronized thermal analysis methods and Mössbauer spectroscopy have been applied for the study of the phase composition of the brex (STA 449 C, Germany). A comparison of the peaks of the metallic iron formation shows that the reduction of the metal iron takes place to a larger extent in the brex samples No. 1 and No. 2 (with the Shubarkol coal) rather than in the brex No. 3 which contains Globe coal. The degree of fineness of the Shubarkol coal particles might have influenced their enhanced reducibility. For a definitive conclusion on

the suitability of the brex, it is necessary to conduct further research on optimization of their size and on the composition of the fluxing oxides in the brex.

Metal samples (nuggets and shells) were studied using a Jeol JSM 6490 LV Scanning Electron Microscope. Figure 5.31 shows the images of the samples in the backscattered electrons.

#### 5.3 Conclusions

- The research into the properties of brex made from dispersal wastes from mini-plants, producing rolled products, and using oxide pellets as a raw material and the study into the behavior of this brex as they are heated in a reducing atmosphere in an industrial Midrex process reactor enable a conclusion to be made—that SVE technology makes full and effective recycling of these above wastes possible.
- 2. The difference in the nature of the changes in the porosity of both original, and reduced brex depending on the type of binder used, has been established. In brex that used a magnesium binder and which retained their tensile strength, and did not form any fines, the metallization process is accompanied by the formation of a metallic carcass, and the small pores disappear, while the larger pores increase in size.
- 3. Brex that use a magnesium binder have a high degree of metallization after reduction, in the course of this process, the microstructure in the original brex is not retained and begins to resemble the condition under the two-phase «metal–silicate phase» system.
- 4. One limitation on the use of brex that employ a magnesium binder is the increased sulfur content in the binder, which is partially transformed into a flue gas, and in the absence of desulfurization of the flue gas, this reduces the quality of the catalyst. It is this same parameter that will also define the permitted content of these brex in the charge of a metallization furnace.
- 5. SVE can be used effectively to agglomerate HBI fines.

- 6. Brex made from coal and ore could be considered as a possible alternative to the coal and ore pellets for use in the ITmk3<sup>®</sup> process.
- 7. By way of a final conclusion on the suitability of these brex, research needs to be undertaken into the optimization of the dimensions and composition of slag forming oxides in the brex.

# Chapter 6 Review of Alternative Applications of Stiff Extrusion Briquetting Technology

Another example of the industrial application of SVE technology for briquetting is the Coldry process, developed by the Australian Research Company Environment Clean Technology (ECT) for the agglomeration of the brown coal. At the first stage (the Coldry process), the brown coal is subjected to enrichment and drying, and then the brex are formed using a stiff vacuum extrusion process.

The results of theoretical and experimental research carried out at the organic chemistry faculty of the University of Melbourne in 1989 formed the basis of the Coldry-Matmor process [1]. The possibility of creating densified carbon was defined following an observation that was carried out at several Australian mines. It turned out that hardened bitumen-like road surfaces formed naturally soon after rain events when trucks had churned up brown coal fines with moisture when they entered and left the mine. In the days that followed a rain event, the road surfaces at the mine would harden like tarmac and no longer absorb water. A study into this phenomenon demonstrated that a process of low mechanical shear had occurred where brown coal mixed with a small amount of moisture and subject to low-level mechanical shear had substantially destroyed the coal porous structure and triggered a mild natural exothermic reaction process within the coal leading to the mobilization and subsequent evaporation of its moisture content. The low mechanical shear process fundamentally alters coal physical porous structure and to varying degrees the micro-chemical bonds within the coal, reducing moisture content between 10 and 14%, boosting calorific value over 5200 kcal/kg, and creating a new "densified coal" product that is hydrophobic, no longer prone to spontaneous combustion, readily transportable, and from a commercial and environmental point of view, a black coal equivalent [2]. The search for a briquetting technology that would be capable of achieving this effect led to the choice of stiff vacuum extrusion.




Fig. 6.1 The overall process diagram for the Coldry-Matmor process

The overall process diagram for the Coldry process, one of the key components of which is SVE, is set out in Fig. 6.1.

This process starts with the screening and attritioning of the charge. A small amount of water is added to the attritioner, where the coal is sheared to form a coal paste. This intensive mixing initiates a natural chemical reaction within the coal

which ejects both chemically trapped water and physically absorbed water within the coal pore structure. As already noted above, this process leads to a radical change in the structure of the brown coal when a shearing pressure is applied. A chemical analysis revealed the role of phenol residues in the formation of reaction centers within the structure of the modified coal. The activity of these residues is initiated by the attritioning movement, leading to new surfaces being revealed on the coal particles. The convergence of the reaction centers takes place during the course of the extrusion process, which means that at a later stage during the drying

of the brex new links can be formed. It is as a result of similar reactions that the densification of an agglomerated product occurs without a binder.

The plasticized mixture of coal- and iron-containing materials is fed into the extruder and comes out in the form of oblong brex (Fig. 6.2).

The newly formed brex are then placed in a plastic, corrugated conditioning belt (Fig. 6.3) in order to gain strength and to reduce the adhesiveness of the brex which is achieved by blowing warm air over the belt and the brex. The formation of new links within the coal components in the brex itself develops over the course of

60 min. The consumption of air is determined using a calculation of the moisture content of the brex reaching 58% prior to their entry into the drying plant. The height to which the brex are allowed to pile up in the traverser is 15 cm.

Incoming moist brex from the conditioning belt are further dried to their ultimate moisture level within the packed bed dryer. Warm air from the heat exchangers removes the moisture rejected from within the coal pellets. The cross-linking reactions come to completion within the dryer, increasing the brex' strength to levels sufficient to withstand bulk transport. The effective duration of the drying process, according to ECT company information, is 48 h. The moisture content of the brex is between 10 and 12%.

Texas Industries, Inc. (TXI, USA) operated a number of lightweight aggregate (LWA) production plants. They used SVE technology to agglomerate ore fines (Fig. 6.4) for further reduction in their rotary kilns. The company operated two extruders at two LWA plants, one in Texas and one in Colorado. As of July 2, 2014, TXI became a wholly owned subsidiary of Martin Marietta Materials, Inc.

CE Minerals (Andersonville, Georgia, USA and Xiuwen, China): This company agglomerates high-grade bauxite through five of SVE extruders (Fig. 6.5). The extruded bauxite noodles or pellets are dried and fired in order to make high-grade alumina feedstocks which are used in making refractory products.

The producer of Bentonite Clay American Colloid (Mineral Technologies, MTX) uses J.C. Steele & Sons extruders to agglomerate and beneficiate dryer dust and low-grade Bentonite clay into brex of high-quality Bentonite through the use of additives and the shearing action of the extruder (Figs. 6.6 and 6.7). This company operates extruders at locations in Wyoming, South Dakota, China, and Thailand. The same equipment is being used also by WyoBen (Wyoming Bentonite).

Another application of this technology may be associated with the briquetting of red mud. The customer supplied a raw material for testing in J.C. Steele & Sons lab in Statesville (NC). The material consisted of moist, soft, sticky lumps ranging in size from fines to pieces as large as 50 mm (Fig. 6.8).

The purpose of the test was to evaluate the suitability of the material for agglomeration by SVE. The test goals were to extrude the smallest practical pellet size and to use the minimum amount of binder (Portland cement) required. A test goal was to extrude pellets of the smallest practical diameter (Figs. 6.9 and 6.10). A pelletizing plate die for 6.4-mm-diameter brex was used. A 4% addition of

Portland cement was required to make the mix extrudable. With no water added, brex were well-formed but very soft with virtually no green strength.

After 7-day cure time, brex were crushed axially in order to determine axial compressive strength. The results of testing showed that this raw material, with the addition of Portland cement binder, is an excellent candidate for agglomeration by SVE.




Fig. 6.11 Agglomeration of synthetic gypsum by SVE

Carolina Gypsum uses an extruder to agglomerate synthetic gypsum with a lignin binder to make fertilizer filler. Yearly production of this plant is about 20,000 tons per year (Fig. 6.11).




Fig. 6.12 Agglomeration of dry scrubber fly ash by SVE

Universal Aggregates (PA, USA) agglomerates dry scrubber fly ash to make lightweight aggregate out of this pozzolanic material. The pellets are cured like concrete in a special curing vessel. Spray dryer ash, water, and other recycle materials are fed to a pug mixer where the materials are blended together. This mixing produces a uniformly blended loose, moist, granular material that feeds directly to an extruder. The extruder has an auger that subjects the material to further mixing and then forces the material through a die (metal plate with one or more drilled or specially shaped holes). Wet, "green" brex from the extruder are soft and must be transferred to a curing vessel for hardening (Fig. 6.12, [3]).
